LEASE OF SAFETY DEPOSIT BOX

SUBJECT to and upon the terms and conditions hereinafter set forth the undersigned (hereinafter called the Lessee) hereby as (1) rent(s) from The Bank of Nova Scotia (hereinafter called the Bank) safety deposit box number ..... in the vault of the branch of the Bank at ..... from date hereof until ..... and thereafter from year to year until this lease shall be terminated, or the box surrendered as hereinafter provided at the rent of \$ ..... per annum payable in advance, receipt of the rent for the period first mentioned being hereby acknowledged by the Bank. (2) The Lessee hereby authorizes the Bank to charge each subsequent year's rent to the Lessee's ..... account on the books of the Bank.

The Lessee hereby acknowledges receipt of the two keys to the lock of the said deposit box.

The Lessee agrees that this lease shall be subject to the following rules, regulations and conditions and such amendments thereof and such other reasonable rules, regulations and conditions as from time to time hereafter may be adopted by the Bank, which said rules, regulations and conditions (hereinafter referred to as "Conditions") the Lessee hereby, covenants and agrees with the Bank at all times during the continuance of this lease to duly observe, perform and be bound by, according to the tenor thereof.

NOTES:

- (1) State whether as an individual, joint tenants, tenants in common, estate, corporation, unincorporated body or as partners. If partners, state "Partners doing business under the name of (insert the firm name)".
- (2) Delete this paragraph if not applicable.
- (3) See conditions Nos. 12 to 17 for the special terms governing leases to joint tenants, tenants in common, partners, estates, corporations and unincorporated bodies.

CONDITIONS

1. The Bank shall ordinarily permit access to the vault during banking hours on each business day, but the Bank reserves the right to close the vault forthwith if in the opinion of any of its officers it is exposed to danger from any cause whatever or if such officers shall deem such closing prudent or proper.
2. The Bank shall not be liable for any delay, damage or inconvenience caused by reason of any accident to or failure in the working of the said box or the vault or the mechanism of the locks or otherwise.
3. The Lessee shall not use the said box nor permit it to be used for the deposit or storage of any liquid or anything of an explosive, dangerous or offensive nature or which may be or become a nuisance to the Bank or any of its customers or for any purpose other than for the deposit of valuables or other property and papers and the Lessee will on demand permit the Bank at any time to inspect the contents of the said box for the purpose of ascertaining if this condition is being complied with.
4. The Bank shall not be required to superintend, check or verify the deposit or removal of any contents of the said box.
5. The Lessee shall give immediate notice to the Bank in the event of the key or keys of the said box being lost, stolen or mislaid. The expense of a new lock and/or keys shall be paid by the Lessee.
6. The liability of the Bank shall be limited to the exercise of ordinary diligence to prevent access to the said box otherwise than in accordance with the conditions of this lease, and neither partial nor total damage to or loss of the contents shall be deemed proof or raise a presumption that the said box has been opened without authority.
7. The Bank reserves the right to terminate this lease at any time upon giving the Lessee written notice of such termination. Upon termination or surrender of this lease the contents of the box shall forthwith be removed by the Lessee or such person or persons having the right of access to the said box and the keys of the said box shall be returned to the Bank. If this lease shall be terminated by the Bank at any time before the expiration of any year for which rent has been paid, the Bank will refund to the Lessee a due proportion of the rental for the unexpired portion of such year.
8. The Lessee shall be entitled to surrender this lease by giving to the Bank one calendar month's notice in writing of intention so to do prior to the expiration of the current year in which such notice is given. In the absence of any such notice this lease, subject to the right of sooner termination by the Bank as hereinbefore provided, shall be deemed to be in effect for a further period of one year, and the rent for such year shall be paid by the Lessee forthwith on demand.
9. Notwithstanding the termination or surrender of this lease the Lessee shall be bound to pay rent at the rate aforesaid until all keys have been returned to the Bank.
10. If upon the termination or surrender of this lease the Lessee fails to surrender the said box and/or return the keys thereof within fifteen days from notice in writing from the Bank requiring the Lessee so to do, the Bank shall have the right to have the said box forcibly opened in the presence of two of its officers and to remove the contents therefrom and to hold the same on special deposit subject to the payment of all rent to the date of such opening together with all expenses incurred in changing locks and keys and the Bank's charge for subsequent safekeeping of the contents. If default be made in payment of such rent, expenses and other charges aforesaid, the Bank, after giving thirty days' notice in writing to the Lessee of its intention so to do, and after such advertisement as it shall in its discretion deem advisable, shall be at liberty to sell all the contents of the said box by public auction and to apply the proceeds of the sale firstly in payment of all expenses in connection therewith and secondly in payment of such rent, expenses and other charges aforesaid and the balance of the moneys, if any, may be deposited in a savings account to the credit of the Lessee.
11. INDIVIDUAL LESSEE. If this lease be to an individual, any agent appointed by the Lessee in writing for such purpose shall be entitled to have access to the said box and to remove the contents or any part thereof therefrom.
12. JOINT TENANTS. If this lease be to two or more parties as joint tenants, any one of such parties shall have the right of access to the said box and the right to surrender the same, but the right to appoint an agent for either of said purposes shall be exercised by all of such parties. Upon the receipt by the Bank of proof of the death of any joint tenant such rights shall be vested in the survivor or survivors of them.
13. TENANTS IN COMMON. If this lease be to two or more parties as tenants in common, the right of access to the said box shall be vested in all of such parties and such right may be exercised only when all of them or their respective agents are present. The right to surrender the said box and the right to appoint an agent or agents for one or more of such parties for the purpose either of access or surrender shall be vested in and must be exercised by all of such parties. Upon the death of any one of such parties all rights of the Lessee hereunder shall be exercised by the legal personal representative of the deceased party and the survivor or survivors of the other parties.

14. PARTNERS. If this lease be to two or more parties as partners, any one of such partners shall have the right of access to the said box and the right to surrender the same but the right to appoint an agent for either of such purposes shall be exercised only by all of such partners. Upon the receipt by the Bank of proof of the death of any partner such rights shall be vested in the surviving partners or the sole survivor if there be only one. In the event that the partnership includes partners other than the undersigned, only the undersigned shall be recognized by the Bank as having any rights under this lease.

15. ESTATES. If this lease be to the estate of a deceased person the right of access to the said box and the right to surrender the same shall be vested only in and may be exercised by such person or persons (whether the legal representative or representatives of the deceased or otherwise) as shall be the signatory or signatories to this lease on behalf of such estate and, if more than one, the survivor or survivors of them, or his, her or their agent or agents duly appointed for such purpose. Such signatory or signatories for all purposes of this lease shall be deemed the Lessee hereunder and shall assume and be bound by all the terms, conditions, covenants and agreements herein contained on the part of the Lessee to be observed and performed in the same manner and to the same extent as if this lease were to such signatory or signatories in his, her or their personal and individual capacity.

16. CORPORATIONS. If this lease be to a corporation, the right of access to the said box and the right to surrender the same shall be vested in such officer or officers of the corporation or such other person or persons as shall be designated for such purpose by the Corporation under its corporate seal.

17. FRATERNAL SOCIETIES, CHURCHES, LODGES AND THE LIKE. If this lease be to a fraternal society, church lodge or other unincorporated body, society or organization, the right of access to the said box and the right to surrender the same shall be vested only in and may be exercised by such person or persons as shall be the signatory or signatories to this lease, subject to the right of the Bank from time to time if so advised (and on evidence which it may deem necessary being produced) to permit any other person or persons claiming to have the authority to act for any such fraternal society, church, lodge, or other unincorporated body, society or organization, on production of the key or keys of the said box, to inspect and remove the contents thereof or any part thereof, but the Bank shall not be liable for any damage to or loss of said contents or any part thereof by reason of any unauthorized or wrongful act on the part of such other person or persons whether such damage or loss be caused by or be attributable in whole or in part to the negligence of the Bank or any of its employees or otherwise howsoever, and the Lessee shall indemnify and hold the Bank harmless in respect of any claim or demand that may arise or be made against it in respect of any such damage or loss.

18. The appointment of any agent as provided in these conditions shall be in writing and shall be in accordance with the form hereto annexed or in such other form as may be approved by the Bank from time to time. The writing appointing any agent shall be deposited with the Bank. Any such agent so appointed may thereafter, at the risk of the Lessee, exercise the rights and powers conferred upon him until notice in writing of the revocation of his appointment shall be given to the Bank by the undersigned or any of them if there be more than one.

19. In the event of the death of a sole Lessee the Bank may at its option, subject to any statutory or other restriction in that behalf (and on evidence which it may deem necessary being produced) permit any person or persons claiming to be the legal representatives of the deceased to inspect the contents of the said box, and on the filing of letters probate or letters of administration or other satisfactory evidence of their authority, the trustees, executors or administrators of the deceased Lessee, as the case may be, shall have power to deal with the contents of the said box and be deemed to be the lessees thereof in the place of the original Lessee.

20. In case of the bankruptcy of the Lessee or in case the Lessee shall make an authorized assignment pursuant to the Bankruptcy Act or suffer any other legal disability, the duly appointed trustee, committee or other legal representative or representatives of the Lessee, as the case may be, may exercise the rights and powers of such Lessee under this lease.

21. If by any statute, judgment, order or other process the Bank is prohibited from allowing the said box to be opened, the Bank may close the same to the Lessee while such prohibition continues in effect.

22. Save as herein provided no person other than the Lessee shall have access to the said box.

23. The Lessee shall not be entitled to assign, transfer or sublet the right, title, interest, or any part thereof, of the Lessee in and to this lease or the said box to any person, firm or corporation whatever.

24. The Lessee shall indemnify and hold the Bank harmless from and against all costs, loss, damages and expenses to which the Bank may be put or for which it may become liable by reason of any action, suit, or other proceedings relating to the contents of the said box.

25. Any notice to be given by the Bank to the Lessee under this lease may be so given by mailing the same through the post in a registered prepaid envelope addressed to the Lessee at the address given hereunder (or such other address as the Lessee may from time to time in writing instruct the Bank to substitute therefor) and any such notice shall be deemed to have been duly given when so mailed as aforesaid, or such notice may be given personally to the Lessee.

In this lease the singular shall include the plural if the context permits.
