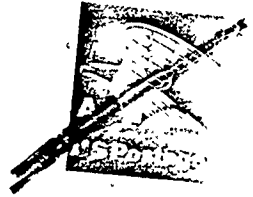
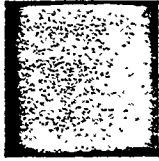
- o When things are written up for Peoples Rally and it is not follow through with in Rally or given prompt counseling.

Dear Stephen:

In analyzing, after the fact, what I was feeling when I called you (UP of LINE) last night --it seemed maybe good to give you some feedback on the reactions you were drawing from at least one person.

It was after my reaction that your mother took you on strongly and told the people to shut up.. It was after you had contradicted and criticized dad, and then told the second in command to "fuck you," that I shouted at you. You were shaking the fabric of our organization and I did not think you realized it! The concrete walls had suddenly become cloth and looked about to rupture or tear.. What you got was a gut reaction.

Mother's subsequently telling people to shut up -- in fact told people that you perhaps could not handle the confrontation... she showed you a preference she would have shown no other leader or member of this family. She would have chewed ass on anyone else -- and would have let the people involve... it was perhaps an unavoidable show of "class" within our structure. It was clear that you were to get different treatment as the natural born... more hostility for the natural born, and more hostility for Dad --automatically.

You as a potential leader should have respect for the existing leader, IF HE IS WORTHY! ...when you do not show it, then question arises that you in fact think him worthy. --of course I think that you think he IS WORTHY.. I WOULD NOT FIND YOU TOLERABLE IF I DID NOT THINK THAT, HOW COULD I BE WAITING FOR YOU--for then I would not trust you, and if I did not trust your "fairness" I would not let you see my thoughts. I consider it a mark of my continuing commitment to you in your line of succession to your Dad and Mother... as a possible choice for next in line.

It appeared that you thought your own image(as potential future leader) was at stake when you corrected Dad...that it was more important for them to have faith in you than in him... Was it ego? When he said HE PLANNED TO SUICIDE, I knew he was not forgetting my daughter in Georgetown, or Jean Brown, June, Betty and others in St, I thought of those down river... If it is hypocrisy to line up 100% with the d of p...then we are marxist-leninist hypocrites.

It is very important that you understand me as a person --but as one of those in the family in a leadership role, it is important for you to evaluate with care our reactions. I am available sincerely your willingness to take up the mantle when and if necessity demands. Dad lay it down... --most sincerely, Jack

I hope you also realize that it was because I considered your image much more important to the welfare of the group, so I did not challenge you further when you were challenging the hypocrite that called you out of order... You were very insulting, but my silence was not hypocrisy -- it was born of the realization that to stir a mud pot makes it stink the more... Dad was in visible pain, for this organization IS HIS B. Y.. I wish he did not feel so intensely, yet know that without it he would not be the only existing TRUE COMMUNIST ON THE PLANET!!!

I salute you, Comrade Stephen -- and respect the deep feelings and frustrations you must deal with as you grow into this most difficult leadership post.

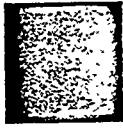

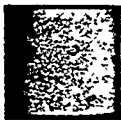
