25 I, VIRGINIA MONTE, declare as follows:

26 1. I submit this declaration in support of Guyana Tribute Foundation's Motion for
27 Preliminary Injunction scheduled for May 25, 2011.

28 2. I am a supporter of the Guyana Tribute Foundation. GTF is a public benefit non-

1 profit corporation duly organized and existing under the laws of the State of California. The
2 purpose of GTF is to provide assistance, comfort and support to the family members of the
3 victims who were tortured, massacred and killed in Jonestown, Guyana by the People's Temple
4 Church under the direction, guidance and instruction of its Reverend Jim Jones.
5 on or about November 18, 1978.

6 3. I fully support and approve the Cherishing the Children Healing Memorial Wall
7 (hereinafter referred to as "Jonestown Memorial Wall") created by the Guyana Tribute
8 Foundation. Its design, color, size, height, length, width and thickness appropriately
9 memorializes and honors the memory of all of the victims including the 305 children, 40 of
10 which were infants, Congressman Leo Ryan and his UPI news group, who perished during the
11 Jonestown Massacre at the hands of the People's Temple and Jim Jones. It seemed only fitting
12 and appropriate that Evergreen Cemetery would be the home to a physical memorial that would
13 stand as a permanent and painful reminder to future generations of the child victims' families
14 and supporters of the lives of the precious child victims who perished so young.

15 6. On or about, May 2011 I found out that Evergreen Cemetery had
16 approved plans for another monument to be erected on the base and setting originally approved
17 for Jonestown Memorial Wall. This monument was proposed by the surviving People's Church,
18 led by Fielding McGehee and Jim Jones, Jr., and proposes to include the name of Jim Jones
19 himself as a victim of the Jonestown Massacre (hereinafter referred to as the "Jim Jones Honor
20 Wall").

21 7. I believe that the Jim Jones Honor Wall desecrates the victims of the Jonestown
22 Massacre which was initiated by Jim Jones himself. Specifically, the name of "Jim Jones" is
23 etched on the Jim Jones Memorial is repulsive and insulting to the memory of the victims.

24 I declare under penalty of perjury under the laws of the State of California that the
25 foregoing is true and correct and that this declaration was executed in
