Dear Mr. Beck:

On March 22, 1983, Judge Brown approved distribution of the third and final payment on claims against Peoples Temple. The total amount to be distributed to all claimants will be \$184,118, which represents 1.25% of the face value of your receivers certificates, and which brings the total aggregate percentage paid to claimants to just under 65%. (The first payment last August was 31.00%, the second in November was 32.39%, and this final payment is 1.25%, totalling 64.64%.)

As you may recall from past letters, the receivers certificates were not money awards but rather served to establish your proportionate share of the assets upon distribution. The receivers certificates issued to all claimants totalled \$14,519,468, while the actual money ultimately available for distribution to claimants was \$9,455,655, or approximately 65% of the receivers certificates issued. This is also, as stated above, the percentage of your receivers certificates which you have now received in settlement of your claim against the Temple.

Along with the final distribution to claimants, the Receiver recommended and has received court approval to make a contribution of \$10,000 to the San Francisco Council of Churches from Temple assets. After the tragedy in Jonestown, the San Francisco Council of Churches, at its own expense, made generous contributions of time and services in making initial arrangements. The court found that a contribution to that organization was appropriate.

Finally, a small amount of money has been retained in the receivership to cover the costs of the final winding up and dissolution of the Peoples Temple. The Receiver estimates that after all payments and expenses have been made, there will remain a residue of approximately \$10,000. Since this would be too small an amount to distribute to claimants, (it would amount to about \$15 per person) the Receiver has obtained court approval for this money left over to go to the Glide Foundation, a California non-profit corporation dedicated to community service.

Enclosed is a draft from the Receiver and the Disbursement. As before, I ask that you sign the back of the draft, sign the Disbursement, and return them both to us in the enclosed envelope. As soon as we get those back from you, we will send you a copy of the Disbursement and your final check.

This has been a long process which I'm sure you are glad to see coming to a close. Although the money you have received over the past few months can never begin to replace the family members you have lost, it is my sincere hope that with the close of the case this tragic chapter in the lives of so many can also reach some measure of closure and resolution.
