- 5. Wants affidavits from any and everyone, both here and in Guyana, who can state (in court, if necessary, though he does not want to have to bring people back and would rather choose people who are here to show in court) that TOS had functions as general counsel for the church. Anything to witness he solicitied any of the cases? That he had direct dealings on the Medlock or Cobb or Katsaris suits that they can testify to. June and Jean should schedule perople from the congregation who would be able to come and talk to Nancy and Pat re. Stoen's involvement either as general counsel or as personal attorney as church attorney. Wants affidavits from anyone who might have been in Bux on Medlock property: consultations where TOS was involved.

6. Interested in having Guy Young talk to George. Wants Guy to get an attorney in Reno, will talk to Guy and help him get an attorney -- told him not to worry. Wants to get it documented that TOS talked to Guy's ex-wife and trying to get Guy to quit the church to see his child. Said that in the Walter Duncan And aafidavit TOS had perjured himself because he admitted a vendetta to Duncan and W.D. will testify to this in court.

One point I have not written and still am hesitant about is with something that happened right when Debbie Blakey was leaving here and Teri was arriving back. I have told Teri this and yet I still am not sure my independ is correct. Here it is for what it is worth

Debbie and Leona had an enormous conflict. It was always Leona's fault, at least as I heard things from Debbie's side. But as it became clear Debbie was going over, suddenly her "conflict" with Leona ballooned into an all out war, again from Debbie's point of view. Several times a day I would hear wild stories about how Leona was trying to get into the finances or how, when Debbie was gone, we should all look out for Robin because Leona was going to "kill" her. At the time I thought it was overdone, over dramatized on Debbie' part. My inclination was to think that she felt guilty about going over and leaving us, especially Robin, here with the responsibility. And so she built an huge case to rationalize, in her own mind or for the rest of the third floor, why she had to go.

My logic breaks down here, becuase I can't figure why building such a case would be likely to insure her trip to Guyana. Maybe it was just over-excitement. I know that when Teri returned Debbie made it very clear to me that she wanted to pick Teri up alone at the airport. I consented and Teri tells me Debbie painted a picture of a terrible race situation about to break out in the Temple. True, things were bad before Marcie especially got back. But I can't help thinking that Debbie played her part in fanning this thing with Leona. I am slow to credit Debbie with that kind of manipulation, but in the back of my mind I think it was the case. It is a serious thing to say, but the thought remains there and I keep coming back to it. (Again, maybe Debbie just couldn't handle Leona's hostility. And she DOES have it. I don't know how I would handle it either -- as of yet she has not targeted me.)

I am reading a book now which I tried to read several years ago and had no understanding for. Now I am inspired by it: Reminiscenses of VL by Krupskaya. It came along at a good time. I appreciate the perspective. I am moved by a deeper understanding of life by principle and see us, you, working it out all over again. 'I am committed to this struggle. Thank you for the opportunity to live life by principle.

"If it's true, that's another ball game. But how are you going to prove it? It is her word against his. Besides, if it is true, the charge against the Temple is a malice. You published with intent to hurt. Punitive damages. The element of malice is an important aspect of it. "

He wanted to know if SB had taken it on herselg to xxxx respond, or whether she had been officially speaking for the church...was she told to say that? I said I didn't know.unifuming

"This opens pandora's box. Records and all. Stoen cannot be the attorney because of a conflict of interest. Confidential stuff he was privy to But this is entirely uncalled for. You gave him solid ground for a suit. He can stay in business with this. He can probably contest that this is a separate matter, not relating to anything he was privy to as Temple atty. Or, he could easily get another attorney to do it. This is why I have never filed anything, though. This opens pandora's box."

At first he said SB should get over. They he said no, that causes too many headaches to have someone over. She should stay under house arrest -- meaning she is absolutely not to get served. We will have to disown her role as official Temple spokesperson."

Re. Stoen, he said: "This is very frowned upon, what he is doing."

- 2. Eax Krebs, the U.S. Ambassador here, is retiring from the foreigh serwice. He will be leaving Guyana about June 15th to go into retirement. I don't know where he'll ge going but if you send a p.r. letter to the U.S. ambassy here, they'll forward it on to him probably. Thank him for his interest and assistance to our mission here. Also mention about what a less it is to lose Mrs. Krebs(Esther, as the chairwoman of the American Momen's Group(which P.A. and Deb are members of). She(Mrs. Krebs) has actively participated in humanitarian cases of need (thank her for something like that). She was active in "charity" work.

Maurice King was recently appointed the new P.S. twik taking bertie Orderson's place. This is the top administrative post in the ministries. Bertie Orderson was a great friend to us when he was in that post. I hated to see him leave. Bertie is now the secretary to President Chung. It is sort of an interim appointment; not a promotion. He is going into the foreign service(so I've heard) and may join Claude Worrell in Washington. Bertie and Claude are good friends, anyway. I hate to see our two finest friends out of the country, but what can we do? If you ever have Orderson in your company, you can talk straight with him and keep in mind his many kindnesses and friends. He is a teacher by profession and loves that field, but his loyalty to Frime Einister Burnham and belief in a socialist philosophy/economic order took him into government service. He is writing(ar at this stage, may still be gathering material) a book on Prime Minister Burnham. Ironically, as it is, Bertie and V.H. are good friends too.

Thank him for his kindness in taking our members quickly in his dental office. Whenever we have people in from the interior on a tight schedule, he will try to take care of all their dental needs as quickly as possible. He said he would try to wire Jan's teeth together(but we have not had any need to do it since Jan has been staying on her diet). None of the other dentists we talked to would even try. He is Cheddi Jagan's brother although Sirpaul is quite different from his brother. 1 have heard that Sirpaul makes more money playing poker or gambling than in his flourishing dental practice. Sirpaul does advocate his brother's literature in his office, but I don't think his support goes beyond blood ties. Blood ties among East Indians in Guyana are very tight normally and I imagine their relationship isn't much different. Anyway, I've never heard anything different and Cheddie takes Sirpaul's practice when Sirpaul is out of the country or on vacation. Cheddi is a dentist also(I'm sure you already knew that). From this brief background, I'll let you decide how you want to handle this. I have mixed views as to just how far to go with this. I would like to have him see some of our literature on our humanitarian programs, but I don't know if we want to chance him being in possession of it. However, he could easily get literature from anyone who might be on our mailing list.

Speaking of Cheddi Jagan. Today he was officially sworn in by the President of Guyana as the Leader of the Opposition. This supplanted Fielden Singh. he may at some later date want to get a letter of introduction to Cheddi Jagan from Dr. Carlton Goodlet, when Jagan is more firmly established to be supportive of the FMC government. Jagan is back in Parliament(he couldn't be Leader of the Opposition in Farliament if he wasn't) and rumor has it that he may be the new minister close to our mission's "agriculture" program. I have no more than hearsay to go on. Will let you know when I read it in the Chronicle.

Dear Jean,

Thank you for the considerate letter. It surprised me that you apologized. For what? I know you are pressed for time and I have not been under any paranoic delusions that you aren't attempting to respond to my reports or requests. Knowing Charlie read your letter to me (it was on top of all of the mail on my desk without envelope when I returned from Jonestown), I was relieved to see nothing in the letter he couldn't read. He made an unplanned trip to Georgetown which I shall mention below.

This is the weekend of the Spiritual Jubilee with Muhammed. I am anxious to hear about it. I am sure it will be a smashing success as no one but Jim could make it. I hope it brings even more cooperation between different avenues. I with I could be there, but will wait patiently to hear about it. It sounds as if Jim has absolutely no time for rest at all. This isn't sounding the way I want it to, so suffice it to say that we miss him very much, but appreciate his consistent demonstration of principle.

I wish to apologize to you for my curt and nasty attitude on the radio acut the typewriters. You have done nothing to deserve that from me and I had no right to act as I did. I would like the portable to be electric and the long carriage one can be manual. I am disappointed in the quality of the typewriters sent to us so far. The Royal electric was a terrible choice (D. Wise made it). Karen L. said Tim C. had one just like it and it gave him trouble all the time. The IBM selectric was a dream and worked beautifully until a certain b....d assisted it in being smashed to bits. The electric Smith-Corona portable works all right except the period sticks (which it did in the U.S. according to 5.B. when she brought it down to me) and now other letters are starting to repeat as well. It needs repaird before it is too late, but I don't have a relief BB-S-e-1

typewriter and can't possibly be without one for one month to six weeks, which is how long it will be in the shop. Joyce said there have been three sent to Jonestown. None worked well from the start. I take that back, one of them did. The other two barely worked and did died almost immediately after arrival. The one she is using which is giving trouble now, she likes real well, but she is in the same position as me. It needs repaired, keeps getting worse, (because she has no replacement typewriter) and she can't do without it. Hers is a portable manual, but heavier than most. She wants a very heavy duty manual or electric. I don't think she cares as long as it is heavy and reliable. (she has strong fingers and really hits the keys)

On to other business...

- 1. Attached is the social security informantion sent for Jackson's. This is not retroactive, nor is it being deposited to an account for them there.

 This may be the response to their application sent in some time ago by me. When we got no response, you took over(not to take x away from the fact that I was thoroughly stupid-for not making sure it got processed from your end long before I did).
- 2. The p.r. flyers which I listed in that one letter are the ones I need.

 I am using them more in p.r. now than before. When I meet someone, or haven't seen then for some time, I give them a p.r. set of leaflets. It saves time if I'm in a hurry,; and also gives persons I don't have time to talk to at all some kind of background of the group and of our example of integrity so consistently demonstrated. I also send them out in letters of interest or to persons writing asking for healings (the letters I forward on to you). The ones I asked for large numbers of are for general mailings (if o.k.ed by you there). If not o.k.ed, I indicated a quantity for simply p.r. use.
- 3. You mank can tell Wanda that toys cannot be impossed here. They are encouraging local production of toys and have therefore restricted importation. & Actually, an unsolicited gift like that could maybe come in(I'm not sure, though),

but I don't think it would be fair to the others here because they do get equal birthday presents from Our Friend and also sending an individual personal gift would be taking away from that and making the individual more important than Our Friend. I don't know if wanda is reasonable enough to see that. If not, tell her they are banned items. To clarify for you...if toys were part of family personal effects(ised) shipped with several other things, they could come in, but not alone.

- 4. The radio strategy would have worked fine and everything was straightened out as we planned,...but...my equipment was faulty the first time, so I replaced the experiment using a different approach and that time I had a faulty battery. I was concerned that a third attempt might make things worse than they already were. I am thoroughly disgusted. The machine worked fine when I tried it bendothhand and the battery was fine last time I had used it. I hope that the man MIke called will be able to help.
- I am quite angry about the whole thing and can say no more than "Charlie, you forgot to mail the flyers". I was going to come back to Genrgetown early enough before Indapendence Day to give the mailers enough time to arrive(it takes seven days for something in Georgetown to reach someone in Georgetown). Charlie said he needed to go to G/tn to get some boat part because the trawler can't go to G/tn until something gets fixed. It seemed needless for me to hurry back to town when the flyers were all ready and only needed mailed, so I asked C.T. to mail them for me just as soon as he got to town. He did not do so and when I got to town, they were still sitting on the bookshelf. I do not like to have to come into G/tn unless necessary, but I don't have faith in anyone's followthrough here. Something more important can always come up and it is simply a matter of perspective as to what is the most important. Obviously, to him the

- 6. Charlie came into G/tn for an urgent boat part and the boat is not even scheduled to make any trips for quite some time, so I think it was simply an excuse to go to G/tn; and especially at that imparticular time --- I wasn't in Georgetown. I am quite disturbed at C.T.'s choice of travel buddy: Jeff. Bendmade a good point about no male or males should be alone in G/tn. Also, C.T. has absolute check signing privileges (ask Helen for details) and I don't believe Jeff was has changed, but is rather manipulating (which is o.k. as long as he is at Jonestown and works well). & C.T. gets negative so easily and then lets things get exaggerated in his mind. Joyce can handle those moods pretty well, but Jeff is not Joyce(what an understatement) and I thank heshould add to that negativity. Jeff is very devisife.. Anyway, I don't think we should let anymore situations like that happen. If that means me coming back early, I think I should. LThe peace with Charlie in town was beautiful, but I don't trust him without someone to watch him when he is in town controlling money of P.T. and there are only three persons I would trust to watch him: Joyce, Debbie, or me.
- 7. Joyce and I discussed: Debbie and I staying in Jonestown more often and transferring all of my files and correspondence materials there. I think this would give us an opportunity to spend more time there. The problem with that idea right now is that we have no place to work. The office is not really an office at all. It is, rather, Charlie's domain and we would cause a number of problems working there (Joyce and I both agree with methat). We cannot have a building built and called an office or that would threaten Charlie also, so what we thought we should call it is a "files and correspondence" building. We could just build one of the regular buildings and section off a part for use as an office. There are a number of suggested buildings to go up and if the program could get speeded up and one of those buildings go up right away, we could move a great deal of general work out there, but I don't want to do it until we have some place to work or it will get backed up too far. (Debbie

has straightened out the mailing files, which alone I had not gotten around to). but there always seems to be work to do on them and I don't want to let them get in disorder or out-of-date. Debbie needs to spend more time with Kike so we need to get this in motion right away. Joyce is going to approach Charlie about it, but want to keep you informed what we have in mind. There is another consideration which will have to be discussed and guidelines considered from your end. That is, that once in the interior we are cut off from everything. We don't even get the news up there. I have no way of following trends (because much of that is from conversations rather than newspapers), but perhaps I am overestimating my importance in that area. I don't know. I will not be able to do either p.r. or visitations (religious) --- which neither to regreat getting away from, but how necessary are they. Of course, I would still have to come in for customs or odds and ends of work now and them and could take care of some of those things while I am in town, but that isn't with any kind of regularity. I am really in a corner. I feel guilty not being in Georgetown doing my work and I feel guilty not being in Jonestown to help with the evergrowing amount of work there, as well as making it possible for Debbie to be of help to Kike.

- 8. You asked if I received a p.r. package awhile back. I need more specific information to answer that. When? What was in it?
- 9/ The letter to Llewelyn John is not necessary now as I'm fairly sure the matter has taken a different course, however, I think suspicions are lessened when people know what you are doing and if (beings we have met him) we do send him a greeting card now and then just to let him know how much we love Guyana and how we are working hard to assist the FCH program and how much progress has been made, I don't think it would hurt. If something ever came up in the future, perhaps it could be avoided. You can decide there what you want to do with it. I did not want a gift sent to him (that would be a bit too much) and I don't remember requesting a gift to be sent to J.Leila either. I do think a card should be sent to Leila, thought.

In September 1971, after having worked for three of America's large corporations and having suffered enough from their total European value systems, capitalistic manipulations, the American dream scheme (like so many of our Brothers and Sisters who are still trapped). Lwas made aware of the EAST/UHURU SASA SHULE, INC. 10 Claver Place, trooklyn, New York.

After having made several visits to its school and Afrikan Cultural shows on weekends, I began to find a new spirit of hope rising in my head. I could not overlook the need for direction, purpose and values practiced in such a troubled time for Afrikan people in North America. It didn't take me long to become totally involved in the struggle for Afrikan survival in the Brooklyn Community via the EAST Cultural shows (some people call it "Jazz"), EAST Bestaurant, BLACK NEWS, Afrikan Book Store, EAST Distribution and Publication and mostly the Uhuru Sasa Shule which is actually making a serious and well planned effort to reshape the minds of our youther it an Afrikan school for pre-school, elementary and secondary re-education.

I was able to visit Guyana in 1972 for the first time, when my head was again opened. Guyana is a country that is seriously challenging thru socialism the systems of colonization and neo-colonialism. You can say it was love at first sight. But there I was feeling new found hope for the struggles of Third World Peoples via Guyana.

Upon my return to the State(s) (of seige), we decided that we would again in 1973 sponsor a tour for serious students who wanted to visit and see Socialism being developed in Guyana. he plans that followed were difficult. We made another visit to Guyana to outline and confirm a schedule of events for our excursion, two months prior to the trip departure. We received not only a warm welcome but the full cooperation of our Guyanese Comrades. On August 27, 1973, some sixty-four (64) Brothers and Sisters departed from New York to Georgetown, Guyana: I will not attempt again to trace

the whole glorious excursion to Guyana but you can read about it in - Vol. 2 No. 10 Special Edition, October 22, 1973 of BLACK NEWS.

After that visit, we, the comrades from North America found it pretty hard to forget what stood out most in our minds Land Development, Agriculture, Farming, Feeding A Nation, Self-Determination, the Earth, the Source, the Energy.

Several visits followed to check out the possibilities of a Land Development Project sponsored by the Uhuru Sasa Shule, Inc., - Al-Karim School, Inc. We learned that first you have to apply for the land and describe how, why and what you intend to do with it. Land is of no use unless one is prepared totally to make sacrifices and committments with determination and discipline. One must be a pioneer - which means one who is the first explorer, developer, to prepare the way. A soldier, having a spirit to forge a head against most odds and to accomplish the goals. These words sound great but what do they mean. Simply, doing the work required to develop a Cooperative Farm. A pioneer is expected to work hard, follow orders, keep strict discipline, respect others, be physically, mentally, and spiritually fit, to be knowledgeable and skilled in some areas of farming, and to stick to the task until it is completed.

1974, we filed for land and received confirmation. This ear we paid the Survey Fees. While the survey is being completed, we are recruiting pioneers for the task ahead. A lease Agreement for 3000 acres will be signed for the Mabaruma, Northwest District - Wauna Area Land Site.

The work will be before us to develop a Cooperative Farm in Guyana.

Anyone between the ages of 21-40 can apply - wives, sisters included. We are not accepting children at this present phase and if pioneers are not swimmers, they should learn.

If after having read this, thinking the proposal over, and

discussing this with family and friends, you are ready, then so are we. You are welcome to grow with us in our task of building a Cooperative Farm. But please keep in mind it is a serious endeavor and should be attempted only by serious Afrikan Pioneers.

As the "All American" depression engulfs the nation the Black community will have to absorb some of the worse blows to be dealt to the empire. I use the term "all american" because the African community in america seems to constantly be in a depression because of our terrible economic and social conditions and political powerlessness when the nation is in a so-called economically progressive state.

While the New York City government is laying off tens of thousands of its workers one of the areas hardest hit by layoffs has been the departments dealing with education (Board of Education, Higher Education, School Crossing Guards, etc.). The city layoffs of personnel in the public education system is well above 8,000.

Although almost 70% of the city's million public school students are Afrikan-American and Hispanic speaking, the education personnel of these groups barely hit double figures percentage wise. What the Black community has to do is look at the politics and economics of education and see how the community can get its full share of the benefits like other communities/ethnic groups do. Until the Black nation takes a serious look at this aspect of their community and map out a plan of action for controlling and benefitting from the thought, mind and value shaper, we're doomed and will remain in a powerless, oppressed and sub-servient state.

There are millions of dollars in terms of goods, services and payrolls allotted to these, public educational institutions that are supposed to be nourishing Black minds and preparing Black youth for a better place under the sun. But because so many Blacks in their apathy allow their enemies (or possibly worse, mis-educated negroes) to carve out their children's brains, the Afrikan race still suffers from self-degradation and economic, cultural and political exploitation. Why in predominantly Black and Puerto-Rican communities are crackers still shaping Black thought, getting thousands of dollars to mentally castrate Black youth?

As we cry about unemployment and beg for jobs we should be looking at funds coming into our community from our tax dollars and seeing to it that the residents benefit first and foremost from them. What no other people on the globe tolerate, we are subjected to.

Everyday thousands of aliens commute into our communities to educate Black youth (), stop fires (), man (police) our communities, run our stores; factories and other



From my talks with both Charlie and V.H., I've drawn one conclusion: 1 don't know what's going on!

Here is a little background information on V.H. that might be useful in assessing the worth of his assistance. He is overzealous when it comes to spending someone elee's money on machines. He just loves machines. It isn't that he doesn't know what he's talking about when it comes to that specific machine that you're interested in, but he will try to get you interested in things you don't keed. He does know about machines and often finds very good deals on equipment, but I am wind of the one who stands over the whole thing and if it isn't up to the quality he claims, he either refunds the money or replaces or fixes the iter. (That is one aspect of the role I play in this). He does not stick to one opinion about what is the best suited for our needs. For example, he thought that the Ball community canning center was ideal for our needs when I first talked to him. I suggested looking into tin cans for food preservation and he thought that it would be too involved. Now, from what I am getting feedback on from C.T. and V.H., he is convinced that tin cans is the way to go. There must be a machine involved in the tin canning that he wants to get his hands on.

Charlie is really upset about the discussions with V.H. I think his ego is what is upset! He claims to be concerned about what I would have to do to get all of these things followed through from V.H. That is pure rubbish. He could care less. His ego is threatened because V.H. is being listened to without C.T.'s comments. It is a fact that it puts axiiting pressure on me, so I want to know if what is going on is worth it. I've done it for less, but I sure don't want to get into anything if it isn't necessary. I don't know if you even know what I am talking BB-5-h

about. He is an engineer, which we don't have, and he is quite willing to put his time in free(that is not my opinion, but I'm speaking in terms of dollars). I think he has been quite useful in the project and he has been generous and still is. I am writing in straight terms avoiding cynical comments. What good I do think that the whole thing is becoming a problem to Charlie. he would rather from a comment he made to me, listen to someone who is in the family than to someone who is outside. I agree with this when it comes to policy, but we need to tap from every source we can get if the knowledge is useful. I don't think Charlie agrees with that theory anyway. He is so threatened by anyone didn't set right with him at all. I do agree that bmitty needs to say he doesn't know something when he doesn't know. But for the most part, Charlie just didn't like sharing the king-cheese role, and I think that the kapacker meeting with V.H. made him even more threatened. Frankly, I don't see that there is so much difference between C.T. and V.H. when it comes to their commitment to 1.1. Soth are in it for the same reason just different faces.

I wrote the above before our first conversation and have not yet heard a reply about the subject, but I am going to go ahead and mail this with everything else.

V.R. has come over several times since his return and mebbie's presence has been an invaluable blessing. Frankly, I don't know if I could go through this thing if it were decided as necessary. I sounded very noble indeed before he returned, about doing anything necessary, but now that I have seen him again a few times, I don't know. Not only is he repulsive, but his condescending comments are getting from me.

I hot biting responses: This could make things worse if I were to start up another friendship and then make sarcastic remarks, than to just cut from him completely.

Dear Mr. Sheehan:

This is about as completely as we have documented the conspiracy to date. Perhaps the background will help you make sense out of the things I have been telling you over the phone. Enclosed in the envelope are two articles which refer to the child custody case I talked to you about most recently. They are not included in the "book" because the fact that Jim is the father of John has not yet been made public. (You will note that the articles make no mention of the fact.) We may take the initiative on that by holding a press conference in the near future.

Our questions are many, and they have to do mostly with the options we have in fending off the kind of continued attack we face now in Guyana. Just this week we got a letter from an attorney who represents the parents of two youths in Guyana; one (Bruce) Oliver is 19 and married, and the other (Billy) will be 18 in two months. The attorney tells us that both young men must be returned to the parents. We are not too worried about this, for obvious reasons. But the law partner of the attorney is also commentator on a local Oakland radio show. We were informed by Mr. Holmes and Mr. Warden that if we did not return the "children" immediately, the radio station would be very hard on us via Warden's radio show. If we did, their program would go very well for us. By the way, the Olivers have been in touch with the same Joseph Mazor.

But the case with the child John in Guyana is a very serious one. Your advice on how to protect ourselves from attempts to take this child, from a possible planefull of hostile relatives gathered up by this same bunch (Mazor, Mertles, etc.) and ultimately from attempts to try to take our leader, is very much appreciated. We do not see an end to the concerted efforts to dislodge or "de-stabilize" our group in Guyana, nor to get Jim, on any pretext they can come up with, into the courts. You said in our first conversation that when the attacker is irrational, you do not try to defend yourself with rational means. We identify with that very closely.

I think it might help to explain to you that our congregation is made up of people from all ages, all races, all walks of life; & all of these, especially now with the move to Guyana, Jim has taken responsibility for. Many are elderly, and most are black. "e are a people who have

suffered or who have identified with the suffering of lifetimes of oppression and deprivation. It is difficult to describe the pathos of the situation. For the first time in the lives of many who are there, they have a home, land, the best in schooling and medical attention, and --as one black sister said, for the first time in her life she could walk down the street and not be called "nigger." Now we find ourselves under the continued attack of this conspiracy of media, reactionaries, and government agencies in the States. In our evolvement together, we have become many things: a family, a people with a purpose to live and build a socialist life, and in most cases fiercely loyal to the leader who has cared for the rejects of capitalist society and given us, individually and collectively, the context for life worth living. Without Jim's vision and determination and love for us, nothing would have been accomplished.

I have enclosed for you, too, a copy of a letter received from a member of our group in Guyana, which we have made into a press release. Sharon is the mother of three racially mixed children, a highly educated and highly paid social worker and consultant. Her enthusiasm for life there needs little explanation.

Thank you for your concern. Any help you can give us by way of legal alternatives, a safe place for the child in dispute, or any creative ways to combat the continued intrusion -- we are appreciative and look forward to your reply.

I called saying TB had left town and suggested that I call; she'd said he was working on affidavits and would not be able to talk until Wednesday (today). He will be in Oklahoma for several more weeks.

When I described the situation with the media smear and the links with the T Dept he said there is a way of dealing with it. What is happening to us is not unprecedented. He made the analogy of the authoritative parent telling the child to be home at a certain time. You cannot arrue on the adult's terms, because he/she is irrational. Therefore, you go ahead and stay out anyhow, because there is no way you can successfully argue on their grounds and do what you want to do. Where the parent is coming from is an irrational assertion of authority.

Said he has seen this with clients who are "highly principled." He said he himself is a "highly principled attorney." People who are principled encounter extraordinary opposition, especially in the form of authoritative and regulatory institutions. Said he has seen this with cases he has worked on with F.Lee Bailey, and it was true with Scientology. (I am not sure what he means by principled -- it could be a range of things.)

The way you deal with this type thing is to kick back. Since the other side is not rationatl, not principled, you take them on with wits. Said (another analogy) a small fighter can't take on a welter weight fighting square, has to fight back by slipping through the blows. The media hate people about as much as people hate them. You should treat them openly, candidly, honestly, giving them nothing to hold on to. Then they feel satisfied. The worst way or responsing is to cut them off. Then they get twice as hostile. What we need is an extraordinarily adroit FR person. His best advice would be to get someone, not a P.T. person, who could dela with the press, interpret us to the press. He said NIXON cut the press off, and it was the press that destroyed him. Like a wild dog, they bite when they smell fear.

I told him that what I had described as a media smear was at this point our secondary concern. We had lived through that and were continuing to function, but that the truth was the media persons (named Jim Clancey) were admittedly working in collusion with government agencies (T-dept) to destroy the Temple. Now we were concerned how to counter this obvious conspiracy of governmental agencies. He siad that is the way it works, and usually one agency (i.e. Treasury, IRS, or some other) leads the way. His advice was to first write to him exactly why we think this is beoing done to us. Not to fictinoalize, To know the source of our problem, to deal with it, he will have to know what is triggering this governmental response. He mentioned a case in Florida with a guy named Glen Turner—a thing going called "Dare to Be Great" in which he had enormous training sessions for businessmentof somesort. Said that the A.G.'s met from 49 states and determined to undo this guy. (He didnt say why, but the point was clear what he meant by the source of the problem.)

Then he asked me to correspond with him, and a personal visit might also be useful. But first, I am to try to mail something to him using cover. He bluntly told me he figured I would know that that meant to mail a safe way: use another agency's letterhead on the envelope, mail from another city (he says where your mail gets picked up is in the city where it is mailed), surround all the edges with tape and make a mark under the tape which would show when and if the tape were removed. Then he said to call him to identify the letter that would be coming, tell him the letterhead to look for and the mark. I am to send general mail first. He will let me know from that end whether it is safe to use similar methods in mailing crucial contents.

I liked the guy. I think he could help us.

PHONE CALL TO D. SHEEHAN, FRIDAY 10/14 REPORTS FROM JEAN BROWN

He was very friendly, said that he had not received the mail he had instructed me to mail yet. Tom just had mailed it Thursday morning. We talked about the reasons for our persecution, as he had asked. When I mentioned the word, he immediately said, "Well, that would do it." Said we are in good company, some of his best friends have the same problems as I described for that reason. Said he has known that the Socialist Workers Party has been bothered for years with this kind of tactic. He will work over the week-end, so made himself available to us. Said he is working now on taking depositions against the FBI for domestic surveillianse. Will wait for the mail to arrive (he asked for "safe" mail, so I sent Peoples Forum and Barb articles, statements why we were undergoing this and so forth). He will call back the first of the week, unless I call him. He asked for specific questions to deal with, how he could be of help.

(As per our radio conversation of Friday, I will tell him full background and about Jeremie's and Minnie's situation and why. Also will mention Bonnie's project and ask what he recommends be done.)

Finally got ahold of DAN SHEEHAN this morning (Monday). He is in Oklahoma taking affidavits against the FBI, travelling all over until March 15 when he will return to New York. He asked about the nature of the proceedings in the Guyanese courts. Said in regards to TOS being in Washington that State Department and Congresspersons respond more readily to public pressure than to "principle." Ultimatlely the outcome of the custody situation will be determined by politics, and what Guyana choses to respond to -- his feeling was that pressure from State Department and Congress would have an effect on behalf of TOS. I told him of our excellent rapport there, and about Dr. Fernandes. He was pleased at that. Began to explain about the group of 10 freshmen congressmen who came in together, including Wirth, Dellums, Mossett, Pattison and some others who share staff, share communications systems, and generally try to make themselves open to common problems and "justice" issues. Said since TOS has talked to them what we should do is call one of their staff personnel, ask for the names and districts of all 10, and get a story on our behalf to the major media in their areas. Said Congressmen respond directly to press in their own districts. Called them "absolute relativists." Then not only will there be that pressure on them, but also if they are inclined to see both sides, it will give them something to back up their opinions. He said mainly we can deal with staff, find out the major media, and strengthen our hand in those districts which will have an effect.

Again he asked what were the proceedings in the Guyana court based on. Said there was a decision in the local court here that TOS had legal and physical custody. He said then the court has communicated that to Guyana for a decision on the local court level there. Again he said ultimately the politics in Guyana would determine the outcome, and he felt that they could be influenced either direction.

He just got appointed to the National Council of Churches committee on Church and Civil Rights. Said his main concern will be IRS harassment of "unpopular churches."

When I told him about our letter from IRS he responded immediately that we should keep him posted and write a 3-page introductory letter to the chairman of the committee, Dern Kelley, 475 Riverside Drive, New York, and explain the harassment of the IRS we are receiving and the work we are doing. We can use his name in this letter. 



Honorable Prime Minister:

Because I care for and believe very deeply in my Pastor, Bishpp Jim Jones; because I care about our people both here and in Guyana; and because I wholeheartedly believe in socialism and respect the efforts of your government to create a just, co-operative society in Guyana, I feel responsible to convey to you the nature of the persecution our church is currently facing here in the United States.

In the midst of a terribly polarized society, Bishop Jones has shown, in the most personal and in the most profound terms, that as Americans we can live together as brothers, as sisters, as comrades. Despite all our differences of race and ethnic identity, economic stratification, or philosophic point of view, we have seen by virtue of Bishop Jones' ministry that we can indeed work together for the common good. This example has had a tremendous impact on the communities where our congregations are located, and throughout the state and nation as a whole. The more successful we become and the more people we convince of the benefits of the co-operative point of view, the more opposition from conservative elements mounts as a consequence. The criticism being leveled against Bishop Jones here is superficial, trumped-up, and tailor made by conservative and reactionary elements to try to discredit his character and work and to prejudice the public against the viable socialist alternative Peoples Temple represents.

But I feel you should know, too, that the people here are not fooled by the Mc Carthy-like reaction which the media have become the vehicles for. There has been an overwhelming outpouring of support and encouragement from leaders, both political and religious, and the people who know and respect Rishop Jones for his sterling reputation as a champion of economic and social justice. Floods of letters, phone calls, and eloquent public statements have been coming in attesting to the good works he has been known for over many years and through many struggles. Just in the past two weeks leaders who have stood in defense of Bishop Jones include: California State Assemblyman Willie Brown; Rev. Cecil Williams; Civil rights activist and recent participant in the World Conference Against Apartheid, Racism, and Colonialism held in Lisbon, Yvonne Golden; California State Assemblyman Art Agnos; the Lieutenant Governor of California, Hon. Mervyn Dymally; American Indian Movement leader Dernis Banks; Dr. Carlton B. Goodlett, President of the American Newspaper Publishers' Association; and many more. People who believe in and are struggling for progressive change in American society are unified in defense of Bishop Jones. The precedents for this kind of attack range from Mc Carthyism in the 1950's to campaigns against Martin Luther King, Jr.and the Civil Rights struggle in the 1960's, to the systematic castration of

the Black Panther Party in the early 1970's. Viewed in this historical context, the present attacks on an eminent socialist leader come as no surprise.

There are no words to express the gratitude which we, as members of Peoples Temple, feel toward you and your cabinet of enlightened, progressive ministers, for the assistance you have given us. The Co-operative Republic of Guyana represents to us the chance to live life according to the principles of sharing and equality which we have come to treasure. Whatever tactics are used to try to "de-stabilize" our efforts, we will not be swayed from our purpose. We feel a deep solidarity with you and the Guyanese people in this struggle.

I realize this is difficult; but it is required for the sale. The last batch of mail I received contained some documents which had been notarized in Georgetown; it would be very helpful if you could somehow manage the same with this one. PLEASE RETURN TO ME IN THE MAIL AS SOON AS POSSIBLE the signed escrow instructions and the signed and notarized Grant Deed. The sale cannot be closed until we received these papers back completed.
- Vincent Lopez see report #34. Attached is letter from Jim Herndon specifying what he wants in Chet's affidavit. He wants this back from Chet as soon as possible.
- 3. Cynthia Pursley we have talked to her mom, who tells us that her divorce order includes the stipulation that the minor is not to be taken out of the state of California without the husband's permission. The order was obtained when Cynthia was still a child; there is the fact now that Cynthia is no longer a child but is regarded as mentally incompetent. We have yet to obtain a copy of the divorce order as Marilyn became quite upset and threw a tantrum when Jenny told her she could not go over for at least 3 weeks more. Before the tantrum happened, Marilyn was in the process of getting a signed consent from the husband. I talked with her on the phone before she was told by Jenny about not going, and she said that the husband had never actually enforced those terms of the order; in the beginning when she used to go on trips to Mexico she would tell him ahead of time but after awhile he told her not to bother, just go ahead. She seemed to feel that the same would apply here, that he would agree and not worry about Cynthia going over. The case is different obviously since Cynthia would remain and whe would not. This case will require some more work: I want to get a copy of the divorce order and show it to Jim Herndon and find out if there is any problem with the sisters over there taking over for Marily in re custody of Cynthia, and if it can be done without court process here, and if there is anything in the divorce order which because of the question of mental incompetence extends the \$i\$ interest of the natural dad past the age of 21 of Cynthia.
- 4. Serena Hunt see law office report #20, dated 2/28/78, item 1. Attached is a copy of that report in case you dont have it. The current status is that the convalescent hospital in which she was placed no longer will accept Medi-Cal papients. That issue is being fought in the courts in a class action by Public Advocates, and we have received the attached letter re the case from PA. We have this week received the attached letter from Serena's worker at Social Services. The problem with this case is that Serena's property is now in Tony's name. All of it. Jack Beam is the attorney in fact. The deeds are recorded. This could be a very touchy siguation and should probably be a property to get rid of soon. A long time ago when Baker was still with us he did a title check in Mendocino County on all properties in Tony's name and Ex knows how to do that again. - 7. Dolores Wilson She was supposed to come over this summer. Her sons are over there. She is completing her thesis to get her masters degree in education. She has a little girl, about a year and a half old, unrelated, who she wants to adopt. The child's mother was murdered, the child was found besides the body, in the blood surrounding it. She was so traumatized by the event that for a long time afterwards she would not speak. Her dad realized he could not handle the child and asked Dolores to care for her. Dolores worked with her and now the child speaks and behaves normally. The child stays with Dolores. Charles Garry talked with Dolores and the dad, who insisted on coming to the interview and has been showing reluctance lately for Dolores to adopt the child. Charles said he did not think that the child should be considered for adoption, that it would not be necessary and that instead the dad could just sign a consent, which he had him do. See attached. However, it appears tht the dad is not too hot on giving up the child for adoption and he is insists that the child keep his name and not

take Wilson for surname. He wants the child to go over with Dolores, thinks maybe someday in the future he could come visit the child.

I do not think Dolores would leave this child here.

Under the circumstances, since she is needed there and since she already has sons there, do you think we should rely on the consent already obtained from the dad? Leona and I discussed the possibility of Dolores going to another lawyer and trying for adoption; the problem with that is that the dad was present when Charles said adoption was not necessary. Charles did his usual p.r. job and won over the dad. For Dolores to go to another attorney might cause more dissatsifaction on the dad's part than we would want - and provoke unnecessarily.

- 8. Berda Johnson Have received attached regarding bill that is not being paid. Have warned Kris Kice to watch for posible process server at 998 Divisadero, which is where the letter was directed. No one there to tell process server where Berda might be. Though that is not entirely controllable situation, people will say what they want to say. This is for your information; no action necessary unless you think so.

REERLY Transfer of property to Pete apparenty we got our directions crossed up or something, because we though (Jeand and I) that we were told this weekend to immediately get the parcels transferred to Pete. Dear Dad,

Thursday

There are kits lots of things I want to tell you so I'll attempt to write them down. For all the problems in San Francisco, there is a lot of strength stenacity in people. I will write a summary of each person, how I think each is doing in this report. Marceline made many phone calls to people all over the Bay Area and found a positive attitude towards the Temple and from most people the idea that we are still around in strength. That is an accomplishment that lots of people working together have done. I don't want to minimize, the positive aspects because there are many. But many mistakes have been made and problems that have come up I really do not know how to get around. And those are what I want to try to describe.

Terri and I talked about them when she arrived, and she it told me some things I did not know. One is that some phone patch messages were not getting through to me and another that Sandy was talking to Leona behind my back. So I'll start with Sandy. For months i was satisfied that things were going pretty well. Sandy spent lots of time with Leona and they built up what seemed to be a good communication; Sandy waited on Leona hand and foot and I spent most of my time trying to get radio traffic done. Leona was cooperative and we made collective decisions in most instances that wm worked pretty well. That all changed when the crisis over Leona's sister cameup. Leona took all of us on over that, including Bandy. Since that time, or increasingly since that time, Sandy has cut herself from everything and everybody. She gave up trying to matixmaintain the relationship with Leona and "started "sandbagging"herself in her room hours and days at a time. This sis going on currently. She told mareir Torre already that she expects to die within not too many years and that she is really sick. She said she will not go to the doctor because he will tell her there is nothing wrong. All I know is that she complains constantly of having no energy and LYCLEx is goes to sleep in her room, opting out of all responsibilities.

Re. her ailment, which Debbiervans says potassium deficiency, Sandy . said that you knew. I recall that you had told her to keep drinking: water. Terri explained to me that Sandy had taken us all one ridewith that one -- that was strategy to cover forta message given about "Bibles" and was necessary to keep up the context in radio conversations. So Sandy goes all over the Temple with a bottle of waterand drinks gallons. always thought that was literal, and Sandy took me for a dummy, usings sickness as an out. I cannot mgive her assignments, that was going on and little got done. either, as I am not in a position in her eyes to do so. What Terri told me she was doing to work against me was say such things to Leona as "Why is Jean the only one who has the keys to the money?" To my face she has been friendly and supportive, and we have had no friction. But then I ask nothing of her. Terri also told me there have been phone patch message when I was out of the building that I never got word of. If feel that I am constantly left to fend for myself by Sandy, and also undercut.

She handles the petty cash and while I am out of the building; people come to her for for small amounts. Itsually she describe have more than \$150.00 at a time and does turn in the receipts. Lately she has asked for \$500.00 for tonic which she describes as a special kind of supply for you, which I presume is legitimate. However, I am not allowed to see it or know where she goes for it - she cuts all the information off the receipt but the total amount. This has happened to the total amount of \$500.00. Now she is ready to come over - I would encourage it as she is of no help down in San Francisco. She plans to come in October.

My problems with Leona started when out of the blue she jumped me for holding out information on her -- that was the Kwan case which I was the Kwan case which I described in one of my write-ups. She and Mack both jumped me. My paranoize of her since then has made it hard for me to deal with her, and I am sure

that has made matters worse. I live in constant fear of being in a situation where I will be confronted for not communicating something or for having made a decision without consulting with her first. I really need to know h how to deal with the situation. When instructions comeover the radio, the are often met with opposition from Leona (and from June, also, which I wil get to next). I feel the opposition may not even be so much to the radio instructions, per se, as to me. That gets so damn hard -- to get work done is one thing, and to steel my nerves to the point I don't feel personal attack each time I open my mouth is another. I feel like it is a no-win situation. I believe that input from people is good in most situations my own judgement is naive and often I do things without thinkingthem thru first. But the input in recent/months has notbeen constructive from Leona -it has been personal attack. That is what has caused me such emotical problems. I can deal with peopleand problems in a systematic, rational with dogmatic fashion. But when reason fails and everything is irrational, like Leona's actions since her crisis over her sister -- I am lost. And I have experienced paranoia like never before. When we go see Garry, which Leon3 has included herself in ón since Terri left last time, we go over all rado instructions together first. For awhile we did well -- came up wth reasonable approaches to get out points across. Leona can be teriffic in that regard. But since her sister's situation again, it seems to me she uses every occasion to justify her position. If Garry is passed because we changed instructions on him, or want to manipulate him in some way -- she just says, "You can't treat people on the outside that tay," or some such things. She makes is clearshe is not defending Garry, but attacks me - Ter ri- the radio -- who ever is the responsible party afr for the message. It has become an impossible situation, and you brought change to us when it

was badly needed. LYCLE FUR ELEMENT OF REFL CYZZYAY I need to know how to deal with Leona before I go back; whether to acquiesce and epologize and

all that; and how to get things done at the same time.

I am sure that I have my part in this. I am closed with information, and many times I am sure i have made stupid judgements and omissions. What I fear is the feeling that there is no way out of it -- that there isn't some change I wan make or some technique I can leran to avoid such a stalemate happening again. I believe shi is on a power trip. She accepts no mann countering to her opinions and demands allegiance and instant follow-through. I am not the only one to feel this: Tom, Clancey, Sandy for others. Also Randolph. But when being acquiescent to her demands means a conflict with radio instructions, I do not know what to do.

When I said earlier that June expresses opposition to radio instructions, I talked to Terri about it and she said to be sure to tell you. Juen did not express to you the conflict that I have seen in her many times. She feels, often, that instructions are an imposition or not legally sensible and gets hostile. She often walks out of the radio room mad. Then she gets guilt because she feels it is disloyal to question and clams up about her feelings. This has happened many times. She menticed something to Marcie about it when she was in S.F. the last time. About two weeks before June went over to Jonestown, I finally conftonted her. She was pissed with me because I asked her opinion on amm some instruction for Garry which she disagreed with with. (June has no love for Garry, but she has little tolerance for any sort of maneuvering or manipulation to get points in or get responses from him. I told her something was going to have to give because we had to work together or everything would fall apart. I told her that her imput was valuable because to just put things to people without discussing it XXXXXXX first was not what Dad desired, either. We are supposed to use our collegaive head. She just said, "I am a negative ar person; just call me Leona the Second .: I cannot stand positive people like you (Jean) and Laura Johnston etc." We talked it out and I think made some sense of it, Her attitude improved and I have nt not seen her since she returned. Part of it was just needing a rest,

I think. But this conflictof June's hason several occasions puther in the position of backing Leona against instructions. The night of the event with Don Freed and Mazor when June, Mac, Clancey and I were at the hotel, Sandy called to reinforce the need for a press conference. While I was still on the phone, June asked what Sandy wassaying. I told her that the feedback from Guyana was to go ahead and have a press conference that night — and she openly and loudly put the idea down in front of Pat, the legal secretary from Garry's office, Mac some others.

I feel that most of the time she tries to work with things and cooperate to find the best solution. Her work is steady and speaks for itself. When I explained to her that things that come across the radio for Garry are not necessarily legal points - but sometimes thoughts to motivate him or encourage him to look forther down the road etc - she said she could see that and we have made some headway. But before her trip here she had reached a real low point and her negativity about some of what comes across the radio is a real obstacle to getting things done. Terri told me June said when she was here that she did not know anything about your ill health. Yet I tald her myself in the radio room right after I had heard it that you had lung cancer. I don't understand why she said that and will ask her when I return.

I think the mess-up with Mazor could have all been prevented if we in San Francisco had been working together instead of at odds. We should have reserved judgement instead of jumping for Freed's and Pat's conclusion; we should have listened to the tapes for ourselves and given you our collective opinion on what was said in the St. Francis meeting.

But Leona was not on good terms during that time in view of her upset over her sister. Mac was suspicious of the whole thing. When we went over the plan with him the evening before, he unly took the contract to look at with his fingernails and would not touch it and for the first time (after having been in my room many times). Also dif the loudspeaker in the ceiling were some sort of electronic device. And I was content to BB-SW-S After Truck West.

to listen to Freed spin tales about Stoen and sip a glass of wine rather than begin work listening to the tapes right away that night. So by the next day when Clancey copied the tapes and I started transcribing, it was already too late to register our misgivings because Chalres was getting ahold of Mazor to get him to go to Guyana right away. crand then the probilem became dealing with Garry about Mazor. We in San Francisco bearn the full responsibility to of landing Mazor in your lap the way he did. I

The assumption that seems to underlie the trouble there is one of race -- one that I think Leona capaulized when she said that no black people (in Peoples Temple) are listened to unless they talk up. I get this from Archei who immediately, when he is not consulted on something, assumes he is being patronized. He told me as much. I attribute Vera's (and also Dennis Allen's) attitude to the same thing. When Paula first arrived, she made a d thoughtless statement when a question was directed to her in finance meeting. Someone asked her about the soles of boots and whether a certain typed held up in the rain. Paula axax and swered that she didn't know, the question should be referred to Hue because he worked in the mud more than she did. Vera instantly shot the statement to Naxine sitting a few seats over and asked, "Did you hear that?" Paula didn't know what was going on, but that is what constantly plagues us there -- There is an attitude of looking for fault in white leadership, and of course there is plenty to find.

Archie told me before i left to tell you that if you need him, he will come. He works very, very hard and at clast with AJ, though he gets way out sometimes. I can still talk to him with the hope of working thing out. I think his leaving would be a sore loss to our crating efforts because he is black leadership which the crew respects and follows. In that

regarnd, there is no one to preplace him. But I think that when he says he is ready to come, he probably means it. Rosie has been having trouble with blood pressure. It has stabilized now, but was way up,

· The publications department have been going through some ups and downs. Patty Chastain and Kathy Tropp have had difficulties, probably from working together for so long in that samelplace, as mucheas anything else. Kathy Tropp wnet out and got temporary work without asking anyone. Her note to counsel about it a day later (she worked for a termporarty employment agency at a bank) she said she resented Tim Clancey for not teaching her to run the presses and she couldn't stand working with Patty any more. Sandy, Leona and I talked to Tim and then to Kathy. Tim taughteher to run the presses within a week and the situation seems to have smoothed out. Patty pulled me askide the day before I left and said she had to talk to somebody because she was getting so negative. I really think that the turn of events wth the Peoples Forum coming up, and the hopes of good press will pick things up in that department. Patty loves working on the Forum and feels it is a real contribution she is making. Tim seems to hold up with a real positive attitude. I have sought him out more than once as someone who keeps his head and a positive perspective, when I needed to sort things out with someone.

Randolph keeps on very steadily. He said something that alarmed me a few days before I left. Said he had adopted a new identity -- a non-identity, a non-person. Like he had resigned himself to a life of work only and no illusions to rely on. I don't know if that is an accurate interpretation, but he somehow keeps on with a lot of tenacity and usually a good attitude. Marcic Said she would talk to him.

Maxine Betts works very hard and trys to be of help in lots of fit different departments. She helps in Puplications, in accounting work for me, in packing, in counselling and of course in the kitchen. She is going to school again for dentistry and keeps a very hard schedule much of the time. She is a great help there, and one who does not let the race thing dominate her thinking. She is a real support.

Andy and Tom seem to keep plugging with no complications. Tom has developed a liking for Hattie but it dres not run interference with his work, which he will do whenever seed. He too is paranoid of Leona. He said she put her hand on his shoulder and said she used to have Johnny AS A son, then Hue, and now Tom was her son. Tom of course swondering what that will entail, to have been duly annointed. Tom works wherever he is asked, and that includes the back lot crating and the kitchen, both of which help a great deal. Andy continues with procuring and PR — whenever there are calls to be made in the community he persists to the last degree. He seems to have fearned something about consulting before acting, though he still gets in some tight spots.

Irvin is another person who can be counted on to enlip out in any number of stituations. He is very cooperative and like Maxine, his pre-occupation is not race. He is very level-headed and works extremely hard.

Donxsee Swaney has her ups and downs in moods, but I think has a lot of staying power. She recently volunteered to help Kathy Richardson outin the lettersoofrice. She usually is very willing to help in any capacity and keeps at iv. Lauric Efrein, bo. She works amazingly hand

Phyllis Houston is in good shape, I think, but then she is so Considently! quiteand FRE repressed that it is hard to tell what sherreally thinks.

As long as she is involved in things, such as PR, community events:
and some of what its going on, she seems ok. She stays very close to the

Temple -- is always on hand, even during much of her workday, if that is
any indication. Pictures, letters and radioconversations with her

As for my position, it is notworking out very weel doing thefinanced job (having to be on hand most of the day for money matters and being on the receiving end of the hostility that goes automativally with that position) and the radio, to getthat work done. I hope it can be worked out for someone to be there to hlep --not Terri because she is invluable here in Jonestown. But somebody to help takethe radio notes and dispatch the ra work. Someone who can relate to Leona to o. That's what would helpame the most. Sandy could ideally fit that role, 1 77 7 C. C. but she hasnot.

Thank you for the chanceto behere again. I wantto be more reliablehelp to you in San Francisco. I hope articulating these problems can help sort things but. Thank you, Dad. Jean
