DISCIPLINE GUIDELINES

A. PUBLIC SERVICE OFFENCES:

SERIOUS FIGHTING (VIOLENT) WHEN ONE IS ANGRY AND DEFINITELY TRYING TO CAUSE INJURY.

PHYSICAL VIOLENCE (SINGULAR VIOLENT ACTS) DELIBERATELY HITTING; KICKING, TRYING TO CUT SOMEONE, TACKLING, WITH NO SEEKING PROVOCATION.

RIDICULING ANOTHER'S PHYSICAL APPEARANCE

VANDALISM DELIBERATE DESTRUCTION OF PROPERTY OF THE COLLECTIVE. (EVERYTHING HERE BELONGS TO THE COLLECTIVE.)

STEALING TAKING SOMETHING THAT IS NOT YOUR OWN WITHOUT PERMISSION. POSSESSION OF A STOLEN ITEM OR STOLEN ITEMS.

MALICIOUS TEASING MAKING FUN OF SOMEONE'S SEXUAL PREFERENCES, REMARKS OF A PERSONAL NATURE INVOLVING OTHERS OR RELATIVES OF ONE, MENTAL DEFICIENCIES, LACK OF COORDINATION, ETC.

THROWING ROCKS AND OTHER DANGEROUS OBJECTS IN SUCH A MANNER TO CAUSE INJURY.

PROVOCATION BEHAVIOR LIABLE TO CAUSING ANOTHER TO FIGHT, HIT BACK, SUCH AS INCESSANT TEASING AND TEASING ABOUT THINGS ONE KNOWS IS DISTASTEFUL TO ANOTHER.

EXTREME BOISTEROUSNESS DISRUPTIVE BEHAVIOR, LOUD BEHAVIOR, PLAYFUL, CALLING OUT IN CLASS HAVING A TEEFER TANTRU, EXCESSIVE TALKING, RUNNING AROUND CLASS.

EXTREME VERBAL ABUSE CURSING, TALKING DOWN TO PEERS, TEACHERS, OTHERS.

DECEIT COFYING/CHEATING OR GIVING ANSWERS IN TESTS SITUATIONS, WITNESSES TO LIES OR HALF TRUTHS, GIVING FALSE INFORMATION, TALKING BEHIND THE BACKS OF OTHERS.

CUTTING CLASSES WITHOUT PERMISSION OR WITHOUT AN EXCUSE IS REALLY SERIOUS AND SHOULD BE REPORTED TO CLARA IMMEDIATELY.

NUMBER OF POINTS CONSTITUTING CLASSROOM WARNINGS ARE:

FRES "A" AND "B" & PRIMARY 1

5 points = 1 classroom warning
2 classroom warning = 1 floor warning

PRIMARIES 2, 3, & 4

3 points = 1 classroom warning
2 classroom warning = 1 floor warning

Note: Dad had a commentary on the pineapples. Some people are picking them without authorization. He wants this stopped. IS should be notified and some arrangements made for securing them.

Citrus

Should hereafter be off limits--automatic PSP offense.

Shirley continued with her report.. $\frac{1}{2}$ cup of beef liver contains 45,000 units of A, $3\frac{1}{2}$ oz sweet potatoes contains about 7000 units of A. It is very nutritious and all should eat this wholesome vegetable.

Truck

Discussion arose as to bringing out the truck from town.. Ujara was making \$50 per day when he was in there on one contract he had arranged --there were other jobs. Said could look in construction, hauling fertilizer, Rice for Guyana Rice Board to the ~~xxxxxx~~ docks and ships.. someone needed to follow this up. He pointed out that once you have proved yourself reputable, you will be trusted with more and more jobs.

Someone commented on the Peoples Temple sign on the door of the truck--draws hostility from locals who feel we are taking work from the Guyanese..even though there is more truck work than there are trucks to do it. Touchette's pointed out this condition has persisted from the start and will continue--to some, we are yankee foreigners and will remain so...

In discussing which would be the better truck for town, Ujara felt the stake truck best--take sides off and use for the rice, etc. Out here, we need the dump truck --we have a lot of rocks and fines, etc., to haul.. it will also relieve the tractors so they can be used in agriculture as they should be for most part.

It was pointed out that by using tractors to do truck work in the wet, then, when it is dry and we need the tractors on the land, they are broken down and in need of repairs..from abuse.

Abuse in town

Hugh Fortson mentioned that the trucks in town are being shabbily maintained. Trash left in them, and ~~then~~ them up like we have done the pickup out here..THIS SHOULD BE STOPPED!

Dad said that money CAN be made on the trucks, and that someone should be deciding to go in and make that money. Ujara will have to go in and get it set up --then Grenshaw alternate with him...

Ujara said he had contacts with the rice board, with John Fernandez and with some of the trucks that haul containers.. you get \$100 per container for hauling them..

It was mentioned a survey should be done.

Gene commented that the ability to put the tractors on our land MAKES THE DIFFERENCE --for instance, without tractors we can plant 50 banana trees a day...WITH TRACTORS, WE CAN PLANT 50 an hour with aid of 2 tractors...This is a major production difference. We don't drink and don't believe in smoking --not for moral reasons, but for health reasons first, and second cannot see spending our collective funds on such items. There is no crime in our community. We believe in the principle of cooperative living as in the days of the new testament. We correct by denying privileges when people do wrong.. We don't believe in suicide..it is a selfish act.. makes others feel rejected, and leaves whatever job you were doing for someone else. Rule about smiling..ALL ARE TO SMILE.

The chair is to be shown along with the broom when our guests come in..

Cleve and Helen are to go to town..Cleve has to go to the boat.. Richard is preoccupied with Janaro..Cleve and Helen get in there. Dad wants something done --train Philip for Captain and Solomon for Engineer. Lost \$40,000 but can get some in another contract..breakdown on boat due to carelessness and Richard too lenient. Cleve went on board and declared he was the owner and got them to hustling. He is to get the part repaired and get it back into town.

Dad wants black cat caught and castrated--picks on the other Toms..

Get the map of sight plan up on the wall.. 100 crates coming in; must work all night to build a warehouse, Dad said.

PEOPLES RALLY NOTES, 8/1/78

o Dad has called a joint Pavilion gathering to discuss the issue at hand. Issue: Several of our people including Dad and Joyce Touchette are sought to serve papers on by the government who seems to be participating and/or cooperating with the conspirators, Tim & Grace Stoen who is part of the Interpol connection in order to stop the revolutionary movement of Jim Jones.

At this point the discussions have been focused around the peoples willingness to uphold our long-standing commitments -- one for all and all for one. The custody cases are what the conspirators are using to get the cooperation of the Guyana government and what be cooperating capitalist in disguised positions of the PPP and PNC.

Jeff Carey brought out some important view points -- some like Pauline Groot feels some are focusing too much on historic recognitions through "revolution suicide." Glen Moten whose views were somewhat different last evening -- now says he would be for the revolution suicide. L. V. McGinnis, Jonestown Police Captain, was very undecided about taking the children's lives if the situation arose in order to prevent our children further pain and torture. He said he would after long reasoning with him.

Carolyn Loomas says she is against revolution suicide. Legistic emergency was called at 7:30 having been gathered in the pavilion since 1 p.m.

Hazel Newell, Ruth Lowry and Chris Buckley didn't raise their hands when Dad asked who would be willing to help in taking the lives of our children and seniors so they wouldn't fall into the hands of the fascist.

Dad gave a summary of what has transpired. Some that were first against "revolution death" and now are in accord like Glen Moten and L. V. McGinnis. Dad said we may be in for a long wait - like the police back in states do. Rob Gieg, Bob Kice, Don Fitch and others are to discuss a plan to get what we need if we have to. Dad asked for pharmacist and medical report.

Dad said we may just wait - the enemy want to weaken our morale. Dad said we have to decide if there is a stage which we will consider revolution death. Dad said each person will be watch to see if you have bullets left. This is for everyone's safety.

Question: If they don't do anything - do we proceed to make a provocative act? The best thing is for them to make a move against us - then

the socialist thing to do would be to take hostages and negotiate freedom.

If: If they don't let our boat out and we ~~are~~ shut off...

If they arrest our people in Georgetown... then that does give us a right to move - expect that this would justify provocative action. We could move the battle to places we've talked about. We need to be ready to move in the course of getting what we need.

Judging what a provocative act is:

- o If they do nothing - can we live in a state of suspension every day we're here.
- o What if they let things just come and go with their little papers..
- o And if so, how do we know they will be coming in to serve papers or make an arrest - question about coming and going.
- o How do we say we don't want any guests.

Dad said children can fight at age 12 - will consider younger. Like Martin Amos who wants to fight - Dad said first see what their philosophy is.

Dad said no one is to take any mail. Rhevena Beam brought in an envelope, business type envelope, to Johnny - Dad asked her why and if she'd heard him say no mail was to be brought in. Rhevena said no -- Patty Cartmel said she heard it.

Burnham previously said there was to be no service on us. Dad said he was to call us at 1 or 2 o'clock about perimeter of protection saying no one outside of Guyana would be able to touch us. Gene Chaikin feels the reason it is taking them so long is that they just haven't come to a conclusion and that they are just that way -- slow. Says they just haven't dealt with it yet. Dad said its a very dangerous situation.

Dad said when Stoen comes in -- he can't go out.

Discussion:

We should prohibit them from coming in - if they send reinforcements then we know the government is enforcing it.

Dad said it is also against the law not to let any government official in. And it still breaks the law if any of their party is refused.

Pauline G. suggested demonstrating in Georgetown saying we want to be Guyanese -- Dad said if they gave us Guyanese citizenship and guarantee us in writing then we will, but until that time we won't.

Issue: We don't want folks coming out here and taking our people, Dad said.

Katherine Dominick (senior) says erect a double fence at gate to keep them out.

Dad mentioned that it was risky at gate - need 2 people for talking and one stay with radio.

Mary Wotherspoon will finish casava at 7 am tomorrow. 80 bags can wait 3 days. Rob says it should be spread out in shad at the mill where it won't get rained on. Jan said tent would be ok - then it was suggested to spread it out under the dorms.

Dad asked for those who would agree with Gene's idea to take hostages.

Dad mentioned that PNC was unreasonable - they wouldn't take Russian aid. Russia wanted them to include PPP - question about PNC refusing.

Lee said make a show of arms - Steve says they shouldn't know what we have until they get in here. We have a chance with an ambush approach, but not if they already know what we have.

This would be an ideal time to make a stand on basis they refused to adhere to Russia's offer.

Etta suggested seniors and others laying down in front of land rover. Penny feels Stoen will come in with more forces since they didn't come today. She says we should consider getting Dad and children they want out.

Lew asked if local enforcements could come in without the direct approval of Burnham. Gene said local official is authorized without going to Georgetown. Does he control Gaskin police too - no Benjamin in Port Kaituma. GDF has the big weapons.

Lisa said have seniors lie down in road - Dad said but we're dealing with fascists, we're not fighting socialists. PPP doesn't meet Dad's expectations.

of representation but it would not be satisfactory because of the
class system -- no equality. Love or lust of money would lead to
its destruction. A few would have all the wealth. Two classes --
wager : the ones who owned it. First when the theory of Marx was
tried in Russia they had capitalist ambitions. Stalin had to lead
the people through a conspiracy and the major power of Germany - the
conspiracy was funded by leading industries of the U.S.. In World War II
Rockefeller was making money on both sides - he owned factories in
Germany. Stalin had a progressive government until the late 1930s.
He established communal and agricultural production. Imperialist
agents bought off some of his generals in his army and his staff. It
almost bought destruction. He arrested them and had some killed.
He began a great purge. Some were put in camps, institutions or slain.
When Hitler invaded them they were only 16 years removed from feudalism.
They resisted until they committed suicide rather than let them take
them -- they held out 3 years and never surrendered. They wouldn't
have been able to resist if Stalin had been a bad man. They made
circle around their city like we do and had to eat their own dead.

The capitalist could not break through. Moscow fought off Germany as Stalin was being fired on. Stalin wore used clothes and left no inheritance. His daughter left and went to the U.S. American didn't win it. It was won in Stalingrade the city named after their leader. The seniors fought with pitch forks and they kept on marching. (Not sure Russia had him killed) - probably because he was no longer reactionary. (Marx has been right in predictions about capitalists - it will fail). But thought it would take place in an industrial country, but instead in an agricultural setting. We believe Marx theory was the best theory of economics to go by. We don't say Lenin was perfect and neither was Stalin. (Sebalina - Stalin's daughter). Stalin died of a cerebral accident - he had maintained life for some days then died. It was said that people worshiped him too much. Sebalina was a strong supporter of her dad. He was not forced to retire - they removed him. Stalin had to be tough.

Dad said he's tired of gossip - Dad said he has two children one person had to be trained to fuck. Kimo is Dad's son. He knows how to teach people. It's a burden to have sex with people you love. If you really need pleasure you could get out and find it in the night. Dad said he only has two sons. One is little and one very tall. Dad believes in general love -- doesn't love one more than the other. Dad mentioned how Grace had wanted him to marry her. Dad said we ought not to be moved by physical appearance. We should like people out of character.

Your cells are dying at that age. Dad mentioned that he is the only one that can bring people back and give new life to dead cells. People here are in better health. When people come in from states they look blotted.

Dad said if Grace S. was an ordinary woman she would want her child happy, but she doesn't care about him. Anyone can see he is an obviously happy child. All children here love animals. Dad said how miserable John was with Grace and that at the age of 2 he wanted to die. John hates capitalism and loves socialism and speaks of it with every breath.

Dad mentioned that Tim had asked him to save Grace from committing treason. Dad got Tim to be a normal homo-sexual. He and Grace both saw John as a sex object. They know if John dies they won't have to remember any more how they treated him. Dad says he doesn't know if anyone admires him because you know he requires you to do good. Chile is in a bad state of affairs and they can't do anything about it. Argentina is another one they can't do anything about. America couldn't stop Angola and the Cubans they let them go on and win its victory. Dad feels it would be an even longer day before they would come in and do anything with us. The prime minister keeps a third world view but doesn't line up directly with a major communist party. Carter has given Guyana several billions of dollars of aid. Obviously he doesn't want to get into a war. It would be silly to think they would want to provoke us on any act. It would embarrass the government that

they have already established trade with. Two parties: PNC reserves the right to trade with all communist nations but won't line up with any particular one. PPP is lined up with Soviets - more Soviet oriented. No right wing to work with here and even if it did, we have the people.

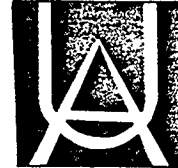

Heading the teaching staff is a veteran in helping children overcome learning disabilities, Tom Grubbs. Primary-level classes are small, emphasizing expressive skills, and the fully-accredited high school uses the community as an open-air classroom, training ninety students in over twenty different fields, from veterinary medicine to mechanics to food processing.

It all led to the establishment of a fire-and construction-brick factory, now in production. In the huge food-preparation facilities (3000 meals per day, plus snacks, special dietary meals, etc.) new specialties and delicacies are frequently cooked up from locally grown products. Many jungle teas, herbal and medicinal recipes have been concocted. The diet is balanced with a variety of vegetables, poultry, fruits, and even whole-grain rice (a non-paddy variety), grown right in Jonestown. Nutrition levels are high, [as witnessed, for example, by a visiting head of a Guyana dental school. He examined 87 children and found a total of two cavities.]

Up to three hundred people a week, mostly Amerindians, come from as far away as fifty miles by canoe and on foot to get treatment at the Jonestown free clinic. Education is of critical importance in Jonestown. Classes of all kinds are offered to the community at all hours. A campaign is underway to wipe out illiteracy among the elderly, some of whom had virtually no formal schooling. Community education and entertainment is enhanced by a 10,000 volume library and a large-screen television system with over a thousand hours of high-quality video-taped programming. Spirited "town forum" meetings form the cornerstone of an elaborate structure of participatory government. All have a voice, from the oldtimers down to the children.

If there is any group approaching homogeneity, it is the 250 senior citizens. Mostly black, many started out in the rural South, but found themselves at the end of the line in the inner-city slums of Chicago, Los Angeles, and Houston. Today, in a place where gentle, persistent trade winds temper the tropical sunshine, they have found peace, and a new lease on life. They are pleased to be useful and to participate in every area of community activity, and they enjoy the respect that elderly people deserve. 90

In the early 1960's, while on a missionary tour, Jim and Marceline Jones passed through British Guiana. They had a good feeling about the people, the climate, the atmosphere. In late 1973, Rev. Jones and several staff members went back there -- the nation had won its independence in 1966 and was now called Guyana -- to discuss setting up an agricultural project. They were offered a large tract of land in the interior, where the government has been trying, with limited success, to encourage the Guyanese to settle (practically the entire population is concentrated on the narrow coastal plain), and develop the rich potential of the land. Back in California, members of Peoples Temple discussed the offer, and soon dispatched a "team" to Guyana to pioneer that initial land-clearing and construction.

A creative manufacturer of educational materials, Grubbs has developed an array of home-made interlocking wood puzzles, board games, and special types of blocks that make learning fun and challenging. The fully-accredited high school, in addition to regular academic subjects, uses the community as an open-air classroom, training

ninety students in over twenty different fields, from veterinary medicine to food processing.

On one occasion, a science class discovered a deposit of a white substance and found it to be a high grade of firing clay. The find led to the establishment of a fire- and construction-brick factory which now is in production. The development of this "indigenous technology" may even revolutionize construction in the district.

In the huge food-preparation facilities (3000 meals per day, plus snacks, special dietary meals, etc.) new specialties and delicacies are frequently 'cooked up' from locally-grown products. Many jungle teas, herbal and medicinal concoctions have been developed. The diet is varied and balanced with a variety of home-grown vegetables, poultry, fruits, and even whole-grain rice (a non-paddy variety is used), produced right in Jonestown (the community was named in honor of its founder by the Guyanese government). Nutrition levels are high, as witnessed by a visiting head of a Guyana dental school. He examined 87 children and found a total of two cavities!

The 65-member medical team has assisted in several childbirths, and has helped upgrade community health levels in surrounding areas. Up to three hundred local people come from as far away as fifty miles by canoe to get treatment at the Jonestown clinic, and the young project physician, Dr. Laurence Schacht, along with nurse practitioners, RN's, therapists, and paramedics, has been responsible for saving many lives. Dr. Schacht, who is now training a team of young "barefoot doctors" has done astounding work in prevention of parasite-caused diseases (notorious in the tropics), and has done amateur radio consultations with scores of physicians in many countries. He has been called a "modern-day Dr. Schweitzer." Under his supervision, a remarkably thorough system of preventative care has been set up, including breast exams, blood-pressure checks, weight-watching, and periodic complete physicals for the entire community.

Classes of all kinds are offered to the community at all hours. A campaign is even underway to wipe out illiteracy among the elderly, some of whom had virtually no formal education. The driving force behind it is a former college teacher and senior citizen, Edith Roller. Community education (and entertainment) is enhanced by a 10,000 volume library, and a large-screen television system with over a thousand hours of video-taped programs. Spirited "town forum" meetings form the cornerstone of an elaborate structure of participatory government, with central steering committees, various departmental meetings, and the like, where all can have a voice, from the oldtimers down to the children.

Jonestown is a community where things get done. Often, people find themselves marveling at the staggering amount of development that has been accomplished in a place that, not long ago, was an almost impenetrable jungle.

Sitting around the table in the community's agricultural office for a farm analyst's meeting are some of the people who are responsible for it all: field crop supervisor Jan Wilsey, a young Pomo Indian woman from Northern California; expert tractor operator Phil Blakey, who grew up in Northumberland (England); a former attorney from California who manages the 5000-tree citrus project; the project agronomist, Russel Moton, an ex-wino from the Philadelphia ghetto who the church sponsored through school; Dorothy Buckley, a teenager who grew up in the racism and poverty of rural Mississippi (where she watched a friend starve); Jack Barron, a 57-year old chemical engineer from a prominent family in Delaware. This sort of diversity of backgrounds characterizes Jonestown.

If there is any group approaching homogeneity, it is the 250 senior citizens. Mostly black, many started out in the rural South, but found themselves at the end of the line in the inner-city slums of Chicago, Los Angeles, and Houston. Today, in a place where gentle, persistent trade winds temper the tropical sunshine, they have found peace, and a new lease on life. Besides, they are able to be useful and to participate in every area of community activity, and enjoy the respect that elderly people deserve.

Evonne Golden mentioned to me today that upcoming there will be a National Convention of the Black Teachers Caucus and she wanted us to purchase a table for that affair. Angela Davis and Harry Edwards will be the key note speakers. This thing is coming up in April.

I have attached a list of some other events that are coming up some may have already passed by the time you read this, however, we have not decided one way or the other we thought if it were worthwhile it would be cleared from your end. We really have not been involved in a lot of dinners, testimonials and that kind of PR. Most of our involvements have been with the Council of Churches, World Peace Council, Evonne, AIM, Enola and other small progressive organizations that have been supportive of P. T.

I met with Dellums on two occasions. The first encounter I mentioned to him the Tim Stoen situation and he claimed he was unaware. If in fact an aid of his had drafted a letter for his signature in this case he felt that his staff person was fully aware and competent to make a timely decision in the matter. He mentioned that he had 18 aides and that he did not keep up fully on the materials that came through his office in Washington. He finally stated that if I could come up with the name of this particular aide who had written in support of Tim Stoen, he would personally look into the situation. The next night there was a reception for Dellums at this Berkeley office. I presented the name of the aide to him at that time.

Dellums gave me a song and dance about being a public ^{servant} service and that as a public servant his responsibility was to investigate claims from U.S. citizens of children being taken out of this country away from the legal parent. (although he lead me to believe the previous day that he was unaware of the Tim Stoen situation, the very next evening when I showed him the name of the Aide, Dellums leveled about the case).

I explained to Dellums that in reality the child belonged to Rev. Jones, it was at that point that Dellums stopped and listened. In a very soft spoken way he stated, "I will look into this situation, there could be a possibility that my office has been used". "If my office has been used then I will investigate the matter."

EXECUTIVE OR ADMINISTRATIVE FUNCTION:

"THE TRIUMVIRATE" or CHIEF ADMINISTRATIVE OFFICERS

A. Duties of Chief Administrative Officers (C.A.O.'s)

1. GENERAL STATEMENT -- Under the direction of the Executive Director, to administer the entire project, that is, to effectively carry out or effectuate the policies and plans originated in Peoples Forum & Rally, Steering Committee and by the Executive Director.
2. SPECIFIC AREAS OF RESPONSIBILITY -- not inclusive:
 - a. Allocation and supervision of all personnel.
 - b. Supervision of all legal, accounting and insurance functions.
 - c. Supervision of all means of production and distribution (income producing projects including the farm).
 - d. Supervision of all construction, maintenance, decoration and landscaping projects.
 - e. Supervision of all support services including educational, community services, child care, medical, housekeeping, library, recreational, secretarial, clerical and guest reception.
 - f. Supervision of all transportation, shops and repair facilities.
 - g. Supervision of purchasing, inventories, storage and of distribution of all commodities.

B. Organization of C. A. O.'s

The C. A. O.'s or Triumvirate function through ASSISTANT CHIEF ADMINISTRATIVE OFFICERS (A. C. A. O.'s), Advisory Boards, Peoples Forum and such direct contact through personal or staff contact as is necessary to effectively administer their duties. The ACAO's in turn supervise all department heads, and report directly to the Triumvirate.

JUDICIAL FUNCTION OF:

"PEOPLES FORUM & RALLY"

A. Duties of the Judicial Function

1. The Assembly of the whole community which functions as a super-legislative body and legislative assembly and reporting assembly which informs all members of the community of its condition, progress and development.
2. Functions as a JUDICIAL body to evaluate and reward behavior through positive reinforcement.

B. Organization of People's Forum & Rally

Chaired by the Executive Director

JONESTOWN GOVERNMENTAL RESPONSIBILITY

PEOPLES FORUM & RALLY is the primary governing body including all citizens, practicing a total participatory democracy, even of school-age children...

LEGISLATIVE FUNCTION:

"STEERING COMMITTEE"

A. Duties of Steering

1. GENERAL STATEMENT -- To deal with all planning and policy matters subject to review by the Executive Director and Peoples Forum. This generally means making decisions of what we wish our community "to be."
2. SPECIFIC AREAS OF RESPONSIBILITY -- These include:
 - a. All zoning, building and construction plans and priorities.
 - b. Building, decoration, landscaping and recreational center plans, the work on these to be carried out under the ACAO's and the administration of the Triumvirate.
 - c. Basic design of utility and transport road systems, through the planning stage: the work on these to be carried out under the ACAO's and the administration of the Triumvirate.
 - d. Acquisition, development or termination of basic industries (but not their operation).
 - e. Policies with respect to: holidays, labor incentives, recreational activities and facilities, educational facilities, continuing education, advanced education for the youth, and cultural programs and facilities.
 - f. Rules of behavior and penalties for their violation. Policies directed at motivation for compliance and positive reinforcement.
 - g. Establishing general policy with respect to project priorities.

B. Organization of Steering

Steering includes all department heads, attorneys and accountants, C. A. O.'s, A. C. A. O.'s, and Assistants, and those designated by the Executive Director. It functions on detailed plans through sub-committees, established as needed, which sub-committees are responsible to Steering. Examples are the Jonestown Planning Committee and the Mechanical Priorities Committee.

C. Liaison with C. A. O.'s (Triumvirate)

At least one C. A. O. shall attend Steering charged with the specific duties of liaison and coordination, information and advice concerning feasibility and timing of projects, and reporting on problems and progress of the various community projects and activities.

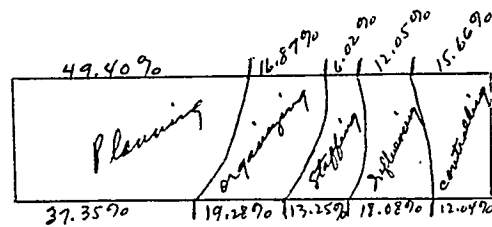

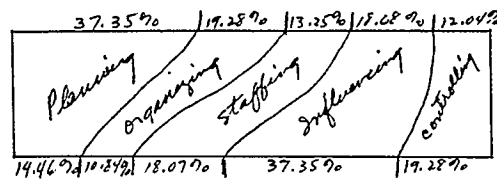

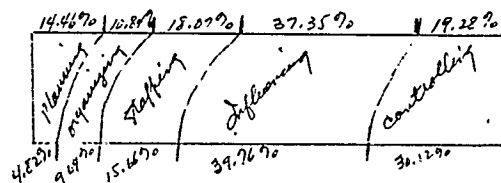
PLANNING OF ADMINISTRATIVE TIME BLOCKS...

Meeting of TROIKA WITH ACAC'S

From all departments will need:

- 1) JOB DESCRIPTIONS on each person within department, or if one person not presently on job and it is being done by whomever can get to it, then describe the function and say "personnel needed."
- Recommend procedures needed to complete the jobs. (See Harold and Tot.)
- 2) Give departmental outline or schematic and chain of command.
- 3) List your short term and long range planning with a deadline of _____ on when this should be in -- probably within 2 or 3 days. We will soon be going into major production on farm with the seasonal change, and into major construction as soon as lumber arrives..

It is necessary for Troika to see that you ARE COMPLETING YOUR TASKS, so these reports are necessary.

- 4) We will need inventories immediately: Feeds, foods, fuel, spare parts, and supplies in every department are important for us to know about -- we need to know what may become an emergency before it gets there.. Harold explained perpetual inventory, monthly summaries and daily usage records we will be keeping, physical inventory every 3-6 months and there will be auditors to check on this. There is need to set up record system monthly or as needed to keep above "safe" minimum.
- 5) List your procedures and go over them with the CAO's before setting changes in motion from what you originally set up in items 1, 2 and 3 above. If there are any changes or personnel shifts within the departments, please let the CAO's know immediately.
- 6) A system of followup needs to be formulated; there is a need for the CAO's to be able to evaluate the projected tasks you set up vs what you completed of those tasks, each. Will try to do much of this in these meetings.

MEETING: Will meet on Mondays 6:30 to 8 PM, and Steering will be at 8:30.

JOB POOL--Some changes are being made now, however all input will be taken then final decision will rest with the CAO's. ASSISTANTS TO THE ACAC's is not necessarily a full time job.

Factors to consider in the Jtn-Gtn business and financial problems.

Jonestown --primary view

- 1) Coordination: Administration is presently very deficient and is not coordinated... slightly, perhaps.. but not on any efficient basis. How do I know? because the records they should be asking for are not being asked for! Therefore, without that information they are only administering half-assed but undoubtedly with all good intentions.

To correct this --need to set up a simple log chart and see that the input comes in...#1

--PLAN the organization time required to handle the evaluation of the input you receive...#2

--Coordinate the followup from Rally, steering, ACAO's and Analysts, and see that you get reports indicating that the followup is completed. #3

--Organizing the personal time into a block-type of schedule is a must or there will never be sufficient time allocated for administration...#4

#4 is perhaps the key to the entire problem...

RR time is separate from administrative entirely!

When we refer to block-time, this means allocation of areas of work per the number of hours needed daily: see the material I completed for you on administration --note the chart on last page or thereabouts with the % of time needed for organization.. THIS MUST BE ALLOWED FOR -- and used that way. This will not be done unless you keep a personal schedule and take 15 minutes at the end of each day to plan your next day... You can tentatively plan the week ahead with appropriate time blocks.. but this will change daily: you need a score sheet yourself on how much time this week, for instance you had given to organization...

Determine how much sleep and personal time, including laundry and bathing and eating --plus "some" free time... then allocate the rest of your time into the blocks..You spend time with the baby also, and this needs to be counted for... It is possible to get a phenomenal amount done in small amounts of time if they are organized and planned appropriately.

Georgetown primary view

I feel very sick when I look at what is coming down in this arena...

- 1) Coordination -- requires an independent initiator who is willing to work within an agreed-to plan... This pre-supposes that a plan has been laid out. In our instance, I do not feel that a Gtn plan, per se, exists.. but rather -- a supposition of what should be done and changes kaleidoscopically with every new coordinator that goes in, however well intentioned. I think a plan must be devised for Gtn..and the people planned into that structure.
- 2) The functions in town must be divided, but still coordinated: I would separate into: BUSINESS EFFORTS (boat, etc.), FAMILY SERVICES AND JONESTOWN SHOPPERS, and PUBLIC RELATIONS & POLITICAL STAFF. Understandably these will at times overlap -- but over all of this should be a general coordinator with the authority to do just that. Primary persons in each department should be stable and rotate within time cycles. The workers can be switched as needed, if the primary persons are functioning.

A careful evaluation of the pro's and con's must be given... of course, but I would like to see us consider very seriously either purchase or leasing of a very large warehouse on the waterfront.. I would handle the P. R. out of the house, and everything else out of the business structure.

We are operating a multi-million dollar operation out of our hip pocket and it is costing us a fortune in errors and miscalculations. It would be cheaper to set up a structure from which to operate --as it appears to me, perhaps others can see this differently and am certainly not fixed in my opinion --is just how it looks from this point in time.

One person should remain in the office on the phone, and another to maintain and supervise the warehouse. If a group of 3 or 4 for each position were trained in there together and set it up so that one in each post could function and operate, then we could rotate them... the "work crews" could be varied as the need changed.. Distribution of our merchandise could be handled out of Gtn.. and the warehouse would suffice for both "holding" items from customs, merchandise for distribution, perhaps eventually our PRINTING AND BUSINESS SERVICES (TYPEWRITER REPAIR, ETC, & RENTAL BUSINESS), and any others that we might envision.. along with a snack shop for the business people in the area for coffee and sandwiches and sodas.. The meetings with general coordinator could alternate between the business location resident and the house residents.. I would lodge a few strong ones at each place.. then have the general coordinator meet with each group of them, alternately.

I think that the general coordinator or the TOWN ADMINISTRATOR will have to fall within the same TIME BLOCK LIMITS as I have mentioned for out here -- with sufficient time allocated to planning and organizing and CONTROLLING.. or it will never happen that we shall have our town organization structured. Without that structure, we will not make the money our potential allows...

3) Greatest weakness (in my opinion) which must not be overlooked:

Primary would be the sharpshooters: We have a group of people that consistently shoot down structures that we get going and initiate. Instead of finding the problems and mending our fences, we seem to prefer to rip out existing fences and build new ones too frequently. In business this is known to be extremely costly. Perhaps it would be wiser to include the sharpshooters in the planning stage so they have a personal investment in the structure.. Right now, I see them gathering.. Certainly it looks like Richard is messing up. His problem seems to be personal if he took 5 hours talking about it.. that usually means sexual...

Subject: Departmental Inventories

Basic Plan:

In order to maintain a system of controls on all inventories that will assure adequate stocks at all times I suggest the following be required of each department maintaining inventories:

- 1) Perpetual inventory records, approved by the C.A.O., be maintained in each department and remain available for inspection by the C.A.O. or an appointed representative, on demand.
- 2) Monthly summary usage and receipts reports be generated from the department's inventory records and be given to the C.A.O. no later than the 5th day of the month following.
- 3) Physical inventories be taken by each department each 3 months and a copy be given to the C.A.O.
- 4) Spot audits be taken in all departments every 3 to 6 months, or as deemed necessary, by an auditor selected by the C.A.O. If serious differences or errors are detected then a more complete audit may be ordered.

Minimum/Maximum Levels and Re-order Points:

The C.A.O. should sit down with each department head and set proper inventory levels (maximum and minimum) and re-order points, keeping in mind the regular reserves required and the anticipated time lag in receiving re-orders. A safeguard system will be required to assure that "critical" items to the departments or project's function will not be allowed to drop below predetermined "safe" re-order points. This system to be approved by the C.A.O.

Maintenance and Reviews:

Once the inventory system is set up and functioning periodic reviews of the system would be in order to pick up any areas requiring change or improvement. This period should be established based on the size, value (or cost) and degree of importance to operational functioning and efficiency of the particular inventory and department. Also, whenever inventory differences are not adequately explained or corrected then a review be set up with the department head and corrective measures be established or appropriate disciplinary action be instituted.

C.A.O. - BASIC OBLIGATIONS

The function is administrative in nature. That means, getting things done, and, by implication, having the organization and information to get things done. It means the day to day supervision of the entire project. Included are such items as purchasing, inventory, accounting, personnel deployment, as well as the normal departmental operations.

It might be easier to examine what it does not include: first, the formation of policy. Under the Office, this is a function of Steering, and somewhat of Rally. In order to avoid conflicts in operations it would be good to find a dividing line in steering tonight. All administrative measures such as construction or other maintenance operations are not steering issues. Job changes are not steering issues. Basic planning functions are steering as is the obligation to create rules of deportment (which may also be created in Rally). Therefore all of the subcommittees of steering that relate to planning as distinct from administration will still be in effect, and their total output would be coordinated through steering. This should cut their agenda way down, and give sufficient time to thoroughly explore issues of importance.

Another function that is not of C.A.O. is judicial: The Office, Rally, Counseling and Public Service. Public Service would be under the C.A.O. with respect to the work that it does but not with respect to who is on unless we wish to give the C.A.O. and Assistant C.A.O.s the power to put people directly on for some limited period of time. (Anyway that point is unclear in my mind at this time.)

The way I visualize it C.A.O. would have a working area and a staff. They would supervise purchasing, inventories, accounts, personnel deployment (I don't think I have all "central" functions in mind now), etc. All functions not centrally administered would be delegated to one of the C.A.O.s in their area of concern. So, as to the Departments, the job is supervisory but as to the "central" functions it is direct administration. For example, the radio people and the purchasing agents are directly on the staff of the C.A.O. and not supervised, for instance, by housekeeping.

One last point is that your "sway" includes Georgetown Operations and thus I think that you need to set up one person in charge there, and also some structure or operating formula, in writing, so that everyone can be held responsible for his job.

There are lots of "models" of administration type organizations. I do not hold any preferences, except that you must have a very efficient person to maintain followup and tickler systems, and must maintain a very tight system of internal control so that you can pick up on your own ~~and~~ omissions. Also, there may well be some routine appearing matters that would not appear to require any sort of interdepartmental coordination, but which in fact do. For instance Jan just raised the issue of a faucet near Apt. 2 which the nursery wants out but which Simpson uses for watering the garden. Charlie would somehow have to know to coordinate with Jack or Jim. The "somehow" needs to be worked out. Also, there are some "cross-departmental" areas that need to be worked out such as the poison control which has both agricultural and housekeeping applications.

I am sure that a lot more stuff will unravel as time goes on, but I hope that this will help. If you want more please let me know.
