Last in 1969 in October Jim Jones called me out and told me of my mom, Pearlona Forney Thomas and my two dogs, Bessy and Sammy. He then said, "Alfred and Alfred. You have twins?" I said, "Yes." He told me that my sister had died of cancer of the uterus. He told me to go to the bathroom and pass a cancerous growth from my uterus. I went to the bathroom and sat down. One of the nurses put some paper towels from the rack in the bathroom under my vagina. I felt this thing moving down from my uterus which felt like I was having a bowel movement. This thing was very black with a bloody mass at the end of it. It smelled terrible. I had just left the hospital a few weeks before. Dr. Calderwood, then the Chief of Staff at Kaiser Hospital in San Francisco, told me when I returned that he never expected to see me again.

Another time Jim Jones called my brother's name although he wasn't there. Later Jones said to tell my brother to be in the next meeting. My brother did not go. Shortly after this my brother was attacked and caused him to sprain his ankle. On his way home he had groceries in his arms. He fell in Union Square Park. People came and took his groceries and left him there.

I felt very ill and was vomiting and bleeding from my throat, but recovered within minutes.

I was also struck in the back by a <sup>MOORING</sup> shetled mooring line in Georgetown in the presence of dozens of witnesses, one of whom Compton Consoles, who is not a member of People's Temple, said he couldn't understand why I wasn't hurt. Another man, Anthony Simon, says that I looked lifeless until the name Jim Jones was mentioned, whereupon I recovered.

While syphoning gas to refill the tank I got about a cup of gasoline up my nose and in my eyes. I <sup>received</sup> chemical burns which blinded me. I had a message sent to Pastor Jones. His reply was, "Do not worry, it will be <sup>all right</sup>." Almost immediately the intense pain stopped, vision returned and within a few hours all traces of the burns were gone.

In 1972 I met Pastor Jones and I had, had a severe pain in the lower part of my back on the right side where two other doctors had told me I had two kidneys but pastor Jones called me out and I passed a cancer through the rectum. I saw this cancer with my eyes. I haven't had pain again.

I had a heart attack also in 1971 in June, I could not do any thing for myself, I just had to have complete bed rest for about six or eight weeks, then when I went back to church pastor Jones saved me from having a fatal heart attack. He has saved me from having several heart attacks. Pastor Jones has saved me from having a stroke that would have left me a vegetable because I was losing all use of my self.

In 1976 I had spinal meningitis and didn't know when I got to the hospital, who had taken me there or how long I had been there but the nurses and doctors told me that I was lucky to be alive. When I got to the hospital the nurses said that I had a fever of 103° and it was still rising, but they would not tell me how high my fever did rise. The doctors or nurses didn't see how I was able to think straight, because they said that I had blood on my brain, but pastor Jones although he was in Los Angeles and I was in San Francisco he said from the pulpit there that I would be alright and I was. After the meningitis attack I lost my hearing and the doctor said that I would never hear too, all that he could do was give me a hearing aid, but after pastor Jones put his hands over my ears two or three times I can hear normal again.

In April of 1976 I had another severe heart that kept me in intensive care for 72 hrs. During that time my heart felt as though it would jump out of my chest or turn over. The doctor when he saw the trouble he put a monitor on me and it was a show to every one that entered the intensive care room doctors, nurses, and visitors because the monitor was going crazy and ~~my~~ most people thought I was not going to live, but pastor Jones sent one of his men singers and for the first time I slept for the first time in 3 or 4 days and nights. I was discharged from the hospital the next two days and have been going every since today I feel fine.

I didn't even talk about Jones said, Everyone who has pain raises your hands to me, I did this and at that second my (terrible) headache went away.

NOTES TO TELL NELSON:

Affidavits sent to the President of the US with explanations on all the charges and to show him what we are up against. They talk about orchestrating a tax thing against us. Even to embarrass him. Any ideas he has on that, forstalling that we wouldn't mind at all being disciplined, or reprimanded for things we did, but this is erie smear campaign, reminiscent of the McCarthy era or worse.

Get Phillip on the radio and let him ask certain ques, relay it to him, to get it doo him. Don't know how enthusiastic they are, can't know that they will but get on the radio and interview the press, or pick out some that we thing would give a reasonable interview. Some would feel slighted so they would just knock us out of vindictiveness if we did that. For instance I would say when I handled the CA's at no time did I -- anyone I was attempting to heal where I felt succeeded I would always send them to a doctor, always. Anyone I dealt with with terminal CA, I would tell them to be absolutely sure they followed exactly their doctors specifications. We have had reports of all kinds of wonderful remissions & you can take a voice print and certainly test that I know I can heal. I know I have a certain paranormal aspect, but that was always far, far secondary to anything else, it isn't important. We don't see ourselves as a panacea.

Each of these charges I could handle in a way that would not compromise him. I wouldn't say the end justifies the means. I would think that I would have to talk about a woman in general that the reason I am down here is because of the baby. And how that baby came to be. The woman was suicidal and her husband thought she was going to cause difficulties to the cause on top of it, go out and do treachery. He asked me to do what I could and he thot sex would help her and I did. And she had a baby. One of the reports said that she said she never was a believer, Obviously this is odd. Say everything in a general way without hitting her publicly, first. I could approach them that way. Allude to it, but say that I will be going public the next time.

If JJ surfaced in an interview it might waylay, show humility, say I am not even sure of the overall workability of egalitarian philosophies, but I know it is not right for 2 out of 3 babies to go to bed hungry and the reason that we got many of our people out was that we knew that they would go back to their former patterns of violence & suggested it. We wanted them to be a part of a solution where they would make a good image for the United States as well as help in a country that is trying to build a non-aligned society. That would be one reason. We will have news people down here. When the road is prepared and there is more adequate guest housing. Our people are very happy and very well housed and very well taken care of. We have our own ware house where they get food, the best of clothes that they need, the best medical care that they can have on earth. What other place can the doctor see everyone each week. The best of educational material. not to mention being out with nature, good clean air, mineral water, and an atmosphere free from racism which is so important to people. That is roughly a little bit of the idea.

A summation of the worst parts of the affidavits needs to be ready for the interview so he can go down the list. We didn't want to get into personalities to hurt them, and we didn't want to even explain one of the reasons why I am here for the time being, until this thing is worked out. I will not allow a child to go to a person who beats their head against a wall, and threatened to kill herself and the child, threatened to kill her husband, all the other things she did. Rather than hurt, or embarrass her or other members of her family. Her family are all racist bigots and I don't want to expose my child to that.

Again- I wish to communicate with you- but time is limited as to whether it is done effectively or not. So many things to say- and so limited as to creative ways of doing it.

I am sorry for your pain. Sorry I ever give you any- and sorry I can do nothing about helping relieve. I am very sorry that I mentioned anything about that woman I spoke about wanting sterilization. I usually think things out that I tell you a little better- but that was a new thought- and seemed so logical- and I did not think all the way thru the motives etc. and how it might affect you.

I knew it would be painful- but somehow I did not want to do something that was against the scheme of things. And I think too that woman may have wanted to hear something like- "no- things will be different in the future"- or maybe she wanted to hear how much he would have liked her to bear his child- even if she never would. For you know how she loves children- and how she would have felt giving birth to his life. I'm sure some of that "romantical" nonsense was working in her mind too. Anyway- I am sorry that I ever mentioned it- and I will tell that woman to do nothing in haste.

I feel a sense of loss about this life - not so much personal pain- but more of loss. As I think back- I remember times of your pain- inescapable times. Times when my own pain was so minimal. I remember so well when you told me of G- and what the coming event was. How the pain first made me think of leaving- had it been any other person- I would have. But it was so very clear- that your own pain was so much worse than my own. The full extent of your love then was so obvious.

And obvious too is your constant suffering. It is suffocating to deal with- since my own inability to help you is also very obvious. There is tragedy about these lives. and I suppose in the same sense- grandeur of sorts- but the pain obscures the glory.

And duty obscures the pain. So much for that...

I knew these last 2 times- that what was planned on would not take place. Because- it had again moved from becoming an added 'attraction' to a desperate need. I know that when I do not have needs under control- the "gift" of the situation is denied. I truly believe that much of what goes on like that- is influenced by what is going on in the head. A Socialist can not have desperate needs- it is that simple.

I get so repressed in my feelings around the person that I love- that sometimes I think I am too repressed to do the love-making up right. If there were time- and the opportunity- I would like to take my lover and do so many tasty and lustful things- my lover makes me feel very lustful- and aggressive. Now there is a good activity too often denied. But I relish in so many beautiful memories.

The times are busy- and that is good. Pressures keep the mind from getting lost in the frustration of it all. the end seems far, far away. But yet- so very near. I have enough to get thru this life time- and so grateful for a purpose. All else seems superficial.

I wish there were words to tell you all that is in my heart... I wish there was a way to ease your pain. But there is no way to go- but thru... I give my very best to you... in deepest faith- Teko

sorry it has been so long since I have even written a note. I am not one to write many letters.. but I do think of you often, and miss our occasional talks. It was good to hear your voice the other day on the radio. I didn't feel free to talk as there were a number of people in the room and I didn't want them to think that I take advantage of being in the radio room to receive personal traffic- so I didn't respond much- but I was glad to hear from you.

things seem so busy around here- but yet I really couldn't tell you just what I do here.. now that Lola is in the apt. with me- alot of what I do is listen to her. She does alot of talking. we get along pretty well- I am solicious of her and she seems to appreciate it. things are ok. in that dept. She doesn't seem to be in a big hurry to get out of here- tho I do believe that she wants to go. She wants to be sure that she has everything that she will need there- and is shopping in shifts- and plans on sending some things over before she goes- so Alice- or rather MJ can keep them for her. She wants to get well stocked up I guess.

which is ok. because I really have my doubts as to what is going to happen when she goes. For one thing, neither bitch vera or wishy-washy Maxine will take up Lola's mantel. They just push things off on her- even after she tries to get them involved and point out how things should be handled etc. they just don't assume the responsibility.

when she goes= the projects will no longer be bringing in the money they do when she is here.. and also the 'message' intake will be greatly cut- because they won't do that. As it is, I have to rely on Jenny to get things for me to send over- supplies etc. and Claire sometimes. but I don't even like to do that.. but I have no choice.

You know, I like Mildred very much, and I Don't really want to have to say much to her about her attitude and tone on the radio. I did write a little note last time. But sometimes she is downright nasty- and it is very alienating not just me- but everyone in the radio room. You know, if mild mannered Martha gets put out by it- something needs to be said. I know she is caught in the cross fire and it is alot of pressure. But if she could just remember what it is like here.. it seems as if anybody could- she would since she was in this position herself. Even Tom says that she is doing herself what she always cussed people out for doing to her. I wouldn't say anything if it didn't come across bad here. She has been some what better the last couple of days- so maybe the note I added last time helped. But if not- then I would suggest that other people relieve her on the radio from time to time ff she feels under too much pressure.

I could almost accept that easier- you know- if you got some sort of release- and not just pain.

it hurts to hear you say that you know so much has gone down that even if you meant what you said- nobody would believe you anyway. i feel that comes to me- and i don't know how i can convince you that i do believe you and the things i hear will not make a difference.

there have been too many things between us; too many years; too many talks; too much sharing of small things/ too many complete moments of love-making. Too many painful situations that have been worked thru.

It is like the same questions keep coming up and have to be dealt with until a decision is made and then the question is dropped. For instance- my suicidal feelings- i have dealt with them for so long- and have decided it would be "anti-" to do it- (and i had promised you i never would and i understand the reasons against it)

But when i was so depressed in sept.- i again thought of it- closer to home than the usual casual thought of death. but i never seriously considered doing it- even tho i was pre-occupied with not wanting to live.- it was almost as if the "answer" were settled but i masochistically suffered with the "question". and i can't deny that i 'like' to be depressed in a certain way- (i know my masochistic tendencies in some areas.)

Just as at times- i 'want' you to know my suffering (as a subtle attempt at manipulation) but then at the same time- i do not want you to know because of the pain it causes you. in some ways i have over-come the desire to manipulate you- in other ways- i have not.

back to Redwood Valley. Faith Kice rode with us. The road  
was wet and as we neared San Rafael on 101, a car  
was coming onto the freeway from a ramp into our lane -  
the right lane. There was another car in the lane next  
to us on the left. We were joking and listening to  
the radio and I saw the car coming into our lane.  
I said "Patricia, watch out for that car!" She put on  
the power brakes, skidded and swerved into the car  
next to us on the left which pushed us over into  
the middle barrier, then after hitting this the car  
went into the middle lane and was spinning rapidly.  
There were cars on the freeway behind us traveling  
at high speeds around 60-70 MPH, which should have  
been hitting us. As we were spinning it was as if  
the cars were further behind us yet coming towards

I have always considered it a miracle that I left Texas, traveled to California and heard Jim Jones speak my third day in that new state. I had done five years in the drug scene and after 150 trips on psychedelic drugs and two years shooting speed I was wasted. Hopeless and without ambition I was received by Jim Jones and ~~the~~ People's Temple as a friend and am grateful for the hard work I did and the structure that was provided for me my first few weeks in the temple. That initiation permitted my mind to heal ~~my~~ and I soon started school. Living in the equalitarian college dormitories in Santa Rosa I studied hard and made Straight A's, received an AA degree and did a year of premedical study at UC Berkeley. I wanted to be a doctor but knowing how hard it would be to get accepted in the states and having heard Jim say that "two of our students have been accepted into medical school in Mexico" I went there and he was right; I was accepted just as he prophesied. I went to Mexico to study and learned a foreign language to do so. I made straight A's and scored high on the national Boards. My success, being so far away and alone, was entirely due to the profound inspiration I received from the life and sacrifice of Jim Jones. The People's Temple sent me hundreds of letters while I was there and I knew who my comrades were. One time soon after enrolling in Mexico's medical school I was flying back to San Francisco and as the plane touched down there was a surprising jolt. Then there was calm and the landing was completed. Later at the Temple that night during service, <sup>JIM'S</sup> Father's messages, which he called in from the vacation bus trip to the eastern United States, stated that he knew the flight number and the time the plane touched down and that he had saved our lives. I say our lives because at that time there were two of us in school. Jim had spoken earlier that only one of us would make it through and it was but six months later that this prophecy came to pass, the other student deserted and I was left to do my job alone. During the second year in Mexico Jim landed a plane, which he chartered to the mission project in Guyana, at a city in eastern Mexico to pick me up. There had been a misunderstanding and the airport authorities would not let me board. Because he had concern that I would not be able to return to Mexico to study if I did not obey the authorities I flew separately to Guyana. Jim asked me if I had enough money for food and room during the trip and after I said yes he handed me 300.00 dollars. The ticket to Guyana cost 299.99. How miraculously well he anticipates our needs and how much consideration he showed to land an entire airplane, on foreign soil, for one of his members. I recall once in Mexico I became ill and had shaking chills. I was under four blankets, had a heater aimed at myself but still had chills. I thought of his name and the chills ceased suddenly and I was calm and slept until I felt well.

He stated "for all the vain reasons for man to destroy . . . . over a little place known as Hanoi. He told us that Dean Rusk would be the Secretary of state and would be very much involved in this. At that time, Dean Rusk was not known in the political arena and no one even knew what or where Hanoi was. Years later, however, the U.S. did become very much embroiled in the Vietnam war, and Dean Rusk had become the Secretary of State.

In early September of 1976, I was in a car with 7 other youths. It was late at night and ~~we~~ we were driving north on East Road in Redwood Valley. We were hit head on by a drunken driver. Some in the car suffered ~~serious~~ head

wounds from the broken glass. The front half of one girl's scalp could be lifted up. Another's head went through the windshield and back then out the side window. She appeared to have a broken neck, and she had no apparent vital signs. The driver's arm broke the steering wheel and she thought her arm was broken. Mike Cartmell jumped from the car and ran 1 mile to Pastor Jones' house to tell him about the collision. Jim told him there in the yard that everyone would be alright and there would be no broken bones, and no after-effects. Jim also told us this at the scene of the accident. At Weick General Hospital, the x-rays were taken of everyone involved and not one broken bone was found. The doctors said that Cathy Stahl would have brain damage and severe eye damage. Explosive tape testing was done and she suffered neither. The hospital staff was truly amazed at this. The wreckers who towed our car away told us the glass slivers had to be flying as fast as bullets to become embedded so deep in the cushions of the rear seat, and that it was a miracle that the people in the car were not killed.

It isn't unusual for Jim Jones, to drop in to our little hospital to speak to each person there, and to stop by and talk to the doctor about someone's health problem. We all feel the security of meaning something here, and of being cared for, like never before. I'm so glad to be back in the country again with gardens and growing things all around. I asked him what was wrong he was unable to tell me. I washed him up and asked her to get a doctor for him. She wouldn't call a doctor. She said, "if the doctor came he would report it. I cleaned him & bandaged him up to the best of my knowledge. Two days later she submitted him back to the hospital.

If Patients would urinate on themselves she would just let them soak in their urine. If they had special diets, she'd feed them, anything, such as chitterlings & pork chops, mostly what she liked.

These are some of the worst things she's done to her patients. I can go on & on about the cruelty of her <sup>Resthome</sup> Resthome in Ukiah.
