Jim Jones' church, Peoples Temple, is located, and I am very familiar with the outstanding work his organization has done in service to society. Rev. Jim Jones is one of the most principled voices for social justice in the nation, and he has been instrumental in providing forceful leadership in developing practical solutions to serious urban problems, such as crime, drug abuse, who neglect of the elderly. I am certain that you are aware of the character and integrity of this man, as are so many of us here in the United States who have come to know him.

Because he is an extremely effective leader in the arena of social progress, Jim Jones has (especially of late) been the object of some malicious attacks from various individuals who (out of personal vindictiveness, racism, and other despicable motives) have mounted a snear campaign. A great number of people are aware of the Peoples Temple Agricultural Mission and feel that it represents a useful and significant effort towards international co-operation.

Dear Mr. Dymally:

Again, thank you for being such a tremendous source of moral support and genuine help to us. There are no words to describe what it means to know you understand and appreciate what Jim is doing, what all of us are trying to do.

We have some very reliable information that pressure is being put on Tim Stoen; we are not sure just how, but we know it has to do with the child custody situation of John. Jim wanted you to know because he trusts you and fears that Tim, because he is in a very real sense "white", prestige conscious, and ambitious, may possibly have been persuaded to turn against us. He said he would never go against us and promised to always give help when we asked, but now his signals are somewhat changed and we are not really sure which way he will go. It is a terrible thing, the kind of pressure that can be brought to bear on a person — more than many or most could bear. Jim empathizes deeply with the kinds of pressures he is dealing with.

I think that Tim (in addition to many others, but in a large way Tim) has taken so very much from Jim. He has put Jim through a great deal, and I know for the sake of the entire church, Jim has always done whatever he could to help people in their development, not only as individuals but as individuals within a group with a much larger consciousness than just 'we four and no more'. The attempted frame-ups Jim has been through -- though he has always been exonerated -- the personal battles he has fought for each of us and the battles for the survival of our group. It makes me heartsick to think that someone he has loved so much could possibly have turned against him and all of us.

We are at a loss to reach Tim now, though he is in town. Several of us have seen him -- I, for one, saw and talked briefly to him on the street. But despite our pleas, he has remained aloof when we asked to meet to talk. We don't know how to ease into the situation at this point, nor where we stand with him. I just wanted to let you know, because this could have some far-reaching effects for us.

The project in Guyana remains a triumph and a beautiful new life for so many people. Dr. Reid, the Deputy Prime Minister, will be coming into the interior to visit with Jim and to see the development. This, of course,

Every day when we talk to "Jonestown" on the radio another group of officials is visiting, and all rave about the project. We are all looking forward to your visit with the greatest anticipation. Vera, Phyllis, CJ, and I went to someone's house for this fundraiser. Willie Brown and Sheriff Eugene Brown were the two best known people there. I met two people

Steve and Sonja Arnold originally from NYC and old friends of Mark Lane. He is a real estate agent. We talked to Sheriff Brown, Willie Brown, and Randy Stallings who is the head of the anti Death Penalty initiave. Stallings told us that in his speaking engagements throughout the Central Valley, he finds an overwheliming number people persuaded in favour of the death penalty because of the recent rape and ax mutilation of a 15 year old girl. He understood how the media had conspired against PT.

We four met him at his fundraiser held at the St Francisc ( 5.00 dollars each ) where he had just flow n in from Washin D.C. on a 8.45am flight after finally signing the Energy Bill at 7:15am yesterday. He listened to us talk about Mark Lane, the press coverage, and said he would look at the press clippings if we sent them to his office since he hadn't seen the Sun Reporter article or any other.

I talked to Stann Smith of the Building Trades Council, who told me that he had seen one of our people xegently a while back. I asked," Which one?" He said, "Tim Stoen." I asked, "was this while he was with us or when he turned against us?"

He said, "was there ever a difference?" I gather he meant that against Stoen had always intended to turn against us. I didn't have time for more talk with him. He was friendly if that means anything. We saw Harvey Milk who was the same Harvey-friendly, telling us the press woverage had to improve and the tide had to imptove sometime. We nodded to Sue Bierman at both functions today.

P.S. Willie Brown was concerned about a date for the proming dinner. I explained that as yet no specific date had been set, intentionally. I assume he had a letter drawn up ready to go but he needed a date before he could get things rolling.

Jean Brown indicated that J.J. wanted the community's response to the recent findings of Mark Lane and the Sun Reporter arks article. Some of the reports that I am getting, from those folks who have read the articles are, We are beginning to fight back vera

The first ten pages were run by the <u>Bee</u>; the other four pages were omitted by the <u>Bee</u>, apparently for space reasons, but contain points of a general nature on media coverage of Black elected officials. They are also attached, and so designated.

I think these are questions on which we need a continuing dialogue. I welcome any comments you may have, favorable or unfavorable.

# ew From Where I Sit'

By MERVYN M. DYMALLY California Lieutesant Governor

SINCE TAKING office as lieutenant governor of the State of California, I have been subjected to repeated scrutiny by some newspapers around the state, most notably the Los Angeles Times and, more recently, by The Sacramento Bee. It has long been my policy to maintain an open office, to facilitate to the fullest extent possible media access to myself and my activities. It has always been my conviction that the press has a responsibility to report fully and accurately on all aspects of government in order to inform the public of the doings of their elected and appointed representatives.

My conviction is no less firm, though I have come to question seriously how responsibly the press carries out its responsibility. Consequently, I find myself reassessing my policy of openness and access. In considering a change in that policy. I feel an obligation to set forth the reasons for the shift in my thinking.

SIMPLY STATED, I can only describe my experiences of the past two years with the printed media as a horror, as an unending nightmare. I find an image being projected of myself as a person and as an elected official that totally denies my sense of values, that misrepresents my intentions, that impugns my integrity, that mocks my commitments.

One can speculate endlessly as to the reasons for the treatment I have been accorded:

- It may be as blatant as the fact that I am black and the powers in a racist society are obliged to discredit—if not destroy—a high-level black official who has obtained—if not in reality, at least in appearance — the semblance of power. I would like to think noti

- Or it may be as subtle as the seemingly insignificant innuendes and implication; made by white reporters, out of ignorance and in-sensitivity that cumulatively reveal

their unconscious racism.

Or it may well be sloppy reporting and editing, and a tendency among some reporters, once they have decided on a story, to select only the facts that support their conclusions, and disregard the rest. I have seen definite evidence of this in some instances, in The Bee and in

other publications.

— Perhaps it is that the media
Capitol bureaus, while well meaning,
still are all white and thus unable to grasp the realities of black politics and black politicians.

- Or on the other hand, maybe it is that the imbalance in the news reported about me results from the This statement from Lt. Gov. fact that most newsmen are still uncomfortable reporting good news, or writing about some seemingly dull but good thing that an individual does. It is much more normal to dig up the sensational. That's what wins the pats on the back from editors, the media awards, etc. But is it accurate reporting of the total picture about a situation or individual?

- In fact, there are those who say that there is government as it actually exists in reality, and government as it is reported to us through the news media, and that the two are not necessarily the same — indeed, are not the same. I never realized just how true this is until this past two years of news coverage of myself, for I see myself portrayed in the media too often as an unscrupulous politician, and I know that this is just not an accurate picture of Mervyn Dymally.

I AM TIRED of it; I protest, and I have decided to tell my side of the story. The view from where I sit looks very different, indeed, and I thank The Bee editors for allowing me to present it.

I think all of the shortcomings of news coverage I went into above, are illustrated in recent articles about a Los Angeles pharmacist, John David Gardner, and his involvement with me. Let me explain. (The first-article appeared in The Bee.)

Anyone elected to public office quickly finds a large portion of his or her duties revolve around responding to constituent complaints, requests information and pleas for assistance.

A person who has been long established and actively involved in the community from which he or she is elected finds the demands multiplied by virtue of the network of relationships that have developed over the years, and the multitude of persons who feel that they have persons who feel that they have special access to their now-elected representative. A black official representing a low-income black community, who has campaigned on a platform promising solutions to problems that plague the daily life of the computity is deluged with an the community, is deluged with an incredible diversity and volume of requests for help:

I responded to these requests. Letters from me are in the files of

handreds of people who are in prisonor have had problems with school or welfare, or have run afoul of the state regulations or rules in some other way. Often the mother or a relative would come into my office and ask for a letter or a phone call or just "some belp." I never tried to judge these individuals, which was not my job. and I always did what I could - which was very much my job.

A TYPICAL CASE was the family that approached me in 1963 when I was a freshman assemblyman representing the ghetto of Los Angeles. A member of this family, a harmacist, was serving a prison term, having been convicted of illegally selling drugs, and was shortly to be eligible for parole. I agreed to go see him and, in that way, met John David Gardner for the first

If a constituent asks for help and is denied, that person is unlikely to ask a second time. If a constituent receives a response, he or she is likely to ask a second time. So it was that ever the years, John Gardner moved in and out of my political career in a very minor way — one of thousands of individuals. I wrote a letter in his behalf to the California Adult Authority before he was paroled, stressing his positive attributes in much the same socially accepted way that employers, almost without thought, write letters of recom-mendation for former employes. I also appeared, as did several other community leaders, before the State Board of Pharmacy in support of his license being restored at a public

My interpretation of the system of instice in this country, admittedly a literal one, is that once a person has served his time in prison, he has paid his "debt to society." There is no his "debt to society." There is no provision in the system of law for perpetual punishment. My understanding of the philosophy of "rehabilitation" of convicted offenders is that unless they become reintegrated in a meaningful way in society, it is nearly inevitable that they will again turn to crime and return to prison. Fundamental to such reintegration is economic security. reintegration is economic security.
Thus, I tried to help John Gardner,
and for a brief time — about two months, not two years as reported in The Bee, at a salary of \$200 a month - John Gardner worked as a part-time aide in my Los Angeles office in the mid-1860s. He performed some odd jobs at my office and became acquainted with my family. He worked for a time at a small filling station leased by my brother-in-law, pumping gas and occasionally doing minimal bookkeeping.

WHEN THE CONCEPT of prepaid health plans emerged, John Gardner, with some prominent medical doctors, pursued his pharmaceutical interests, and had a health consultant in Los Angeles develop a proposal for consideration by the State Health Department. I, too, saw potential in prepaid health plans as a possible way to provide health care at a reasonable cost to low-income communities.

I have consistently worked with black doctors in the interest of giving them a voice in the organized medical profession of this state. On more than one occasion, I supported or sponsored legislation in support of health care for my district. I often carried plans for proposals, some relating to health services, to Sacramento as I traveled between Los Angeles and the Capitol — including, I am told, a plan developed by Gardner and some doctors. (I do not specifically recall

Performing these duties for constituents is a routine part of a legislator's responsibilities. I have carried countless documents back and forth for constituents. I arranged meetings between State Health Department officials and organized black doctors' groups in hopes of assuring that contracts for prepaid health plans in black communities would be awarded to black professionals.

THE MOST concentrated period of negotiations for such plans occurred during the Reagan administration while I was a state senator. It should go without saying that as a black legislator from Watts, my influence in that administration was not exactly overwhelming. The Health Department fought awarding any contracts to black doctors; and while the department resisted, it approved contracts with four large white medical corporations, two of which moved into South-Central Los Angeles.

By the time a contract was awarded to a black group, most of the patients had been signed up by white plans, and failure for the black plan was guaranteed.

Gardner's plan was not approved, apparently because of his record. He consequently requested a certificate of rehabilitation in the Superior Court

in pursuit of a pardon. The Bee reported that a letter over my signature in support of a pardon appears in the file on this case. I do not recall writing the letter, but may very well have done so.

ON AUG. 12, 1976, I spent an hour and a half with two reporters from The Sacramento Bee. The thrust of the interview was an ill-disguised attempt to link me in a negative way with John Gardner and the allegations against Omni-Rx, a health care company in Los Angeles. Evidently, though I knew it only from The Bee article, Gardner's pharmacy had filled Omni-Rx prescriptions. The primary issue for the reporters seemed to be that people connected with John Gardner had purchased tickets to a fund-raising dinner held in my behalf during my campaign for resoluctions as state senator in 1972

my behair during my campaign for re-election as state senator in 1972.

On Friday, Sept. 10, 1976, an article appeared in The Sacramento Bee entitled "Campaign Fund Donations? Dymaily is Linked to Controversia! Pharmacist." At the time of the interview, a number of staff members in my office speculated that no story would be printed; that the integrity of The Bee management and ownership would preclude the release of such a charade. What was not taken into consideration was the need to print something in order to justify the hours of research that had led nowhere. The story that appeared was a nonstory. It was a stringing together of unrelated bits of information and innuendos, well sprinkled with my candid quotes, refutations and explanations.

reiutations and explanations.

The story, for example, said that "Dymally and Gardner were frequently seen meeting together at the Shanty, a downtown Los Angeles cocktail lounge." Anyone who knows me at all knows that my life-style is not characterized by frequenting bars or cocktail lounges. I still don't know where the Shanty is—or if there even is such a place. Furthermore, I have had no contact with Gardner ever sinced became lieutenant governor—and prior to that had contact largely when he informally dropped by the office.

The story said, "Other . . . sources . . . say that Gardner was connected with a number of enterprises operated by the Dymally family." Any check of the facts will show that there are no Dymally enterprises. I have no business interests. My sister owns a struggling beauty school in Los Angeles (and, incidentally, has studiously avoided accepting any federal funds that most other schools receive for fear that the media would use that as the basis for another negative story about me). My brother-in-law previously leased a service station and no longer has even that. Those are the "enterprises" of the Dymally family.

The health consultant who prepared Gardner's proposal for a health plan was quoted as saying that Gardner referred to me as "Brother Merv," No one calls me "Brother Merv," including John Gardner. I am called many things by many people but that is not one of them. In fact, much of The Bee's story is based on circumstantial, third-hand information from this health consultant whom I do not know. It seems significant that this consultant is white; that the reporters took his word about a black man and presented it as truth; that they apparently did not interview Gardner himself.

IN THE STORY, the health official to whom I reportedly delivered Gardner's plan quotes me as saying. "He (Gardner) is a constituent of mine from Los Angeles. I am not asking you to do any favors for him. But I ask you to hear him out." That quote and its significance apparently fell on deaf ears among The Bee staff; it surely didn't deter them from attempting to build a structure on a nonexistent foundation.

The story concluded nothing, it asserted nothing, it charged nothing. It presented no evidence of legal violations, no conflict of interest, or of exertion of unethical pressure. It was an indictment based on the logic of guilt by association, with no consideration of whether Gardner made contributions to other campaigns, which he did, and no consideration of whether other officials have identical histories of responding to requests of

constituents — parolees or otherwise. It titillated, it implied, it left the readers to draw their own conclusions. It was not a substantive investigative story, though it ran in length for over half a page. But it was damaging.

Picked up by the UPI and AP wire services the story was run by newspapers all over the state — largely without presenting my version of the story — headlined variously as: "Dymally Reportedly Aided Man With Crime Record"; "Dymally, Dope Dealer Tie Probed"; "Dymally, Dope Dealer Tie Probed"; "Dymally Link to Ex-Opium Dealer Bared"; "Report Details Dymally Association with Known L.A. Crime Figure"; "Dymally Crime Link Revealed."

SO INSTEAD of a responsive public official who once assisted a young black man trying to build a new life in a hostile society, I have become, as the media would have it, a fellow traveler with the criminal underworld delice in deput ratific

dealing in drug traffic.
The view from where I sit is indeed different.

First of all, I didn't "reportedly" aid a man with a criminal record. I did aid him, and hundreds of others like him, and I fully intend to continue doing so. Second, my appearing before any public board on behalf of any individual, as I choose, is an exercise of my rights, even my duty—a common act of public officials, and not "political intervention." Third, Gardner was not an "opium dealer" but a pharmacist convicted of illegally selling drugs. Fourth, such a conviction does not make anyone a "known crime figure" in the sense that that phrase is commonly used. Fifth, most black doctors, lawyers and other professionals have purchased tickets to my fund-raisers at one time or another, not because of personal favors, but because they appreciated my efforts for my district, and because they are about the only people in the black community who can afford to heip blacks get elected to positions of power.

BLACKS HAVE only recently come into office in any sizeable number after a long, long period of absence and silence that began with post-Reconstruction. They have come into office only after the long struggle of the civil rights movement, the leadership of Martin Luther King Jr., the marches of thousands of blacks, many of whom were beaten and killed in their determination to secure the Voting Rights Act of 1965.

Let me show you the ludicruous extent, the invasions of privacy that have resulted:

● Last year my brother visited me in my office for a few days. A reporter immediately wanted to know if he were on my payroll.

- I enrolled in graduate school to work toward a Ph.D. A reporter tried to check my grades to see if I was being graded too easily.
- A reporter asked another state official about my sex life.
- Another reporter examined my Master's thesis at at Sacramento

  State University, to see if I had really written it.
- A magazine suggested that I obtained money from Senator
  Humphrey's 1972 campaign, an allegation refuted by the Senator
  himself.
- I was named chairman of the Commission of the Californias. A

  San Diego reporter immediately began investigating handling of an
  eight-year-old assistance fund managed by the commission (never
  any similar investigation during previous Lieutenant Governors).
- My son ran an errand in Sacramento for his part-time employer.
  A reporter wanted to know if he and I were in the legislative mailing business.
- A state health department official was fired. I was the immediate subject of a Bee story saying I was primarily responsible, though the reporter did not even check with me for my side, and though his subsequent stories indicated the real causes for the man's dismissal.
- I objected to naming of a man I felt unqualified to the Los
  Angeles School Board. The Los Angeles Times claimed I used
  a red light to pull a school official off the road and threatened him--even though the Times was given positive proof that
  my car had no red light by the California Highway Patrol.

I have generally found the  $\frac{\text{Bee}}{\text{E}}$  to be one of the fore responsible papers in the U.S., though I admit to having been struck at

their unswerving support of the "Fresno Bee Four", who were jailed for violating a court order, while attacking me on spurious, falacious grounds when I had broken no laws. It seems there is more meaning attached to the concept of "freedom" when it involves the press than when it involves a black official seeking to realize for the historically disenfranchised, the other freedoms guaranteed in the Constitution.

Ironically, it was a group of black church members from San Francisco who waged an around the clock vigil in Fresno in support of the "Fresno Bee Four" until they were freed.

But if the  $\underline{\text{Bee}}$  is relatively more conscionable, the  $\underline{\text{L.A. Times}}$  is imminently less so.

It is difficult, upon reviewing the series of stories on me by the media, to consider their motive. This question is more puzzling when one considers the fact that no legal charges have been made against me by any law enforcement agency. Accepting this conclusion, the question follows: what can be done about it. In order to arrive at any answer to that question, it seems to me we need to examine one of the basic issues raised by such coverage, and I can only suggest here what I consider to be the primary issue. And that is the tendency of the press to justify all their actions by appealing to the First Amendment.

Personally the experience I have undergone is hardly pleasurable, does little for one's self concept and sense of achievement. I'm sure the media would tend to say, "That's your problem, not ours"

But I think it is far more than just my problem. It is the media's problem; it is the problem of our society in general. When-and if--and whether intentionally or for a host of reasons--the news media distort or misrepresent the record, the accomplishments or

the character of a public official, then I think it is a problem affecting all of us.

Professionally I have established a strong record of achievement in the fields of education, political reform, women's rights and civil liberties. When such an advocate—myself or anyone else—is impugned or discredited unfairly or thoughtlessly, then I maintain that more than just that individual suffers.

My effectiveness in these areas in the future remains to be seen, after I have been dragged through the mire of character assassination, innuendo, rumor and hyped-up reporting.

And as a Black elected official, I represent, along with all other Black officials, a symbol of opening up of the system, a symbol of the struggle for justice through political participation. The significance then, of course, transcends one individual. We are, for countless citizens, the vestige of hope that sustains them in the never-ending effort to realize the promise of democracy in the society.

Consideration must be given to whether the creating of impediments to further progress in human rights is precisely the intent of this harassment. For nationwide, the same thing is happening to a score of major Black political leaders. And historically, traditionally, what better way is there to destroy or lessen the effectiveness of any movement, than to discredit its leaders?

Am I asking that the press, and society, to judge us differently or treat us with kid gloves because we are Black? Pricisely not.

All we ask is:

That news media, and society, understand the Black perspective,

try to realize that problems faced by Black leaders were not
are not--necessarily the same as those faced by white estab-

lishment politicians, and that our responses cannot always be the same.

- That we be subjected to the <u>same</u> level of investigation, probing, and scrutiny as other political leaders, no less.
- reporting, probing, exposing--commendable as it may be--does not relieve them of the responsibility to report accurately and fairly, that which is not destructive and sensational.

Finally, I raise the question of the extent to which the printed media have a responsibility to be fair in their portrayal of public officials. There is no law requiring fairness; in fact, the law makes it practically impossible for an elected official to sue a newspaper for libel. There are probably no economic rewards for being fair. Sensational falsehoods are likely to sell more papers than the sober truth.

Thus, my only recourse is to appeal to the moral sense of the publisher or editor or news director who decides what we are to receive in the way of news and to the people who must judge the accuracy and fairness of the news they read. Any person, white or black, Republican or Democrat, in politics or not, can be made to look questionable through a careful juxtaposition of unrelated facts—as happened to me in the Gardner story. In this way the press can destroy almost anyone, regardless of his positive accomplishments.

But if this is the intention of the press or the unintended result of their coverage then it is highly irresponsible. Every elected official has been chosen by thousands of Californians, in my case hundreds of thousands against strong opposition. The press

should respect this, at least to the point of doing an honest job of evaluation. Such a story limits itself to valid criticism, and sets it in perspective against whatever favorable comment may be relevant.

I have no objection to an honest inquiry. In fact, I would welcome one. It would be a refreshing change from much of what I've experienced over the last two years.

Prime Minister Forbes Burnham and Foreign Minister Fred Wills met with Bishop Jim Jones--who established the Peoples Temple Agriculture Mission at Jonestown in the Northwest District--and with the Lieutenant Governor of California, Hon. Mervyn Dymally. The private meeting, which took place residence, Wednesday in the Prime Minister's effice, centered around the topic of relations between Guyana and the United States. The Lt. Governor is the second top political figure in the most populated state of America, and he came as Bishop Jones' guest to visit the Jonestown project and also to pay a courte-sy visit to the Prime Minister.

Both Bishop Jones and the Lt. Governor have spoken out on the right of all Third World countries to pursue a course of self-determination without interference from other country.

Bishop Jones, who has a large movement of many thousands in various states of America, met privately with Mrs. Jimmy Carter, the newly elected President's wife, and also the new Vice-President, Walter Mondale, prior to the recent Presidential election. The Bishop made his support of the Carter-Mondale ticket contingent on the assurance that the new administration would pursue a non-interventionist policy, particularly with respect to Guyana. The Bishop said he was given that assurance by both Mrs. Carter and Vice-President Mondale.

Prime Minister Burnham and Minister Wills indicated to Bishop Jones and Mr. Dymally that Guyana wants to keep the doors open to cooperation with the United States. The Lt. Governor said he intends to convey that message to the U.S. State Department sometime after the inaugaration of the new President in January. The Lt. Governor recently spoke out—in Trinidad, where he grew up—against CIA destabilization efforts in the Caribbean.

Following the meeting, Deputy Prime Minister Ptolomy Reid gave Bishop

Jones and Lt. Governor Dymally a luncheon reception at Hermanston House, which

was attended by other ministers and government officials, as well as representa-

tives of the clergy, trade union later, and the medical field.

Dr. Reid extended his appreciation, on behalf of the government, to the Lt. The first ten pages were run by the <u>Bee</u>; the other four pages were omitted by the <u>Bee</u>, apparently for space reasons, but contain points of a general nature on media coverage of Black elected officials. They are also attached, and so designated.

I think these are questions on which we need a continuing dialogue. I welcome any comments you may have, favorable or unfavorable.

## 'The View From Where I Sit'

By MERVYN M. DYMALLY California Lieutesant Governor SINCE TAKING office as lieutenant governor of the State of California, I have been subjected to repeated scrutiny by some newspapers around the state, most notably the Los Angeles Times and, more recently, by The Sacramento Bee. It has long been my policy to maintain an open office, to facilitate to the fullest extent possible media access to myself and my activities. It has always been my conviction that the press has a responsibility to report fully and accurately on all aspects of government in order to inform the public of the doings of their elected and appointed representatives.

My conviction is no less firm, though I have come to question seriously how responsibly the press carries out its responsibility. Consequently, I find myself reassessing my policy of openness and access. In considering a change in that policy, I feel an obligation to set forth the reasons for the shift in my thinking.

SIMPLY STATED, I can only describe my experiences of the past two years with the printed media as a horror, as an unending nightmare. I find an image being projected of myself as a person and as an elected official that totally denies my sense of values, that misrepresents my intentions, that impugns my integrity, that mocks my commitments.

One can speculate endlessly as to the reasons for the treatment I have

been accorded:

It may be as blatant as the fact that I am black and the powers in a racist society are obliged to discredit—if not destroy —a high-level black official who has obtained — if not in reality, at least in appearance — the semblance of power. I would like to think not:

— Of it may be as subtle as the seemingly insignificant innuendos and implications made by white reporters, out of ignorance and insensitivity that cumulatively reveal their unconscious racism.

Or it may well be sloppy reporting and editing, and a tendency among some reporters, once they have decided on a story, to select only the facts that support their conclusions, and disregard the rest. I have seen definite evidence of this in some instances, in The Bee and in other publications.

— Perhaps it is that the media

— Perhaps it is that the media Capitol bureaus, while well meaning, still are all white and thus unable to grasp the realities of black politics and black politicians.

— Or on the other hand, maybe it is that the imbalance in the news reported about me results from the This statement from Lt. Gov. fact that most newsmen are still uncomfortable reporting good news, or writing about some seemingly dull but good thing that an individual does. It is much more normal to dig up the sensational. That's what wins the pats on the back from editors, the media awards, etc. But is it accurate reporting of the total picture about a situation or individual?

— In fact, there are those who say that there is government as it actually exists in reality, and government as it is reported to us through the news media, and that the two are not necessarily the same — indeed, are not the same. I never realized just how true this is until this past two years of news coverage of myself, for I see myself portrayed in the media too often as an unscrupulous politician, and I know that this is just not an accurate picture of Mervyn Dymally.

I AM TIRED of it: I protest, and I have decided to tell my side of the story. The view from where I sit looks very different, indeed, and I thank The Bee editors for allowing me to present it.

I think all of the shortcomings of news coverage I went into above, are illustrated in recent articles about a Los Angeles pharmacist, John David Gardner, and his involvement with me. Let me explain. (The first article appeared in The Bee.)

Anyone elected to public office quickly finds a large portion of his or her duties revolve around responding to constituent complaints, requests for information and pleas for assistance.

A person who has been long established and actively involved in the community from which he or she is elected finds the demands multiplied by virtue of the network of relationships that have developed over the years, and the multitude of persons who feel that they have special access to their now-elected representing a low-income black community, who has campaigned on a platform promising solutions to problems that plague the daily life of the community, is deluged with an incredible diversity and volume of requests for help.

I responded to these requests. Letters from me are in the files of

handreds of people who are in prison or have had problems with school or welfare, or have run afoul of the state regulations or rules in some other way. Often the mother or a relative would come into my office and ask for a letter or a phone call or just "some help." I never tried to judge these individuals, which was not my job, and I always did what I could — which was very much my job.

A TYPICAL CASE was the family that approached me in 1963 when I was a freshman assemblyman representing the ghetto of Los Angeles. A member of this family, a pharmacist, was serving a prison term, having been convicted of illegally selling drugs, and was shortly to be eligible for parole. I agreed to go see him and, in that way, met John David Gardner for the first time.

If a constituent asks for help and is denied, that person is unlikely to ask a second time. If a constituent receives a response, he or she is likely to ask a second time. So it was that ever the years, John Gardner moved in and out of my political career in a very minor way — one of thousands of individuals. I wrote a letter in his behalf to the California Adult Authority before he was paroled, stressing his positive stiributes in much the same socially accepted way that employers, almost without thought, write letters of recommendation for former employes. I also appeared, as did several other community leaders, before the State Board of Pharmacy in support of his license being restored at a public hearing.

My interpretation of the system of justice in this country, admittedly a literal one, is that once a person has served his time in prison, he has paid his "debt to society." There is no provision in the system of law for perpetual punishment. My understanding of the philosophy of "rehabilitation" of convicted offenders is that unless they become reintegrated in a meaningful way in society, it is nearly inevitable that they will again turn to crime and return to prison. Fundamental to such reintegration is economic security. Thus, I tried to help John Gardner, and for a brief time — about two months, not two years as reported in The Bee, at a salary of \$200 a month.

John Gardner worked as a part-time aide in my Los Angeles office in the mid-1840s. He performed some odd jobs at my office and became acquainted with my family. He worked for a time at a small filling station leased by my brother-in-law, pumping gas and occasionally doing minimal bookkeeping.

WHEN THE CONCEPT of prepaid health plans emerged, John Gardner, with some prominent medical doctors, pursued his pharmaceutical interests, and had a health consultant in Los Angeles develop a proposal for consideration by the State Health Department. I, too, saw potential in prepaid health plans as a possible way to provide health care at a reasonable cost to low-income communities.

I have consistently worked with black doctors in the interest of giving them a voice in the organized medical profession of this state. On more than one occasion, I supported or sponsored legislation in support of health care for my district. I often carried plans for proposals, some relating to health services, to Sacramento as I traveled between Los Angeles and the Capitol — including, I am told, a plan developed by Gardner and some doctors. (I do not specifically recall

Performing these duties for constituents is a routine part of a legislator's responsibilities. I have carried countless documents back and forth for constituents. I arranged meetings between State Health Department officials and organized black doctors' groups in hopes of assuring that contracts for prepaid health plans in black communities would be awarded to black professionals.

THE MOST concentrated period of negotiations for such plans occurred during the Reagan administration while I was a state senator. It should go without saying that as a black legislator from Watts, my influence in that administration was not exactly overwhelming. The Health Department fought awarding any contracts to black doctors; and while the department resisted, it approved contracts with four large white medical corporations, two of which moved into South-Central Los Angeles.

By the time a contract was awarded to a black group, most of the patients had been signed up by white plans, and failure for the black plan was guaranteed.

Gardner's plan was not approved, apparently because of his record. He consequently requested a certificate of rahabilitation in the Superior Court in pursuit of a pardon. The Bee reported that a letter over my signature in support of a pardon appears in the file on this case. I do not recall writing the letter, but may very well have done so.

ON AUG. 12, 1976, I spent an hour and a half with two reporters from The Sacramento Bee. The thrust of the interview was an ill-disguised attempt to link me in a negative way with John Gardner and the allegations against Omni-Rx, a health care company in Los Angeles. Evidently, though I knew it only from The Bee article, Gardner's pharmacy had filled Omni-Rx prescriptions. The primary issue for the reporters seemed to be that people connected with John Gardner had purchased tickets to a fund-raising dinner held in my behalf during my campaign for re-election as state senator in 1972.

On Friday, Sept. 10, 1976, an article appeared in The Sacramento Bee entitled "Campaign Fund Donations? Dymally is Linked to Controversial Pharmacist." At the time of the interview, a number of staff members in my office speculated that no story would be printed; that the integrity of The Bee management and ownership would preclude the release of such a charade. What was not taken into consideration was the need to print something in order to justify the hours of research that had led nowhere. The story that appeared was a nonstory. It was a stringing together of unrelated bits of information and innuendos, well sprinkled with my candid quotes, refutations and explanations.

The story, for example, said that "Dymally and Gardner were frequently seen meeting together at the Shanty, a downtown Los Angeles cocktail lounge." Anyone who knows me at all knows that my life-style is not characterized by frequenting bars or cocktail lounges. I still don't know where the Shanty is—or if there even is such a place. Furthermore, I have had no contact with Gardner ever sinced became lieutenant governor—and prior to that had contact largely when he informally dropped by the office.

The story said, "Other . . . sources . . . say that Gardner was connected with a number of enterprises operated by the Dymally family." Any check of the facts will show that there are no Dymally enterprises. I have no business interests. My sister owns a struggling beauty school in Los Angeles (and, incidentally, has studiously avoided accepting any federal funds that most other schools receive for fear that the media would use that as the basis for another negative story about me). My brother-in-law previously leased a service station and no longer has even that. Those are the "enterprises" of the Dymally family.

The health consultant who prepared Gardner's proposal for a health plan was quoted as saying that Gardner referred to me as "Brother Merv." No one calls me "Brother Merv." including John Gardner. I am called many things by many people but that is not one of them. In fact, much of The Bee's story is based on circumstantial, third-hand information from this health consultant whom I do not know. It seems significant that this consultant is white; that the reporters took his word about a black man and presented it as truth; that they apparently did not interview Gardner himself.

IN THE STORY, the health official to whom I reportedly delivered Gardner's plan quotes me as saying, "He (Gardner) is a constituent of mine from Los Angeles. I am not asking you to do any favors for him. But I ask you to hear him out." That quote and its significance apparently fell on deaf ears among The Bee staff; it surely didn't deter them from attempting to build a structure on a nonexistent foundation.

The story concluded nothing, it asserted nothing, it charged nothing. It presented no evidence of legal violations, no conflict of interest, or of exertion of unethical pressure. It was an indictment based on the logic of guilt by association, with no consideration of whether Gardner made contributions to other campaigns, which he did, and no consideration of whether other officials have identical histories of responding to requests of

constituents — parolees or otherwise. It titillated, it implied, it left the readers to draw their own conclusions. It was not a substantive investigative story, though it ran in length for over half a page. But it was damaging.

Picked up by the UPI and AP wire services the story was run by newspapers all over the state—largely without presenting my version of the story—headlined variously as: "Dymally Reportedly Aided Man With Crime Record"; "Dymally, Dope Dealer Tie Probed"; "Dymally Link to Ex-Opium Dealer Bared"; "Report Details Dymally Association with Known L.A. Crime Figure"; "Dymally Crime Link Revealed."

SO INSEAD of a responsive public official who once assisted a young black man trying to build a new life in a hostile society, I have become, as the media would have it, a fellow traveler with the criminal underworld dealing in drug traffic.

The view from where I sit is indeed different.

First of all, I didn't "reportedly" aid a man with a criminal record. I did aid him, and hundreds of others like him, and I fully intend to continue doing so. Second, my appearing before any public board on behalf of any individual, as I choose, is an exercise of my rights, even my duty—a common act of public officials, and not "political intervention." Third, Gardner was not an "oplum dealer" but a pharmacist convicted of illegally selling drugs. Fourth, such a conviction does not make anyone a "known crime figure" in the sense that that phrase is commonly used. Fifth, most black doctors, lawyers and other professionals have purchased tickets to my fund-raisers at one time or another, not because of personal favors, but because of personal favors, but because they appreciated my efforts for my district, and because they are about the only people in the black community who can afford to help blacks get elected to positions of power.

BLACKS HAVE only recently come into office in any sizeable number after a long, long period of absence and silence that began with post-Reconstruction. They have come into office only after the long struggle of the civil rights movement, the leadership of Martin Luther King Jr., the marches of thousands of blacks, many of whom were beaten and killed in their determination to secure the Voting Rights Act of 1965.

It is only one in a long series of incidents which have resulted in sustained harassment and distortion during my short tenure as lieutenant governor — a degree of harassment which has not been applied to any other elected officials.

THE LOS ANGELES Times was reported to have 12 or more investigations going on me at one time. The Bee has had four or five. The rumors about me and my activities have taken on a life of their own, despite the fact they are regularly refuted and disproved, and that the other persons involved regularly deny and point out the untruth of the accusations.

I have no objection to an honest inquiry. In fact, I would welcome one. It would be a refreshing change from much of what I've experienced over the last two years.

It is only one in a long series of incidents which have resulted in sustained harassment and distortion during my short tenure as Lieutenant Governor -- a degree of harassment which has not been applied to any other elected officials.

The Los Angeles Times was reported to have twelve, or more-investigations going on me at one time. The Bee has had four or five. The rumors about me and my activities have taken on a life of their own despite the fact they are regularly refuted and disproved, and that the other persons involved regularly deny and point out the untruth of the accusations

Let me show you the ludicruous extent, the invasions of privacy that have resulted:

• Last year my brother visited me in my office for a few days. A reporter immediately wanted to know if he were on my payroll.

- I enrolled in graduate school to work toward a Ph.D. A reporter tried to check my grades to see if I was being graded too easily.
- A reporter asked another state official about my sex life.
- Another reporter examined my Master's thesis at at Sacramento

  State University, to see if I had really written it.
- A magazine suggested that I obtained money from Senator Humphrey's 1972 campaign, an allegation refuted by the Senator himself.
- I was named chairman of the Commission of the Californias. A

  San Diego reporter immediately began investigating handling of an
  eight-year-old assistance fund managed by the commission (never
  any similar investigation during previous Lieutenant Governors).
- My son ran an errand in Sacramento for his part-time employer.
  A reporter wanted to know if he and I were in the legislative mailing business.
- A state health department official was fired. I was the immediate subject of a <u>Bee</u> story saying I was primarily responsible, though the reporter did not even check with me for my side, and though his subsequent stories indicated the real causes for the man's dismissal.
- I objected to naming of a man I felt unqualified to the Los

  Angeles School Board. The Los Angeles Times claimed I used

  a red light to pull a school official off the road and threatened him--even though the Times was given positive proof that

  my car had no red light by the California Highway Patrol.

  I have generally found the Ree to be one of the more respon-

I have generally found the Bee to be one of the more responsible papers in the U.S., though I admit to having been struck at

their unswerving support of the "Fresno Bee Four", who were jailed for violating a court order, while attacking me on spurious, falacious grounds when I had broken no laws. It seems there is more meaning attached to the concept of "freedom" when it involves the press than when it involves a black official seeking to realize for the historically disenfranchised, the other freedoms guaranteed in the Constitution.

Ironically, it was a group of black church members from San Francisco who waged an around the clock vigil in Fresno in support of the "Fresno Bee Four" until they were freed.

But if the  $\underline{\text{Bee}}$  is relatively more conscionable, the  $\underline{\text{L.A. Times}}$  is imminently less so.

It is difficult, upon reviewing the series of stories on me by the media, to consider their motive. This question is more puzzling when one considers the fact that no legal charges have been made against me by any law enforcement agency. Accepting this conclusion, the question follows: what can be done about it. In order to arrive at any answer to that question, it seems to me we need to examine one of the basic issues raised by such coverage, and I can only suggest here what I consider to be the primary issue. And that is the tendency of the press to justify all their actions by appealing to the First Amendment.

Personally the experience I have undergone is hardly pleasurable, does little for one's self concept and sense of achievement. I'm sure the media would tend to say, "That's your problem, not ours"

But I think it is far more than just my problem. It is the media's problem; it is the problem of our society in general. When-and if--and whether intentionally or for a host of reasons--the news media distort or misrepresent the record, the accomplishments or

the character of a public official, then I think it is a problem affecting all of us.

Professionally I have established a strong record of achievement in the fields of education, political reform, women's rights and civil liberties. When such an advocate--myself or anyone else-- is impugned or discredited unfairly or thoughtlessly, then I maintain that more than just that individual suffers.

My effectiveness in these areas in the future remains to be seen, after I have been dragged through the mire of character assassination, innuendo, rumor and hyped-up reporting.

And as a Black elected official, I represent, along with all other Black officials, a symbol of opening up of the system, a symbol of the struggle for justice through political participation. The significance then, of course, transcends one individual. We are, for countless citizens, the vestige of hope that sustains them in the never-ending effort to realize the promise of democracy in the society.

Consideration must be given to whether the creating of impediments to further progress in human rights is precisely the intent of this harassment. For nationwide, the same thing is happening to a score of major Black political leaders. And historically, traditionally, what better way is there to destroy or lessen the effectiveness of any movement, than to discredit its leaders?

Am I asking that the press, and society, to judge us differently or treat us with kid gloves because we are Black? Precisely not.

All we ask is:

That news media, and society, understand the Black perspective,

try to realize that problems faced by Black leaders were not
are not--necessarily the same as those faced by white estab-

lishment politicians, and that our responses cannot always be the same.

- That we be subjected to the <u>same</u> level of investigation, probing, and scrutiny as other political leaders, no less.
- That the media realize that the current mania for investigative reporting, probing, exposing—commendable as it may be—does not relieve them of the responsibility to report accurately and fairly, that which is not destructive and sensational.

Finally, I raise the question of the extent to which the printed media have a responsibility to be fair in their portrayal of public officials. There is no law requiring fairness; in fact, the law makes it practically impossible for an elected official to sue a newspaper for libel. There are probably no economic rewards for being fair. Sensational falsehoods are likely to sell more papers than the sober truth.

Thus, my only recourse is to appeal to the moral sense of the publisher or editor or news director who decides what we are to receive in the way of news and to the people who must judge the accuracy and fairness of the news they read. Any person, white or black, Republican or Democrat, in politics or not, can be made to look questionable through a careful juxtaposition of unrelated facts—as happened to me in the Gardner story. In this way the press can destroy almost anyone, regardless of his positive accomplishments.

But if this is the intention of the press or the unintended result of their coverage then it is highly irresponsible. Every elected official has been chosen by thousands of Californians, in my case hundreds of thousands against strong opposition. The press

should respect this, at least to the point of doing an honest job of evaluation. Such a story limits itself to valid criticism, and sets it in perspective against whatever favorable comment may be relevant.

I have no objection to an honest inquiry. In fact, I would welcome one. It would be a refreshing change from much of what I've experienced over the last two years.

Dear Mr. Burnham:

I want to share with you a matter of great concern to me.

The concept of a politically motivated conspiracy directed against an individual or organization in an attempt to discredit and destroy one's effectiveness in the political and social arena should be utterly foreign to a democratic society. Unfortunately, however, such is not the case.

Having myself been the subject of an ungrounded attack by the media and other agencies, I have first hand experience as to how such campaigns against outspoken persons are launched and carried forward.

Recently, the Lieutenant Governor of Colorado, Lieutenant Governor George Brown, and I joined the National Association of Human Rights Workers to announce the publication of an exhaustive study of organized efforts in the United States to discredit black elected officials. In looking at the extensive body of data compiled after two years of careful research, the picture is unmistakably clear that conspiracies against black and third world people are very real and serve to blunt the effectiveness of any person trying to represent the interest of third world people.

One such person to whom the media and several agencies of government have deliberately and concertedly focussed their resources is one of the most committed activists and finest human beings I know--Reverend Jim Jones. Reverend Jones is the leader of a multi-tethnic, multi-facted, many thousand member organization known as People's Temple. It is one of the most significant forces today in the area of human rights, social change and concrete service work.

It is my belief that by the year 1980 the minority population in California alone will reach the 60% mark. People's Temple is a working solution to the problem that California can anticipate in the not so far distant future. People's Temple has managed to effectively organize minority and caucasians as well, into a viable, progressive force.

A noteworthy feature of the Temple's program is its compassionate emphasis on the needs of the ever growing senior population. This emphasis accurately reflects the shifting age curve of the future and meets that need with kindness not condescension.

Beyond that, Reverend Jones and People's Temple have helped every person who in recent years has been oppressed or jailed fundamentally because of his or her political beliefs. Jim has never been reticent to speak his beliefs in non-violent causes.

It is my confirmed opinion that this outspoken stance coupled with the undeniable size and effectiveness of his organization, has made him a target of the most gruelling and vicious conspiracy yet witnessed.

That which I know to be obvious, lies and frame-up, are presented to the public as thoroughly proven facts. Interestingly enough, the scurrilous nature of these lies were meted out to papers in those cities throughout the world which has the highest concentration of Carribean and, in particular, Guyanese residents. By doing so, the organizers of this conspiracy hoped to have such information filter into Guyana where Reverend Jones has established a remarkable and highly successful model community which I personally have visited. I found that visit to be one of the most rewarding experiences of my life.

One of the key figures in this cruel scenario is a man with a well documented criminal background who has been described by several correctional specialists as a "con man" with an insatiable desire for money and notoriety. Also involved is a high priced public relations firm whose job is to map out campaigns to discredit Reverend Jones and feed information prepackaged to a supposedly free and "objective" press.

It is clear to me that a phenomenal amount of money is being spent by this conspiracy in an attempt to destabilize the agricultural project in Guyana and to apparently, bring about the elimination of Reverend Jones.

Evidence currently being gathered points clearly to right wing forces of the first magnitude. One such force is known to have political affiliation with those remnants of the Nazis who continue

to permeate the fabric of American society to a degree that would shock people unfamiliar with the growing move to the radical right in the United States.

In fact, the last time I visited the San Francisco Headquarters of the People's Temple several weeks ago, a large Nazi rally was taking place in the nearby city of San Jose. It was covered extensively by all media. Klu Klux Klan chapters continue to grow and flourish in all parts of the United States. It is likely that the Panama Treaty will be defeated as a result of the well financed campaign against its passage. These are but a few examples to give you some idea of the current trend.

As a native of Trinidad, my bonds with the Caribbean are close and everlasting. I feel a certain responsibility to apprise you of my thoughts on Jim Jones and my interpretation of what I have seen of the attack on him and his organization in the past months. Jim is a deeply loyal and sensitive person and he is a man who stands by his word and by those who look to him for guidance and leadership. It is this kind of loyalty that makes him a man to be trusted. I know for a fact that he will stand by his commitment to Guyana just as firmly as he now stands by his commitment to any one of his children.

I look forward to future visits to Guyana and extend to you my warmest personal regards.

Enclosed you will find a review of the article that appeared in the Los Angeles Times on July 3, 1975. I am hopeful that this analysis will convey my impressions and concerns regarding the article.

I feel that the Los Angeles Times has violated many of the basic rules of fair reporting in this article. Through the use of sensationalized headlines and 'hyped-up' wording throughout the article, I feel that the Times has dealt a serious blow to their reputation as one of the foremost papers in the world.

The article uses many words that go far beyond fair, accurate reporting and into the area of value judgments. A small sampling:

- . "misused funds"
- . "forged checks"
- "abuses"
- . "unauthorized salary"
  - "the program failed"
- . "plagued by fiscal irregularities"
- . "exhausted its funds and dissolved"
- "situation was desperate"
- "outlook was dismal"
- "widespread bookkeeping irregularities"
- "shoddy practices and misleading advertising"

I raise the question as to whether or not an article which utilizes such words and phrases would not be better suited for the editorial page. When reporters interject their own concepts, their own judgments, their own value judgments, they are no longer reporting the news, they are creating it.

I also strongly object to the interviewing tactics utilized by the writers of the story; Dave Rosenzweig, Mike Goodman, and Böb Fairbanks. It seems to me that when reporters are preparing to make a series of allegations against someone, and they ask for an interview 'to give you a chance to tell your side', they, at some time during the interview, have an obligation to reveal their facts, their allegations. Otherwise, the person being interviewed is not given a chance to respond to the charges. Rather, your reporters simply took my responses to general, veiled questions and worked them into the parts of the story where they made specific allegations. In this way, quotes were taken out of context and then used in the story alongside information gathered to refute "my response". It was made to appear that I was responding to a specific charge. This was not the case.

These tactics have been ruled unconstitutional when used by our police -- but our law enforcement people obviously operate under a stricter standard of fair play, of due process, than does the Times.

Let me cite a few examples. At no time was I told that I was going to be accused of receiving \$7,000 in unauthorized salary which I allegedly paid back in a devious manner through the Ford Foundation. Had I been told this, I might have been able to save you from making this error in the story.

Further, at no time was I told that the article would claim that my brother and sister-in-law were on the JET payroll; nor that the reporters would claim JET obtained only 37 jobs; nor about the Bill Greene plane trips; nor about the "big spenders" at Perinos; nor the claim that thousands of dollars of furniture had disappeared.

The reporters obviously did not want me to respond to these charges; to say something they did not want to hear:

- That the Urban League, not Urban Affairs hired my brother and sister-in-law
- That hundreds were trained by JET
- . That I too was upset by the Greene trips, et cetra

This would have ruined their story.

Your story forces me to consider whether or not we are witnessing the birth of a "New McCarthyism". Is guilt by innuendo and guilt by association going to become the horm of investigative reporting?

I have examined some of the statements made by public officials during the McCarthy era, and I find them frighteningly similar to the current practices of the <u>Times</u>. Senator Estes Kefauver of Tennessee said in March, 1952:

...McCarthyism represents one of the greatest threats to our nation and to our freedom. Due to this guiltby-association technique and smear technique used for political purposes; McCarthyism is forcing a lot of our people into conformity of thinking.

The magazine, Commonweal, said of McCarthyism in August, 1952:

...a real danger exists that the smear technique and the sly innuendo will come to be accepted as normal tools of statesmanship, that the blanket accusation and the careless charge will become routine elements in any campaign.

I ask that the <u>Los Angeles</u> <u>Times</u> take a good, hard look at their "investigative" stories to make sure that they are not falling into the habits practiced by Joe McCarthy in the 50's.

Mr. Chandler, your reporters acted as prosecuter, judge and jury in this article. This "trial by newspaper" compared with the Yellow Journalism practiced by many papers years ago, a practice that was thought to be dead.

Your article devoted almost 90 inches to attacking me with a few facts mixed with innuendo, allegation, half-truth and distortion, all aimed at making it appear that Urban Affairs and my involvement with it was nothing more than sham, trickery and financial double dealing.

I quote from the State Attorney General's office:

"Earlier Thursday, Assistant State Attorney General Warren Abbott confirmed that his office has been investigating for more than a year what Abbott called "relatively minor accounting questions" concerning the Urban Affairs Institute."

Abbott stressed subsequently that this investigation, and that involving Windsor, were of the books and ledgers and not of the Lieutenant Governor himself.

Further, Ms. Nancy Boggs, administrative officer with the Ford Foundation, in a letter printed in the <u>Times</u>, July 14, 1975 denies the charge that there were "reported abuses". She states that "refunding was approved in part because progress was being made in remedying a number of problems that had come to light sometime after the project's initial funding in 1968 — and not 'despite reported abuses'". She also said in her letter that "we were encouraged by U.A.I.'s efforts to correct internal management problems."

The Institute was born out of the ashes of Watts and other major cities which were ablaze in the late 1960's. Its goal was to involve minorities in government and public affairs. I am proud of my efforts and along with those who objectively studied U.A.I. proclaim its programs a success. I regret the Times felt the need to dust off the accounting books of this long since dead Institute to see if those of us in the program stuck to the budget—to see if we spent the Ford Foundation's money in a "proper" fashion. Your two young reporters, who were miles and miles away from the hot streets of those days, chose to apply the sterile accountant's standards of peaceful 1975 to a program that was far more interested in the social, not bookkeeping, problems of the 60's.

Maybe they should spend less time trying to find scapegoats among our governmental, industrial, and labor leaders and try to examine the root causes of our real problems — unemployment, inflation and high taxes. That would seem to be a more noble endeavor than spending large amounts of money checking to see if a foundation's tax free money was wisely spent.

Investigative reporting has come to the forefront since Watergate. I respect and encourage this trend, but feel that there is the need, indeed the obligation, for any newspaper to abide by the ethics of professional journalism. I can say it no better than did J. Edward Murray of the Detroit Free Press, a past President of the Associated Press Managing Editors:

...Investigative reporting is a high art and cannot be entrusted to every enthusiastic young reporter infflamed with post-Watergate zeal. The last thing the press needs is an excessive morality binge that looks under every rock and distrusts everything in sight except fellow reporters.

There have been many incidents of harassment of the Peoples Temple that have concerned us.

The whole issue with Kathy Hunter, for one, came as a complete surpribecause Rev. Jones had always considered her a friend. In fact, he has shown her nothing but kindness over the years. When her son married a young Indian woman, an interracial marriage of which Mrs. Hunter did not approve, Rev. Jones paid the bills for the birth of her grandchild when the couple was destitute. On numerous occasions over the years, Rev. Jones assisted her through personal and financial crises. She was frequently in debt.

When Mrs. Hunter went to Guyana, outrageous and completely conflictin stories emerged, both from her own contradictory accounts and from other news media. Note the enclosed repreints for just a small portion of the Confusion characterizes her reporting. In fact, the woman is known to have had a drinking problem.

When she went to Guyana, according to the Guyanese Minister of Home Affairs, the Honorable Vibert Mingo, she misrepresented herself to gain entry into the country, in violation of their immigration laws (Minister Mingo's statement attached). Her entire trip appeared to be either a pr vocation directly on her part, or she was being used by others to create "scenario" for which the Temple would be falsely blamed. It is difficul to know what else to think, as she had always shown so much admiration f Jim Jones publicly. Just a little while back she was saying how Rev. Jo small son John looks just like him. Now she is championing Tim Stoen, who is falsely claiming paternity of the child. How Mrs. Hunter could m such a total, sudden switch is a mystery.

Her stories to our people in Georgetown were additionally perplexing conflicting. One story she gave said she pawned a diamond ring to get t Guyana, that her husband would not let her go. However in a subsequent report, her husband defended what he called "her right to be there" in a editorial in his own paper. Where did her money to travel come from? Sh also claimed to our people that she had been sent by the Press Democrat and other publications; the Press Democrat denied this. She managed to live very expensively during her Georgetown stay.

Another situation which has been widely misrepresented is that of Deborah Layton. Her stories are illogical and absurd. She left Georget after being there several months, finally leaving in the own time and su sequently telling the ridiculous story that she had barely managed to "e cape" from Jonestown a few days earlier. In fact, she left her mother, b ther, and deserted her husband. Her motives and actions are highly questionable, as one can easily gather.

But we are in a real Catch-22 situation with her as well as others, because we are aware of things they have said or done that would belie the real motives. A case in point is the affadavit drawn up and signed by T Stoen, admitting Rev. Jones is the father of John, a fact he now disclai

Stoen claimed he was "forced" or "tricked" into signing a document -- a p fect cover-up for denying his own admissions.

Not one whit of what these people are saying about Guyana and the Temple's mission there is true. Enclosed is the statement about the Project by Dr. and Mrs. John Moore. Rev. Moore is a Methodist minister of 34 yea having headed the United Methodist Church of Northern. California. The Moo are extremely positive about their recent visit to their daughters at the Project. Just last week, a woman who is employed by the U.S. government turned to the States from Jonestown following a two-week visit to her relatives; and left her children there for a stay. She had come with a doubt point of view. But now she is very impressed, and has made herself available to speak to anyone who is interested in the Project.

We work in close cooperation with the local people in the region surrounds the Project. Hundreds of Guyanese people utilize the free medical clinic. People come and go daily with visitors, exchange food and goods, medical help, schooling, and lots of health care programs. Our young people date young people from the communities around the Project, and we continually attend community events, locally as well as in Georgetown, the capital. One hundred of our youth went to Georgetown for a recent national cultural festival and received rave reviews in the Guyana Chronicle, the nation's gest paper. Our band is very popular and plays frequently in the capital. Babies have been adopted into the community; about 200 are brought to the clinic each week for medical care.

Many people have visited the Project, and know the full range of the work, but the press will not publish it. The members of the press who have come have left very impressed, but their write-ups are either not printed or distorted beyond recognition. It is interesting though, that one very negative story did appear in both Toronto and London, an article containing untrue, malicious allegations. These two cities contain the largest number of Guyanese living outside Guyana; and was an obvious conspiratorial attempt to prejudice Guyana against Rev. Jones and the Peoples Temple. (They were unmoved by it, according to the government).

A noted Black newspaper publisher, who is also a doctor and respected community leader will be visiting Jonestown in a week or so. Rev. Jones at the Temple community stay in close contact with many community leaders via radio-telephone patch. Many supporters who have been in communication with Rev. Jones by this means include Robert Gnaizda, head of the Public Advocate public law firm in San Francisco; John Maher; Thomas Fleming, Managing Edit of the Sun-Reporter; Enola Maxwell, Chairperson of the Human Rights Commission in San Francisco. Community leaders and supporters have expressed their expectation for a visit to Jonestown in the near future.

The people of Jonestown are very well-informed, and are abreast of all current events. There are continual broadcasts from the BBC and U.S. stations, and a tremendous flow of informational and educational materials. They have read all the things Debbie Layton alleged and are disgusted!

The allegations about controlling people are ridiculous. A large segmer of the people at the Project come from ghetto environments, and many out of prisons. They are not people who would tolerate mistreatment or confinemer Published allegations of Ms. Layton's like, "I'm sure everybody wants to leave" almost defy comment. People are free to come and go as they choose. There are no fences, and if anyone wanted to leave, there is a free railway passing by the Project every day.

People in Jonestown feel very free in fact, and some of the most wonderf results we have seen are young people who have been rehabilitated from all sorts of anti-social behavior. Many were candidates for jail, or biding ti

in-between stays, but now live wholesome, productive lives, exemplary in every way. Marie Lawrence (article enclosed) was a hard-core heroin Now she is in charge of the Project's pest control project on the agricultural acreage, which entails a detailed knowledge of applied chemistry and biology. She's brilliant and using her creative abilities constructively, having discovered a deep sense of motivation and fulfillment since joining the Peoples Temple. Another young man's anti-social behavior went back to the Watts riots; he is now calm and fulfilled, doing the regular boat run up the river to deliver medical supplies to the surrounding communities. Any number of youngsters were considered "incorrigible", in school and in their respective communities, but now have a positive self-image and a bright future. It is impossible to calculate the savings from the damage that would have eventually been done, at the expense of the California taxpayer. This kind of complete, successful rehabilitation is the best thing America could ask for. And residents of Jonestown, aside from the professional people, had virtually nothing in the way of worldly possessions. If the program were shut down, there would easily be over 600 welfare recipients at the doors of Los Angeles and San Francisco overnight. Children in Jonestown are taught to be constructive and non-violent. It's a whole new generation, a break from the patterns of the past. It is the culmination of the highest ideals of the Peoples Temple and Rev. Jones, to bring racial and economic equality, and peaceful social change. And everyone receives help in the process: the people themselves; our cities; and future generations.

But perhaps the greatest test of our pacifism and commitment to non-violent ideals is to know of the conspiracy working to tear all of this down, to have positive proof of specific people involved in the conspiracy yet to let well enough alone and not bother them. Even the President would have a hard time standing up to the kind of pressures and conspiracy we have endured. There are many people in Los Angeles who are supporters although non-members of the Temple. We have talked to many, in all walks of life, who agree there is irrefutable proof of a conspiracy.

The truth of Jonestown is so plain to see —— yet who will see it? It is obviously worrisome to us that respected people in the media tell us that no matter who goes from the media, no matter how positively they should write, there would be nothing positive printed about us. Two from the San Francisco Chronicle and one from the Examiner have told us this. It is hard to know where to turn in this situation. In San Francisco, the Bay Guardian did a very thorough and excellent article (enclosed). The work is now the same, even more impressive in numerous respects —— but since the conspiracy, good news about Peoples Temple is barred from the public.

So we simply proceed with our work, the best we know how. The caliber of the medical program in Jonestown is fantastic. In the past year, 40 babies have been delivered in our medical clinic, and there have been no fatalities. Medical care is available around the clock-right by the seniors' residences, and everyone on the Project receives thorough, routine check-ups.

The local representative of the U.S. State Department in Guyana, an arch-conservative, has been to the Project many times, and checked out every one of the allegations made about persons by their relatives, and detractors. The State Department has been highly impressed, as you can see from the statement enclosed. The above representative has come frequently, arrived unannounced, and talked with people alone and independently. He has found all the allegations directed to him to be untrue, and remarked that he has really never seen so many people so well cared-for as at Jonestown.

So this is where we stand with our current situation. We know the type of tactics being waged against us in Los Angeles, we are all too familiar with harassment. But we trust you will take the foregoing information into account for an accurate perspective.

A COMMUNITY LETTER

Dear Mr. Van de Kamp:

As we learn more about the schemes to 'get Peoples Temple' through a criminal indictment out of your office, we are increasingly putraged. But we are not naive.

For twenty-five years, Jim Jones and Peoples Temple have worked tirelessly for equality, justice, and humanitarian service. We have organized around issues of civil and human rights, inhuman conditions, and the crying need for world peace and international co-operation. We have a solid record of achievement in drug rehabilitation, in providing opportunities for jobs and education for thousands of young people, in helping untold numbers of people who were destitute, despondent, in need of medical help, counseling, food, clothing, and shelter. We are all personal witnesses to this staggering achievement. You can well understand how a man like Rev. Jones will be the subject of malicious gossip, lies, hatecampaigns, and even conspiracies orchestrated inside government institutions and the intelligence establishment. We have been the object of constant, organized harassment, vandalism, violence, smear campaigns, arsonists, racists, and even hired assassins.

Political frame-ups are not unfamiliar to us, and truthfully, we are not surprised that there is an effort to destroy us through the courts. But the reality of it is no less offensive just because it was anticipated, even expected. We cannot stand idly by and stoically endure

this injustice without protest. In fact, Peoples Temple has earned its unpopularity with certain elements in the United States precisely because it has actively fought against injustice for so many years. We do remember history, and we prefer not to repeat it. These efforts that have been mounted against us are indeed part of a shameful heritage of subterfuge that has claimed many victims over the years: individuals and organizations that were pursuing progressive directions in American life, seeking to bring together oppressed people, overcome racism, and work for economic and social justice.

You have been informed that there is an effort to destroy Peoples Temple. Though we have not 'cracked' this conspiracy completely, we are certain of enough facts to arouse any just-minded individuals, and those who wish the democratic system in the United States to survive would surely be alarmed. Some of these facts have been presented to the press; the mass media, however, has been distinguished by its refusal to print any reports that would point to what is really happening. Additional facts will be brought to light soon. The story began years ago when certain individuals joined Peoples Temple who had prior experience working with the U.S. intelligence establishment and in ultra-right wing organizations. The hard facts came to light beginning in late 1976 when two military officers connected with Senator Stennis were caught trespassing near our church while a black woman mayor from Mississippi was speaking to our congregation about her trip to the Peoples Republic of China (we have no political alignment with any country, and have always attempted to keep informed about alternative forms of government and their accomplishments). The very fact that we pursued these agents and published our startling findings about their spying mission no doubt intensified the determination of those out to harm us. Would it have been proper, or moral, to remain silent about it? We think not. Democracy depends upon the people knowing what is happening to them. What happens to Peoples Temple is only an example, in some instances a harbinger, of what is planned for other minority groups.

We are confident that when you have the full picture of how the current group of people who are specifically organized to harass and persecute Peoples Temple have operated over the past year and a half, first secretly meeting to plot how to push smear and slander articles in the sensationalist press (they even hired a prominent, expensive public relations firm to help), then conspiring to pressure and recruit people who would join them in lies and subterfuges, then going further to harm innocent people using government officials, and even threatening to hire mercenaries, you would not allow your office to be used and compromised to further their schemes.

Some of the devices that have been used in the attempts to destroy us include the following:

--Government agents who have conspired directly with members of the group of 'concerned relatives' that have pushed this campaign have offered bribes and blackmail to various people to lie about and denounce Jim Jones and Peoples Temple. American Indian Movement leader Dennis Banks was pressured to do this and was offered help with his own serious legal difficulties as an entieement.

--We have documented efforts to cut off pensions and other payments to elderly members of Peoples Temple residing in Guyana. Checks have been re-routed -- hundreds of them -- with the active complicity of the U.S. Post Office Department.

--Our mail and other communications have been monitored and regularly sabotaged. One large batch of mail, including important legal documents, was doused with a wine-smelling substance. There have been many similar instances.

--Shipments of vital medical and food supplies have been interfered with by U.S. Customs Agents. Some have never been delivered.

--The same group of people now trying to pressure your office into moving against us has also engineered a series of legal maneuvers to force their children to return to the U.S. As you know, the most notorious case involved Jim Jones' own son, whom Timothy Stoen fraudulently claims to be his. Stoen, not surprisingly, is leading the current vendetta.

--News articles, letters, and other communications designed to cast aspersions on our organization and sow confusions

have been planted in various publications on the 'left' and circulated everywhere in Guyana in the modus operandi GOINTELPRO has used against various progressive and civil rights groups in the United States.

--Other 'dirty tricks' have included making phone calls of an harassing nature, impersonating members of Peoples Temple -- some to your own office -- to create hostility against Peoples Temple. There have been numerous innuendoes to the effectithat Peoples Temple has been guilty of break-ins, bomb threats, vandalism, rape, and even murder -- without a shred of evidence. What you are now apparently being asked to participate in is only the latest in a series of trumped-up, fraudulent devices.

The people in the group of 'concerned relatives' formed by Timothy Stoen are only the front line of a conspiracy. They have spent tens of thousands of dollars to pursue their schemes. We are currently investigating the source of their funding. They have brazenly masqueraded as pious, outraged, morally-offended people who are seeking honest redress of grievances. But what lies behind the mask?

Most of the people who have decided to collaborate in these maneuvers (some, evidently, after much pressure), are operating out of personal resentments against Peoples Temple and Jim Jones. They did not want to follow the path of human service except on a very superficial level, While they fancied themselves humanitarians, they were only posturing. Eventually, they couldn't go on in the contradiction, yet they could not simply leave goodness alone. They became eager to destroy Jim Jones, who represented to them the kind of human commitment that they were incapable of. This is a familiar syndrome, and made many of these people susceptible to being used by others who were interested in destroying Peoples Temple for many years -- people with strong right-wing, reactionary impulses, who could not stand to see people of all races and backgrounds co-operating and pursuing their rightful share of rights and opportunities in life. Another group of individuals, not part of Peoples Temple, were furious 11-3-6-4 that their

that their (grown) relatives chose to spend their lives in service to humanitarian goals and ideals of Peoples Temple rather than to fulfilling others' expectations of them. They, too, have a personal grudge against Jim Jones and Peoples Temple, and have joined the efforts to harm us.

These are the people who are now trying to use your office, and whoever else they can, in a desperate vendetta that we are convinced (and have mucheevidence) is being pushed, orchestrated, and financed from 'above."

It is a scenario that is not unfamiliar to veterans of civil rights struggles and the McCarthy period. Thousands of people all over California and the nation -- progressive leaders, civil rights and community activists, government officials, private citizens, people who have worked with Jim Jones and who have seen the day-in - day-out devotion to justice and humanity of Jim Jones and Peoples Temple are aware of the fact that we are just another target in a long history of what amounts to a form of treason against ordinary people who are trying to secure a decent life for themselves. We are unusual, perhaps, because we are actively demonstrating a successful alternative for people oppressed by racism, and we sense a deep responsibility to keep alive the hope and opportunity we express for others.

The growing body of individuals who we have just alluded to are, with us, infuriated and outraged and profoundly disturbed by what is happening. We are determined to expose the conspiracy against Peoples Temple. We ask that you not co-operate with it.

Mr. Van de Kamp, among us there are people who would have been dead, in prison, in street gangs, in organized crime, involved in drugs, prostitution; who would today be swelling the welfare rolls, who would be a drain on an already overburdened economy, who would have nowhere to turn, who would have been abandoned in their later years in squalid hotel rooms, who would have been victimized by rapists, thieves, and muggers -- had it not been

for Peoples Temple and Jim Jones. Many of us were caught in that vicious cycle of poverty, crime, and despair. We want you to know just exactly who it is that your office is being pressured to proceed against: people who have had very little, if anything of their own, lousy neighborhoods to live in, terrible educational facilities, unsafe working conditions (if jobs were available); people who have had to work hard for just a little tit of hope for a future for their children. And many of us here are children of broken homes, and some of us have even been sold into human slavery, right here in the twentieth century, in the United States. Today, thanks to our people's collective and our community organizations, built on care and concern for people, as exemplified by a most principled and selfsacrificing leader of men, we have been able to achieve a measure of security and well-being that we never before have had, and which we are determined will not be taken away from us.

Yet this is precisely what is intended by the group of people who are trying to use your office to hand down indictments against members of Peoples Temple. There is a sinister dimension to all of this that we think you may grasp. The efforts to frame up a few of our staff members in Los Angeles is actually a device to tie up our finances, and to effectively cut off the pioneer community here in Guyana from vital assistance. This is no mere attempt to proceed against one or two or a few people who are accused of 'crimes' they have never committed or would have ever conceived of committing: it is a move against an entire people, Mr. Van de Kamp, an act of violence and violation of the human rights and inalienable rights of all of us, a despicable attack on our work, our hopes, our achievements, our lives, our future. And it will be publicized to the world as such, and be written and widely spoken about as such by many around the United States and in many nations of theiworld who have taken amprofound interest in what Peoples Temple is doing for international co-operation in Guyana in setting up a model, multiracial community, and in what is happening to wipe out perhaps the most successful and active peoples organization

SUMMARY OF INTERVIEW WITH GORDON LINDSEY and John V Moore 1:00 p.m., August 9 Written from memory, 8/10/78.

Lindsey had called a week or so earlier. I returned his call twice to the answering service. On August 9 he called again, He said that he was writing an article for the <u>National Inquirer</u>, and asked if I was willing to be interviewed. He said that he would be taping our conversation.

"Q-S" = his questions or statements. Often he made statements, sometimes the statements were his words of the implications of what I was saying, or rather his words of his interpretation and misinterpretation of what I was saying. I would reply that I would stand by my words, not his. The order will 'be seriatum as I recall while "A" = my answer.

Indentify yourself. .

A I identified myself as pastor of First United Methodist Church of Reno.

Q. How long have you known Jim Jones?

A Eight or nine years.

Q-S You were in Guyana when? for how long?

A We were in Guyana in May for one week, four days at Peoples Temple house in Georgetown

Q In Lamaha Gardens

A Yes...and three days in Jonestown.

Q-S You stayed in the guest house...it is off by itself...it has a refrigerator...it has a mosquito netting over the bed...It's Jim Jones' house, isn't it?

bed...It's Jim Jones' house, isn't it?

A That's where we stayaf..I don't know if it is Jim Jones' house....I don't understand the reason for such questions.

Q The house is off by itself, isn't it? .

There are other houses nearby.

About how far is it from other houses?

About fifty yards.

Q-S I flew over the project... The people live in huts with a corrugated roofs... and there are privies... Hesad Thirty or

A I'd call them houses. They are small. ... Corrugated roofs were common in Guyana and Trinidad. That's one of the things I noticed in both countries.

Q-S We'll I didn't. (His words clearly gave the impression that he thought corrugated roofs were the exception in that part of the world.)

Q-S You had a privy didn't you. (There were two or three interchanges about privies)

There are different kinds of privies. We used an outhouse. They had public or common restrooms which Barbara used, but I never did. I assume that they had tanks as jour's did...It was very sanitary.

What did you eat? With whom did you eat. You ate with a small Q-S group, didn't you? Did you eat in the dinning area?

We took sack lunches at noon and ate wherever we were.... A In the evening we ate with about twenty or thirty people.

You didn't eat with the people. where they ate. Q=S We ate one evening in the entertainment area ... We had (for brackfurt) pancakes, eggs, juice or fruit, coffee... They have a native

fruit drink, which we also had in Matthews Ridge...We had chicken one night.

Debbie Layton says that the diet is principly rice. Q-S

We had rice, I doubt that rice is the principle food source. It's my impression that they do not produce enough rice for themselves. They must buy rice. I think that their diet is more from the foods they grow..such as the casava.

Debbie Layton lived with us. She is the sister of our Α daughter's former husband. Debbie had problems when she was with us. I think that she was a junior in high school, and went to England for her last year.

Q-S Teenage problems.

Debbie was a member of our family. I have nothing to say about Debbie except that Peoples Temple was a stabilizing force in her life....Debbie is not as credible a witness as her mother or husband or brother.

Are the others credible.

I regard Debbie's mother as very credible

Your daughter is . Carolyn Layton?

Yes.

A And you solemized her marriage to Prokes? Q-S

She was pregnant at the time, wasn't she? Q-S

I did not talk about Debbie's personal life. I will not talk about my daughter's. ... I've been a pastor to thousands of adults...and children... I would not answer questions of this kind about any of them.

\_ praising Jim Jones? You wrote a letter to Q-S No. I never wrote a letter to anyone praising Jim Jones. I did write a letter for the church expressing appreciation for the service ministries of Peoples Temple.

Q-\$ How can you speak highly of Peoples Temple when of "Goncerned Parents" are so critical of P.T.?

I can understand how parents are concerned...We raised Α our children to stand on their own feet, make their own decisions, and live with the consequences of the r decisions and actions.

Q-S Maria Katsaris says that her father had oral and anal intercourse with her when she was a child. (His implication was that it was a terrible charge and that P.T. of Jim Jones were responsible for it.)

A I don't know anything about that...We saw Maria in Jonestown and Georgetown. In Georgetown she had complete freedom to come and go. She could have left as Debbie left.

Q-\$ She doesn't have a passport.

A : All she would have to do would be to go to the American Embassy...

Q-S Did you see Jon Jon?

Yes...(In the course of this interchange I said that Jon Jon did look like Jim. He responded "O come now" or words to that effect. He came back to this issue once or twice in the course of the interview.)

Q-S Can you understand Tim-Stoen and his wife"s feelings? How would you feel?

A I can understand. If my child were kidnaped or taken away, I would do everything in my power to get my child back.

Q-S Would you kidnap the child.

I don't know.

Q-S You would contemplate it.

A It certainly would enter my mind, as would other thoughts.

Q-S That's contemplating it.

(He did not ask me if I could understand jim's position, or what I would do if I were in Jim's position. It is my view that child custody is a legitimate issue and that I can understand, or open to understanding the view of contending parties.... In the course of the conversation I referred to Tim and his as divorced. He objected with feeling, saying they weren't divorced. He charged that I had treated Tim and his differently than my words about confidentiality about personal matters. As best I can recall, I said I apologized. He informed me that they were not divorced, and asked: "People can be separated and not divorced, as Debbie Layton?" I responded "Of course."

Q-S What is your judgment of the medical clinic.

A I think that it is good. (I had the impression that he felt about the clinic as he did about the "huts" and "privies.")

Q-S Do you know the doctor, or meet him? Did he finish his residency?

A I think that he did not finish it in San Francisco, but I don't know. I did not imply that Larry had finished.

(I told him that our daughter was a nurse. He asked "What kind?" I replied: "Registered Nurse." He asked about the medical supplies. I said that it was my impression that they had good medical supplies. Barbara commented over my shoulder "Excellent." I said: "My wife says'excellent.")

Q-S What is your impression of Jim Jones?

A Jim Jones is in touch with the pain and suffering of people...

Q-S What about the pain of suffering of parents?

A There are lots of people in Jonestown who have known suffering in our society...

Q-S What about beatings? \_\_\_\_\_people have pictures of beaten people.

A T I don't believe the allegations about beatings.

Q-S But pictures don't lie.

A Pictures can lie

Q-S Is Jim Jones a rational man?

A I think that anyone who can lead 1,200 people from their country to settle in a new country has got it together.

Q-S I've seen the same thing...in a prison camp in Maylasia.

A Are you saying that Jonestown is a prison camp?

Q-S I didn't say that.

Q-S You sound like a politician.

A I don't mind sounding like a politician...You sound like a reporter.

Lindsey made some referrence to Congressman McCloskey, quoting him about bastards in the context of Peoples Temple. This was when we were talking about the custody issue with Jon Jon.

Once when I was expressing my view of parents of grown children, he interrupted to say that he was not interested in them, but

he interrupted to say that he was not interested in them, but the three small children. Jon Jon was obviously one of the three. At one point he referred to the "Prokes baby"

The foregoing is not in order. Some of it is, but I'm sure that some material is out of order. Since we talked about some issues more than once, the quotes may be out of chronological context but not out of substantive context.

Q-S (He introduced this as his last question, but the conversation continued about matters previously discussed.)

How do you feel about your daughters?

A We camehome feeling good about our daughters and what they are doing.

I spoke with Ramirez who indicated he wanted to talk with Mr. & Mrs. Leonard Datson, Verlina Hollins, Florida Johnson, concerning the possible crime committed by James MacElvane and James Jones - the crime being extortion. He said he couldn't wait until you were through with your murder case in Marin and the teacher to get a day or two recess so he could conduct his investigation in your presence. He said he would attempt to interview these people even though I had asked him not to and said those were your wishes. He said a Crime had been committed - when I pointed out to him there was only a possibility of a crime - he said he stood corrected. He said he has been receiving letters for a month from members of PT threatening him. I told him it couldn't have been us since we didn't even know he existed until Friday. He refused to tell me the content of the letters or the names of those who had written - and said "I know they are members". I asked him how he knew and he said he wasn't under any obligation to reveal his investigation to me. He asked for the name of the case in Marin and for the name of the judge we were before. I told him if he could stop the trial he sure had a lot of power. He went into the whole crime thing again and I said I thought it was silly to think of asking clients to give information concerning other clients. He kept referring to the Temple as a business and not a church - the business being run by Mac and Jones. I kept saying you represented the church on some occasions and some individuals within the church on others. I told him he was really interfering in a Civil litigation pending in the LA courts and he said he wasn't. I told him there was a counter suit filed against SToen the Medlocks attorney and he said it was of no concern of his -I was just confusing the issues of a commision of a crime. He indicated he would go ahead and I finally got him to promise to call you tonight at 6PM. He said he would do so before he went ahead. He suggested that you call the office and talk to just anyone on duty. I said does that mean the entire staff is aware of this case and he said "okay, I will call him."







I am in receipt of your letter dated August 27, 1971, written in behalf of the congregation of the People's Temple Christian Church, expressing deep concern over the senseless crimes committed against those in law enforcement and enclosing two checks for the families of the men recently killed in the line of duty.

I have received your letter expressing your views concerning the child custody dispute presently pending between Mr. and Mrs. Timothy O. Stoen of San Francisco and the Reverend Jim Jones, now in Guyana, South America.

On November 18, 1977, the Superior Court of the State of California in and for the City and County of San Francisco ordered this office to "...take all actions necessary to locate Reverend Jim Jones and to secure Reverend Jim Jones' compliance with his order ... " Paragraph 4 of the court's order states:

> "It is ordered that Reverend Jim Jones will immediately deliver the minor, JOHN VICTOR STOEN, to the Petitioner, GRACE LUCY STOEN, or to her authorized representative."

This office is now representing the Superior Court pursuant to Section 4604 of the California Civil Code. We still hope to be able to obtain the voluntary compliance of the Reverend Jim Jones with the court's order. Our role is that of attorney for the court and not as an advocate for either of the parties to this dispute.

Dear President Carter:

I am the Supervisor for District Five in the City of San Francisco. The Peoples Temple Christian Church is not located in my District, so I have no political ties or obligations to this church. I am writing to call an urgent concern of theirs to your attention. I am concerned at what I understand is the endorsement of some of our Congressmen for the efforts of Timothy Stoen against Rev. Jim Jones and the Peoples Temple. There are some facts I feel you should be informed of:

Rev. Jones is widely known in the minority communities here and elsewhere as a man of the highest character, who has undertaken constructive remedies for social problems which have been amazing in their scope and effectiveness. He is also highly regarded amongst church, labor, and civic leaders of a wide range of political persuasions. Our own Board of Supervisors has presented Rev. Jones with a Certificate of Honor, unanimously passed by all members, praising the church for its many projects "which have been so beneficial to all the citizens of the Bay Area." On the same occasion, he was also presented with a unanimously passed resolution by a Republican State Senator, Milton Marks representing that legislative body.

Timothy and Grace Stoen, the parties that are attempting to damage Rev. Jones' reputation, and seriously disrupt the life of his son, John, have both already been discredited in the news media here. The most widely-read columnist in the area, Herb Caen, printed Mr. Stoen's sworn testimony that John is not his child but rather Rev. Jones. Grace Stoen is reported involved in what could be considered a blackmail attempt against another leader in the minority community, Dennis Banks, reported in the two major dailies with her name also given in Mr. Banks' sworn affadavit about the attempt.

It is outrageous that Timothy Stoen could even think of flaunting this situation in front of our Congressmen with apparently bold-faced lies. I have learned in addition, that he has pressured these Congressmen towards unwitting compliance with promoting State Department intervention in the custody case now pending in Guyana.

Not only is the life of a child at stake, who presently has loving protective parents in Rev. and Mrs. Jones, but our official relations with Guyana could stand to be jeopardized, to the potentially great embarassment of our State Department.

Mr. President, the actions of Mr. Stoen need to be brought to a halt. It is offensive to most in the San Francisco community, and all those who know Rev. Jones to see this kind of an outrage taking place.

And that the nation-wide efforts that went into getting legislation passed to make right 400 hundred years of injustice, slavery, exploitation, torture and oppression, all this can well be in vain. This decision is an ominous sign that black, brown, Asians, Native Americans, and even poor whites, all of us of dolor, are being given a message that we are not wanted in the mainstrem of American life, that we are expendable! This decision is a major step toward setting up all Third World people for even HARSHER measures that would lead to the creation of a permanent state of economic, social and political obsolescence for us. And both recent and current events in the world have shown us what the next step could very well be.

Sam Yette in his book THE CHOICE tells us that it is theissue of The Bakke decision is part and parcel of what is survival itself. shaping up to be a conspiracy against poor and THIRD WORLDPEOPLES in this nation. And the conspiracy begins with the abridgement of civil rights, violation of tresties and promises, taking away of liberties that gives all people an insurane of humandignity and equality. It doesn't stop with student who have been given an unequal equality. It doesn't stop with student who have been given an unequal education, being refused admission into the establishment schools; it doesn't stop with taking the only chance deserving young people have ever had of realizing their potential. It will have further rammifications, you can be damn sure of that! It will affect equality in the fields of housing; its precedent can effect precedents in employment and in social services of every kind. It will keep the poor in bondage. It will keep the door shut. Andif it has been opened a few inches, the door will slam entirely shut! What was achieved in the streets, what was achieved in the lunchrooms, the achieved in the streets, what was achieved in the lunchrooms, the Drie theatres, the buses, and the halls of Congress in the 60s is now being systematically wiped out in the courts. Blaks, browns, Asians, our native americans people who have already been the victims of genocide, all Third World people, all the poor and disadvantaged are now being targeted. We are seeing America being divided into two nations: one affluent and one white; the other impoverished and non-white. The line is being drawn. And while 8000people—according to the paper this last week—are becoming poor, falling beneath the powerty level everyday in the United States of America. And those poverty level everyday in the United States of America. who are already poor are becoming poorer. The rest of the population is being brainwahsed to believe that things are going well, that everything is looking better. Look at your TV. Poor people can be starving, but we can get a TV. And the images of the affluent society are there to entertain us everyday, to persuate us that the American meam is being realized more than ever. But we know better, we arenot fooled.

My friends, we are facing the most ominous time in the coming years. The light of liberty could well be going out in the land-office greatest a most poerful land. Around the world, in nation after naton, you see the persecution of minorities. Torture is an epidemic. It has been made an institution, an official policy of government in some 60 nations around the world. So when we look at the Bakke decision, and I bet if you ask people on the street about it you won't find 1 in a 100 who is even aware of it, and if they were would most likely, probably not even give a damn. It has come to our attention that Tim Stoen has attempted to persudde you to use your influence regarding a custody dispute between him and members of Féoples Temple. The matter is being adjudicated by the Guyana court system, and we maintain that it would be unethical were any pressure or influence exercized on behalf of either of the parties in the dispute. It is for these reason that we ask you to resist any attempts by i.r. stoen or othe others representing him to induce you or members of your staff to interfere in the determination of this private matter.

have recently spoken with representatives from the U.S. State Department and the American Embassy in Guyana. They have insisted that their position is one of total neutrality. Acverthe less, Mr. Stoen has attempted to influence them to exert pressure on behalf of him and his wife. he has even some so far as to accuse members of Feoples Temple of crimes which he later admitted to U.S. officials were never committed.

You are no doubt aware oftthe background and circumstances in the case. If not, we refer you to Herb Caen's column of a few weeks ago. We are sure that after reading this material you will not wish to take a position in the matter. There are other factors in the case of which you may not be aware that would make it especially inappropriate for your office to attempt in any way to prejudice the Guyana court system. For one thing, Tim Stoen was openly insulting and condescending to local officials, stating that he did not trust the Guyanese to handle the matter fairly, behaving in a manner most unbecoming -- indeed, arrogant -- to anyone visiting a third world nation. Though unsuccessful, he was very likely (and still may be) attempting to provoke an international incident over the matter.

It is not for us to reflect here on what may be mr. Stown's motivations, except to say that they are assuredly less than honorable, and should he be successful in enlisting your aid in his dubious cause, it would --needless to say-- reflect poorly on the integrity of your office which, to date, has shown itself totally impartial and above-board in its handling of the entire Feoples Temple matter.

I am asking that our office in San Francisco enclose with my letter some material about the community here, which has been very highly praised by all who have visited as a model of co-operative living and constructive development. We are thoroughly fed up with the despicable attempts to portray this community in some quarters of the press as some type of dismal 'hard-labor' campt this has been done to provide a 'cover' for the kind of schemes which Tim Stoen and others have been pursuing. It amounts to a

tragic and cruel exercize that has almost made us ashamed to our many stands for press freedom. He are especially sorry about Tim, who for several years appeared to do an outstanding job on behalf of the people we serve, but who is evidently under some kind of pressure or fear for his professional reputation —we don't profess to understand the complexity of the forces and the personal morass that have caused him to participate in a desperate and reprehensible scheme, and to enlist the help of others in positions of responsibility.

The undersigned, being first duly sworn, deposes and says:

My name is James R. Randolph. I am 37 years old and I live in the city of San Francisco.

I telephoned Mr. Frank Garmendia this morning, September 29, 1977, at a few minutes till 8:90 am. (I know the time because I was watching it to be sure to get the lower long distance rate.) Mr. Garmendia is a freight forwarder for SOPAC Transport Corp. in Miami, Florida, the intermediary who receives and reroutes our ocean freight bound for Guyana, South America.

Some of the details are as follows:

Mr. Garmendia said "I didn't want to bother you with it before, but now that it is over, I can tell you. Seven Customs men held up the cargo (referring to our last shipment which sailed, I believe, August 29, 1977.)" They pulled one case at random and checked the contents of it. " This occured right about the time scheduled for the cargo so be loaded. I believe inspection took place on the dock rather than at the warehouse.

I asked if this was standard procedure and he replied that it is not. He went on to state that some of them were from the West Coast. When I asked if he said they were from the West Coast, he said, i "Well, from out of town. They were not the regular Customs men I see around here. They wore civilian clothes and had Customs Agents' identification."

By way of explanation he said someone may have given them the idea that there were arms or drugs in our shipment and once they have been given such a report they are obliged to check it out. He went on to explain that as Coustoms officials they have the authority to open and inspect any part of a shipment.

He said they got a copy of the Bill of Lading (actually a packing list, much briefer than a Bill of Lading) and compared it against the contents of the crate they opened but that they didn't find what they were looking for. I am not clear as to whether they got it from him or from someone else in his office. He said they told him "upstain is" (referring to his superiors) "Don't bother them. They're Customs." He said they

were done in a few hours and didn't actually hold up shipment.

Mr. Garmendia also said big companies have big shipments in and out all the time and it would be possible for someone to put something in a shipment and get it out again at its destination withour the company knowing about it, implying that could happen with our cargo and could thus have caused a report to be made to Customs.

When he mendioned the charge might have been made that we are shipping arms, I told him we would be the last people in the world to ship such things.



Dear Sir:

On November 18, 1977, the Superior Court of the State of California ordered our office to "take all actions necessary to locate Reverend Jim Jones and to secure Reverend Jim Jones' compliance with this order." Paragraph 4 of the order (a copy attached) states:

> "It is ordered that Reverend Jim Jones will immediately deliver the minor, JOHN VICTOR STOEN, to the Petitioner, GRACE LUCY STOEN, or to her authorized representative."

According to our information, the underlying facts are that Rev. Jim Jones, a United States citizen, is living in Guyana, South America, where he is exercising physical custody over John Victor Stoen, a 5-year old child who is also a United States citizen. Rev. Jones has refused to deliver the child to his legal parents, each of whom testified before the court and joined the request for the order issued. Our office is representing the court pursuant to Section 4700(c) of the California Civil Code.

We are respectfully asking you to use whatever influence you have to help us obtain Rev. Jones' compliance with the aforesaid order. If we cannot obtain Rev.
