PLEASE, PLEASE have them buy a bunch of small odd colored suitcases that will go under plane seats, and brink the hand written paperwork into Georgetown TOPSIDE on the airplane when you send the busload.

They should be marshalled, and none allowed to lay them down for a moment..none going to rest room alone..going straight on the plane with the cases...If underside, they can be transferred to wrong planes, etc.

- what was being planned against the church admitted that he there was going to be a march (this is when the so called concerned parents (came to the back gate in protest). Louise had told Joe that she was not going to be in the march, but she was.
- 6. Joe was asked was he ready to go to the F.L.. Joe stated that he he would be ready to go in October. The question was asked of Joe would he be ready to leave this Friday. Joe responded No.

 Question why not? HE Hesistated for a long time, then responded had things to take care of. We told Joe that we would help him with whatever he needed taken care of, but he was still hesistant.

I feel that it is my duty to share these thoughts with you. About an hour ago Lisa Layton said she wanted to speak with me. She said that after the white night she felt a kind of angry feeling inside, she felt furious. She felt that she'd "been had." Deceived. She felt that she couldn't write it up to you becuase you had so much on you. She said that she felt the information given to the congregation was inaccummete and incomplete, and that she couldn't make a decision based upon it, but was being asked to. \$\frac{x}{2}\$ told her that we had to look at the situation in terms of the worst of the possibilities, and that Dad always did this as part of his duty to the collective. Also that we often cannot expect that we will have perfect intelligence on everything that is going on —we might have to make calculated determinations on what's available. I think she felt better after we talked for about five minutes. She said so, anyway.

I feel that Lisa's reaction is a danger sign. I personally did not know all of the details, but my feeling was very definite that we were being texted on our collective and individual determination and willingness to die. But this time, I felt that the kind of necessary collective testing didn't quite ring come across authentic. Most people again tried to sense which way the wind was blowing, and 'voted' that way. My apprehension is that among the Lisa Layton-Marlene Wheeler-Jann Gurvich segment of our community, in other words, people with a fair degree of savvy and intelligence, there is going to be a feeling from now on that the white night is really a kind of elaborate ritual testing. Already the same format has been followed too often -- we go through the test, take a 'vote' and the right and whong sides of the vote are pretty much felt by the fact that those voting against immediate 'revolutionary suicide' are subject to questioning that contains within it a not-so-subtle intimidation that they are either cowards or disloyal or too attached to living.

This, I feel, is going to undermine the respect people have for the white night situation -- it's going to breed cynicism about it, and its going to ultimately lead people to harbor criticism about you. It may even jeopardize the whole proceedings of vote-taking, so that it no longer is an index to what people feel (if it ever was) but something else.

I don't know quite what to say about it as an answer. I just feel a little ominous about it, that the procedure will be counter-productive and breed distrust of you and less than total crdultity of your motivations. When that happens, I don't know what to say. I also feel that a bad point of the evening is when Steven verbally attacked you. I can personally understand and empathize x, and don't mean at all to be critical of Steven -- in a way it's good that he be able to attack you purely from the psychological necessity of any young man to work out his Oedipus complex. But not in public.

I am sure you have had a lot weighing on you concerning the above matters and \pm I surely am in no position to presume to be able to advise. I've written this out of what I feel is a duty and responsibility. I think that other white nights strengthened this organization. I don't really know if this one did.



GUARDIANSHIP PROPOSALS:

SB JICSON

Due to the new legislation beginning July 77- guardianships will have to be reviewed every year by the Judge. This changes our previous stance that we felt we should get court appointed guardianships in every case possible. Gene now suggests that we push to terminate every existing guardianship a that we can and ask the parents to sign permission for the kids to go to PL. with whoever was keeping them.

This way we would only have to have parents permission and not the courts. (Parents are asked their permission in guardianship matters and if parents disagree an investigation - contest is conducted which of course would not be to our benefit housing-wise etc.)

If we follow the course of asking the courts permission to take children to the PL. we are back where we started from in that we have 10-15 workers all located om the 10th floor of the Flood Building-S.F. SB feels that we don't want to do this at any cost-since (1) all these separate workers will have to get their supervisors approval (and think this is the same person- not sure) (2) they will be tipped off as to the common denominator of So. America- PT etc.

Sb is inclined instead— to cont. with the individual guardianship operation since the possibility of all these separate workers getting together and discussing the recent influx of guardianship requests etc. in more remote. Then when the yearly review comes up next year— the guardian can write to the worker saying that they are now on a missionary duty in So. America and request the guardianship be renewed. If the court wants to see the child etc.— the guardian has no 'funds' with which to make the trip back to U.S. at that time— does the court wish to send the money? (of course not.)

At this point- even if the parents object- what are their alternatives to effectively get their child back if they don't want to come? Gene feels that the possibility of child stealing charges at that point in time is remote.

As is the chance of the court pushing its jurisdiction beyond national boundaries in these cases...

However, in cases- such as Arterberry- where the worker advised against guardishship due to the fact that she thought Clarence Moore's father would object- we have in that case petitioned the court to give Naomi permission to take the children to Guyana. This met with approval from the worker and she felt it would be no problem with the court (going to court the end of May). SB suggests that we only ask the worker about the possiblity of court permission to take children to So. America- when guardianship is not feasible. (as it is not in all cases due to different circumstances).

SB also feels that if we follow the existing course of doing guardianships where possible that we cont. to push the process as it usually takes 5-6 weeks to have the matter placed on the court calandar. (even for course approved such as Arterbury case).



RE: THE FBI AND JIM JONES

The following discussion of the intense interest of the Federal Bureau of Investigation in the activities of one of the most progressive civil rights leaders in the United States (and a dedicated socialist) is by no means intended to be an indictment of the United States government or of the President, but rather another instance of the already well-known and highly-publicized excesses of the U.S. intelligence community, which has practically set itself up as a national and international policing agency to crush progressive, civil rights, and socialist leaders and organizations, even going so far as to finance and otherwise equip personnel to destabilize and overthrow leftist governments, as in Chile.

Jim Jones is only one of many who have worked for peace, social justice, and civil rights in the United States who have been monitored, harassed, and even persecuted by agencies within the intelligence community. Perhaps the most notable figure who was doubtlestly destroyed by this most vicious aspect of the U.S. intelligence establishment is Dr. Martin Luther King. The efforts against him have been exhaustively documented, as I am sure you are aware, in the revelations of the FBI's COINTELPRO operation, which also attempted to decimate the Socialist Workers Party in the USA. The U.S. Attorney-General has recently refused, in this latter situation, to turn over the files which are vital to litigation against the FBI and, in so acting, has risked a citation for contempt of court. [2-] We want to make it clear that the right wing excesses of the U.S. intelligence community do not necessarily reflect upon

with Mrs. Rosalynn Carter at a dinner engagement some months before coming to Guyana, and she seemed favorably inclined to Rev. Jones' suggestion that the U.S. send medical supplies to Cuba, and wrote to him (letter enclosed) in a supportive vein. Our concern is about right-wing trends in the United States which can be detected within government agencies, and which have been widely discussed and remarked upon even in the major news media (i.e., Newsweek magazine). Not surprisingly, the FBI director himself, William Webster, recently admitted that he was a member of four racist organizations. Congress did not require him to drop his affiliations for confirmation of his post.

We wish to decument here a few examples of evidence that the FBI has maintained an interest in Jim Jones for nearly thirty years, while at the same time officially denying that they have had any interest in him at all. When Jim Jones made application to see the contents of his FBI files in accordance with his privileges under the Freedom of Information Act, the FBI actually claimed that they kept no file on him. This astounding claim must be weighed against the evidence which follows.

During the 1950's, a current member of Peoples Temple, Mr. Charles Touchette (now farm manager at the Agricultural Project) was hostile toward Jim Jones because his entire family had decided to join Peoples Temple, a militantly civil rights and fully integrated organization. At the time Mr Touchette was anti-socialist and racist. He called the FBI to investigate us, speculating that Jim Jones was "in with the communists" (a catch-phrase in those days, now being revived in the neo-McCarthyi'te atmosphere in the United States). Mr. Touchette's report prompted investigators to interrogate members of Peoples Temple. One of these was an elderly woman who had been given a home by Jim Jones when she was unable to support herself, without even a Social Security check. She was queried extensively: 'Did Jim Jones

buy you clothes?"'Did he buy you the hose you are wearing?" 'Is Jim Jones a member of the NAACP?' 'Is Jim Jones a communist?' (We note that Mr. Touchette has for many years been a devoted member of Peoples Temple, and has renounced his former views, and is today a staunch integrationist. His total acceptance into Peoples Temple even after he tried to get the FBI to destroy Jim Jones is a reflection on the kind of character that Jim Jones has. The woman in question who was interrogated, Mrs. Muller, was in her 60's at the time and is now approaching 80, residing here in Guyana.)

Later, after Jim Jones moved from the Midwest (where the above incidents took place) to Ukiah, California in the mid-1960's, the Chief of Police of that town informed Jim Jones that the FBI had compiled a long list of his activities, in conjunction with local police anti-subversive units (called 'red squads' in those days). The Ukian chief, though holding right-wing views, admired Jim Jones and his church members for their good citizenship, and his efforts to rehabilitate young people and care for the elderly, as well as his emphasis on law-abiding behavior. The chief, in addition, did not feel that the FBI should have any control over local police departments. This, we speculate, is what prompted him to disclose the above information to Jim Jones, which is at total variance with the denial of the FBI that any files have been kept on him. It is also probably the case that, although this police chief had become friendly to Peoples Temple, he would not be so disposed today, in view of the resurgence of racist and right-wing attitudes in US society.

Another important clue that we have come upon revealing FBI monitoring and activity to discredit and destroy Jim Jones, concerns a report from a Midwestern journalist, Mrs. Caroline Pickering, to the effect that the FBI and San Francisco police conspired to instigate a series of smear-type stories about Jim Jones in 1972, using a racist journalist who has since been exposed as working for U.S. corporate interests in South Africa. The action against Jim Jones was prompted by the church

donating a large sum to the defense of Angela Davis and other civil rights and black activists who were in no way socialists or Marxist-Leninists. (Note: Mrs. Pickering is currently married to a right-wing judge, and would probably not repeat this information to anyone representing us: the comment was made when she was talking with a person whom she thought shared her views. We have not been able, unfortunately, to locate the names of the FBI agent and police officials in our files, though a complaint was filed at the time.)

Another indication that the FBI has had an interest in Jim Jones happened in the mid-1960's when he applied for a visa to visit the Soviet Union as part of a projected trip to several European countries. Several weeks after making the visa application, Jim Jones was contacted by the FBI and searchingly interrogated as to why he wanted to visit the Soviet Union. (Jim Jones replied that he thought he had the right to travel as an American citizen). Even though this was long after the McCarthy Era, and many people were visiting the Soviet Union, the FBI insisted on questioning him. (Note: Jim Jones was unable to carry out his travel plans because of arrangements concerning moving with his family to California).

On yet another occasion, famous Washington columnist Drew Pearson, who had revealed much corruption in US foreign affairs, was planning to visit Jim Jones because of support and encouragement that he and members of Peoples Temple had consistently given to Pearson when he stuck his neck out to reveal various unsavory practices in the US government both at home and abroad. Pearson, who was to pass away soon after had lost a major network radio broadcast and even was close to losing his nationally-syndicated column. Pearson was also at one time brutally attacked in a restaurant by none other than Senator Joe McCarthy. Pearson never got to visit Jim Jones, but he wanted him to know that "the FBI was after him" (Jones).

In the early 1950's, during the McCarthy period, Jim Jones went to see Paul Robeson, in Chicago, The FBI learned of this (and could have only learned of it through a telephone wire-tap)

and subsequently interrogated Rev. Jones' mother for seven hours. Mrs. Jones knew that her son was a good person, but she was not at all aware of his socialist ideology and she thought that her son was 'crazy' to be involved with it — a typical attitude of many people, even with progressive ideas, in that period of intense anti-communist propaganda and the climate of fear and intimidation that went along with it. Mrs. Jones absolutely refused to tell her interrogatoers anything. She was questioned at her place of employment where she was a shop stewardess in her union, and lost her position as a result. Later, Mrs. Jones became a devoted socialist and died here in Guyana, where she enjoyed the happiest months of her life.

The very recent series of concertedeefforts that have been directed against the work of Jim Jones was perhaps touched off by an incident in late 1976, when a high-ranking military intelligence surveillance team was discovered spying on a Peoples Temple meeting in San Francisco, where the black mayor of Mayersville, Mississippi, Mrs. Unita Wright, was speaking about places she had visited. Our personnel checked the license plate of the car that the men had arrived in, and traced it through the District Attorney lafter much probing and difficulty) to an Air Force Base in Biloxi, Mississippi. Further investigation confirmed that they were receiving their instructions from a racist, reactionary U.S. Senator, John Stennis. The Air Force denied that these individuals were in our area at all. Congressmen who we asked to help in exploring this matter further could get nowhere. And a prominent editor in one of the major establishment newspapers in San Francisco told us that "this time you have gone too far." Nobody would touch the story, except for the president of the black press, /a friend of Jim Jones who should be visiting here soon. It was only two days after this story was released to the press that (we later learned) a group of people who were conspiring to discredit Jim Jones began to co-ordinate their activities with the aid of a prominent public relations outfit. We would discover later that one of their tactics would be to use people who had left our organization to 'bait' the media with ridiculous stories about Peoples Temple. The people involved had both ultra-right backgrounds along with some

who were part of an anarchist/Trotskyite group that advocated irresponsible activities and courses of violence in total contradiction with our beliefs. We now have good reason to believe that their insane, 'revolutionary' schemes were advanced as a provocative ruse, as has been done with other groups advocating social change.

There are other incidents. But the above highlights, we feel, amply illustrate that there has been a continuing effort on the part of the FBI to undermine, thwart, discredit, and ultimately destroy Jim Jones and Peoples Temple, an effort that is not at all inconsistent with the shameful activities that have been catalogued with respect to many groups and principled leaders who have been attempting to work for constructive social change in the United States. We also note that the CIA has similarly denied that any files are maintained on Jim Jones — a curious statement in view of the fact that it has released material it has kept on several members of Peoples Temple.

At this point, we would like to bring up some related considerations that will help put the foregoing into a wider perspective.

As we have noted, the intense campaign to impugn the reputation of Jim Jones, smear his character, and sow discord about his work, is nothing new to the progressive community in the United States. Many leaders and organizations working for social change have been similarly victimized.

Community and civil rights activists who know of the work of Jim Jones and Peoples Temple intimately, have remained staunch supporters. These are people of all races and varying political persuasions. We cite just a few of the more notable examples:

--Mr. Robert Gnaizda, Director of Public Advocates, Inc., an important legal collective that has exposed much corruption in government, is a strong supporter. Mr. Gnaizda, incidentally, was a key aide to California Governor Edmund Brown, Jr.

--California's Lieutenant Governor and former Congressman Mervyn Dymally has been a close friend. Mr. Dymally, a native West Indian, has visited the Agricultural Project, and has published a book through Peoples Temple documenting a national conspiracy to harass and ruin hundreds of black elected officials, himself included;

[--Progressive California State Assemblyman Willie Brown;

--Dr. Carlton Goodlett, M.D. and Ph.D., President of the NNPA (which is the major black press association in the U.S.), who has publicly and repeatedly denounced the efforts against Jim Jones;

--Mr. Thomas Fleming, editor of the largest Afrò-American newspaper in the San Francisco Bay Area;

-- Jane Fonda, internationally-acclaimed actress;

--Angela Davis, rights activist; (Note: Ms. Davis has been very supportive of our position here and asherisoirry muchraware nigroup support of the government)

--John Maher, nationally-known for his rehabilitation work with ex-convicts, and who currently has his own ABC-TV program. Maher has offered his assistance to Peoples Temple in locating a doctor to help get a local Guyanese child here in the North West Region a corneal transplant operation that will save his vision. Incidentally, Mr. Maher, in order to 'survive' in a climate prejudicial to the collective lifestyle of his prison-rehabilitation foundation, has had to moderate his views in public, something that Jim Jones refused to do, and which helps explain the kinds of attacks to which he has been subjected;

--Other local supporters, which include longtime civil rights activists Enola Maxwell and Yvonne Golden (Ms. Golden is President of the San Francisco Black Teachers Caucus); author Albert Kahn (whose works are among the most translated of any American writer); organizations such as the Women's International League for Peace and Freedom (WILPF), the World Peace Council, and the NAACP; the head of the San Francisco Council of Churches; members of the San Francisco Human Rights Commission, and many progressive clergymen.

All of these people, and many more, have been outraged by the despicable use of false witnesses to air monstrous lies about Peoples Temple. The entire catalogue of media-sponsored stratagems and bogus investigations are already well-known and have shocked many people. Those who have followed the campaign against our movement have concurred with our profound dissatisfaction that the U.S. Embassy here was unable to prevent a

young woman from walking out of Guyana with several thousands of dollars she stole from elderly people here in our community, and who subsequently proceeded to cover her crime by shamelessly lying to the press about the nature of our community. There was nothing we could do about it. Our refutations were only marginally covered in a prejudiced media — a typical pattern. We cannot afford, in addition, to become encumbered any further with libel actions which would require that we send witnesses back to the United States to testify.

We recommend, to put all of the foregoing into perspective, that you see the recent issue of Ebony magazine where extensive, quasi-genocidal efforts are exposed that seek to destroy all black elected officials. A similar expose aslo appreared in Sepia magazine a few months ago in an article by Mary Warner, excerpted from a volume printed through Peoples Temple. The extensive list of targeted individuals includes Rep. Charles Diggs (founder of the Congressional Black Caucus), Senator Edward Brooke (the only black U.S. Senator since the Reconstruction Era), and moderate civil rights leader Jesse Jackson of Operation PUSH (who at one time, it has been suggested, even gave information to the FBI, along with Roy Wilkins, about Dr. Martin Luther King).

All of this is mightmarish, and is producing a neo-McCarthyite climate of fear in the United States that is stifling dissent and decimating any vestiges of forthright black leadership in the wake of successful right-wing efforts to cut back important programs for minority and poor people, and other key civil rights gains in many areas of U.S. society.

We are also alarmed and disturbed -- as is a large segment of the American public -- at the actions of President Carter in backing down from what had promised to be a progressive administration. We don!t believe that Mr. Carter is a hypocrite. We can only speculate that there have been some enormous pressures brought to bear upon him, and that these are perhaps related to the selective assasinations of the 1960's of several progressive leaders (the

conspiratorial nature of which is now being investigated and exposed, revealing high-level complicity).

The effect of this is quickly clarifying who rules America -- and who in fact dictates the policies of government: a super-rich military/industrial complex, run by a corporate oligarchy. This kind of pressure has extended into all areas of government, especially the U.S. Congress, which has recommended courses of action (such as breaking relations with Cuba) that have even shocked State Department officials. Another disturbing sign was the frustration experienced by former Watergate Chief Prosecutor Leon Jaworski, who was assigned to investigate U.S. Congress payoff-taking from KCIA go-betweens. Jaworski concluded that the investigation he was to carry out was really only designed to make it appear that the government was policing corruption in its ranks, becuase when he seriously began to get at the roots of the situation, he was rebuffed, and was himself investigated, and had to curtail his efforts. Similar things happened during the Church Committee investigations of the U.S. intelligence community.

We could cite much more evidence that points to the resurgence of a right-wing, fascist-like mentality so frightening that hundreds of people -- many of whom we do not even know -- who have heard of our work here are expressing a desire to join us. Many of these are people who express a sense of alienation and lack of personal fulfillment, bred by an advanced technological state that looks upon human beings, increasingly, as mere commodities, and which is losing touch with the needs of millions of people.

A final note in this vein that is particularly chilling: we know a young man in the US Air Force whose mother is residing here in our community. He tells her that people in the military have a joke about the neutron bomb. They call it the 'nigger bomb,' referring to its projected, special tactical use on black ghettos

to wipe out the population while saving the property, adding that it will be sent to South Africa for the same purpose.

Our purpose in providing you with this information has not been, again, to cast aspersions on the United States, but to illustrate the kind of activity which has worked to undermine progressive movements. The reactionary and right-wing currents within U.S. society can work to undermine, additionally, our quest for international co-operation and peace. These issues have troubled millions of people of conscience in the United States, including many people in all areas of government.

On the morning of 11/5, Hue Fortson was a featured speaker in Oakland at slides. The members of this this humanist fellowship church. Hue took church are affiliated with the Holland Roberts Institute, through Andy, P.T. was invited to this church to explain to the membership what P.T. was all about, both here and in Guyana. There was some question and answers but because the slides took up so much of the time, the questions were minimal. However, one man approached HUE and inquired about the relationship between Jonestown, Burnham, Chagen . He went on to say that he spent some time in Guyana mining Diamonds but ran out of money so he returned to the U.S. By in large through, I think the impression that was left with the small group was positive. One lady asked about the monetary system in Jonestown. Hue explained that folks had money but there was no monetaru exchange neressary due to the collective lifestyle. She talked about slave labor camps. I do think though; that the slides told the complete story about Jonestown.

According to the minister of this church the congregation was a mixture of old leftists, union members, socialists and communists. He considered himself a communist. He wanted to know what our affiliation was with Glide, and it seems like I here that question a lot. I told him none. He then elaborated about Cecil Williams which was quite unfavorable.

On Thursday November 9, 1978 a group of us will go to Sproul Hall to hear Angela Davis speak.

Last Friday, Oct. 31, 1978 HUE, GUY, AnDY and MYSELF went to a fundraiser for Yvonne Burke, who is running for Atty. General of California. Yvonne did not show nor did Dymally, but Andrew Young did show. We talked with him twice. Once was very brief, too many folks around. On the second attempt, Hue asked for his autograph while I talked in his ear. I told him about the project and the reputation it is receiving from visitors around the world and that as UN.ambassador he should see the project for himself. He promised that whenever he was in the carribean, specifically, Guyana, he would drop in on the project. He said he would like to see it.

Andrew Young's speech was somber, dismaly and an attack on the black middle class. He talked about the systematic oppression of minorities and the systematic exclusion of minorities from the mainstream of economic, political life. He spoke about conservatism and the move towards racism as oppose to one world government.

while I was speaking to Andrew Young, a woman over heard my comments about Jonestown, and later asked to speak with us about the project. It seems as though this woman had been to Guyana and was familiar with the land lease program of Prime Minister Burhham. She spoke of a group who presently reside in the bush, originally from the U.S., who received mail from sourounding villagers and citizens of Georgetown who want to know what is happening in Jonestown.

According to this women, who's name I will have to forward later, she has been sending copies of articles clipped from papers here in America. We invited here to the church to see the slides. She was eager to come, she did say that she wasn't guarantseing that she would be convinced by what we had to say to her.

He said he knew little about P.T. other than what he had been told by Billy Hunter and read in the newspaper. He did say that he had heard that J.J. was a very good man. 



This is a start anyway. I'm hopeful about having more time soon —in two weeks, I'll get two weeks vacation time, and can tackle this better, plus catch up on other things. These mass letter—writing projects are very time—consuming; I wind up writing most of the drafts myself, and we distribute in service, right in the auditorium, to make sure everyone writes. It's more work in one sense, but has become the most expedient way of getting it done, rather than assigning, waiting, prodding, feeding ideas, re—working drafts, clearing, the whole mess. Everyone writes, including the older children; and whoever can't write has someone write for them, plus their own. We're going to draw on some additional lists too, for names; I don't see where we have much option.

A child who volunteers to help on letter-writing projects regularly, incidentally, and works very well, is Amanda Brown, one of Roseana Dickerson's grandchildren. She was the one who was sent back down South over a year back when she tried to burn down the girls' restroom at school. She's very sweet when she has something constructive to do; and I wanted to put in a good word for her because Roseana's nasty to her from what I can see, tears her down, and the child's really trying. Anhara Alexander (Jim Alexander's daughter) is also very helpful.

I contacted Joanne Molloy, she's still extremely positive, and was thrilled to have an open invitation to visit. The Northern California Alliance, the group she's been working with, is all split up now, and "Common Sense" has come out for the last time. The Black Panther Paper just folded too.

Jane Fonda didn't win the Oscar for "Julia", but Vanessa Redgrave did (supporting actress) -- I think she's a better actress anyway, more genuine. Redgrave made a nice speech (in news articles enclosed) for which she was hissed and booed; but she was in fact picketed by the JDL, PLO, and the Nazis all at once, with threats for many weeks ahead. The JDL burned her in effigy in front of the Academy, Allen Vincent told newsmen "I was just demonstrating for the white race when 'a bunch of animals' came up from behind and attacked me". The jet set crowd should have at least appreciated that she had the guts to show --she could have been assasinated in a melee like that--, but of course they didn't.

Re-sent our "600" packet to those who didn't return receipts yet --three out of five were from the State Dept (Vance did receive, the others no confirmation), and will give IRS a few more days, no receipt back from them either. Sent out amended QSL list to those to whom we already sent the wrong one only. Also got the packet out to HEW.

Some more clippings enclosed, pretty much caught up now. Note Carter is about to stop neutron bomb production, but the pressures against him are pretty stiff, and nothing defeinite has been announced. It looks like it could go either way.

Regarding what goes to the International Human Rights Commission, what to the press, communications were schizophrenic on that at best, and I assure you I had not been told you cleared that and wanted it out right away. I was first told to go through the (idiotic string of) lies and meticulously refute them point-by-point, to go to the Commission. Then Jim Randolph told me Teri said keep working on it, but something was being done over there simultaneously, which I could use word-for-word instead of what I was writing. I assumed what was being written over there would either greatly clarify what I was about, or could mesh right in, or I could make a direct substitution. But what finally came over, the thing Tropp wrote (sounded like Tropp anyway), was the opposite of a point-by-point refutation! The only word I got about sending anything to the press was along with the notes on what to send to the Commission, so I could only assume it; was one and the same letter. Tropp's letter never got past pencil notes, today, as according to what anyone understood from the radio its use was "optional", and the off-hand impression of Jean, Tom, and me was that it was "bad" -- I mean "bad" in the sense of sophmoric, overdone, snide. But I'm editing out the "Tropp trips" now, and it will get out.

One lesson well-learned: I'll be checking out questions myself on the radio so far as possible. It's not that anyone else's word is not reliable, but it just seems a milt-in liability that "radio" can get to be more like "telephone"— the final product becoming more distorted the more people it goes through.

One thing over the radio though I resented highly, and I want it conveyed to Lee: Teri was clarifying what was to be done about the Commission letter I was working on, and I was acknowledging; then Lee steps in just to say, "Do it." There was absolutely no need for a "man" to step in with "the final word", when Teri was handling all the instructions perfectly well. Why doesn't he do all the nitty-gritty of deciphering instructions and laborious secretarial work, like Teri and other sisters have always done, before he presumes to step in with "the authority trip"? If it weren't that it was your authority (in terms of your wanting something done) that he was talking about, I wanted to tell him where the hell to get off. And people do that, too: choose a time to back up you to make themselves look a little stronger. Your authority I respect, but his I don't. That's just chauvinistic "bullying", no more, no less. He came off looking weaker, not stronger. He insulted both Teri and me, and was using you. Sorry, I'm in one of my more "straightforward" moods, you might note: But it's really worth asking in these instances, if the great "authority figure" knows what the issue is! They generally don't; the "trip" generally supercedes the issue, or the responsibility, by far.

Well back to this letter to the Commission: I was surprised myself, we were taking on "charges" point-by-point, but I just figured it was so riddled with lies, blatant lies, that we could almost stand to gain, especially as the COmmission had presumably read the outrageous document anyway. It could help to come across as thoroughly rational beings who are obviously in stark contrast to lying, devious reprobates. That's very easy to get across, just give the facts! And that crazy Crawford bitch, after they get her to perjure herself 16 times over, she winds up working at Macy's...

Anyway, this WASN'T the final version, only one person had had a chance to go through it all, Leona, who is an excellent critic on a pragmatic score, I found. That's one good thing, anyway, that came out of the meeting after you talked with us all over the radio. Leona was upset because she said the other long letter to Carter sounded like "true confessions" and accused me of not being responsive enough to her criticisms. So we spent several hours together over this thing, and got subtle frictions worked out in the process. I like Leona. I think she does have some racial paranoias, but who wouldn't? I respect her a hell of alot more than people who never speak what's on their mind.

You'll all find alot wrong with this draft to the Commission, I'm sure! I had lots of unanswered questions, but the format, the approach I think is pretty solid, if we'do in fact want to do this kind of thing. It was tedious, but not as hard as I expected, it's filled with abominable lies and transparent subterfuge.

On the assignment to write the Consulate, we got a total of 435 (letters and telegrams) out to the Consulate in L.A.; and the same to New York and Washington but almost entire copies, which isn't an entirely effective way of doing things. Plus 179 more letters to Kurtz, and 128 to Carter re IRS.

Re the enclosed letter to Jerome Kurtz: written because of the threat made about "May 1st" to the Disciples, thought they should get something from us officially on it before that date, so we could say "we told you so" if we need to.

The enclosed letter from Sen. Sparkman just received by several. He was one we wrote months ago, nothing recent, and never got any response until now, so it looks like it really is a current concern, not just a response to a letter. Should we be swamping him with letters again?

Follow-up letter re Mazor enclosed too. And a copy of the current form letter from the State Department being sent to several.

Re my job: I'm making the request again. These reports aregoing in early, so no time to detail. But I would not ask without very sufficient reason. Your speculations about "very soon" are kind, but meaningless. I'll remain here as long as I'm needed, at least this always been and remains my intent, and everyone knows that is entirely unpredictable. All I want is conditions under which I can effectively function now.

Last week when I searched the file cabinets Evelyn's mother left behind to find income tax returns for people overseas as well as here, I found the contents of the safe that used to be in accounting, which we thought had been transported over there. Mildred radioed this over already. Martha suggested I should write up this report on it also. The contents of the safe were in a cardboard box sitting on top of the file cabinets, open. In the box were all the original deeds, wills, some statements of former members, and a binder, which contained coded minutes of old counseling sessions for meetings. I remember a year ago or so, when Frances and Bea did the minutes, there was confusion over a missing binder that failed to turn up when Frances turned in the minutes to Bea one night. Eventually it was assumed that Frances had lost the binder, and I think she was heavily confronted on it by Evelyn's mother and possibly Bea. After that, all the binders that were left were eventually burned. I am wondering if this is the missing binder. The time covered in this binder seems to be between February 1977 and May 1977, and there are also old pages that are interfiled, dating back to 1976, giving histories on people who were on the floor. If this is the missing binder, we don't know how it got to where it was found, but we will refrain telling Frances or anyone else besides Mildred, Rex, Martha and me who know because we are afrad that considering the past history of confrontation and blaming of Frances, it would be demoralizing at this point for Frances and not important to know anymore anyhow.

If you think it's worth it, you might consider asking Evelyn's mother or Ed why the box wasleft in the room and why this binder was in with the rest of the stuff. However, at this point, we are just thankful that it was found. Security at this point also is irrelevant, since mone of the file cabinets left behind by Evelyn's mother in the room where Lee and Jack stored them can be locked; Evelyn's mother took all the keys with her.


