a) bitterness of the meat - she had it already figured out that it came from the breadboard before I got there to talk to her - her main mistake was showing us the foil the meat was cooked in and tasting the juice which proved the poison was put in after cooking & bringing it inside the kitchen - since it could only have been she or the security guards who messed with the meat then I doubted security. She figured we would doubt her and then so it was set up by the breadboard that there was no poison - (I did however get terrible headache & diarrhea - to substantiate the poison)

② 1/11/78 milkshake #1 - Joyce said to Mary Lou "Be sure to have him drink it soon or it won't be any good" She never said this before that I know of. She says this to her daily people however, to get them to drink it before the crushed powder or pills sediments to the bottom.

③ 1/11/78 Milkshake #2 - Joyce T. told Agnes to say "It won't be as rich this time it's made with powdered milk" - This is a cover for sediment left on the side of the container. I taught Joyce that line when we made Lovie Jean some milk.

- ⑤ Shifty eyes when talking about poisoning - looks guilty. Appeared hostilely guilty later in evening after Jim was not dead from all this batch of three milkshakes. Jim said she looked shocked to see him when he walked up on the podium.

Joe Ames had been seen by Leona, Maxine, McElvane, and others at the march today in front of the Federal Bldg, but was not participating, but an on looker. The following questions were asked of Joe:

1. Joe Ames had been told by Louise Blanchard, a former member, who is now marching in protest against the church, that Tim Stone said that Jim had ten million dollars.
2. Joe claims he didn't know Louise Blanchard was talking negatively about the church. Joe had to be asked repeatedly what was he told by Louise.
3. Louise Blanchard told Joe that Mary Griffin's husband was beaten in the F.L.
4. Joe has been talking to Leon Boussard. He had stated to Leon that there had not been any healings in the church of late.
5. Joe after being asked numerous times what else did he know about what was being planned against the church admitted that he ^{KNOW} there was going to be a march (this is when the so called concerned parents (came to the back gate in protest). Louise had told Joe that she was not going to be in the march, but she was.
6. Joe was asked was he ready to go to the F.L. . Joe stated that he he would be ready to go in October. The question was asked of Joe would he be ready to leave this Friday. Joe responded No. Question why not? ^{HE} Hesitated for a long time, then responded ^{HE} had things to take care of. I feel that it is my duty to share these thoughts with you. About an hour ago Lisa Layton said she wanted to speak with me. She said that after the white night she felt a kind of angry feeling inside, she felt furious. She felt that she'd "been had." Deceived. She felt that she couldn't write it up to you because you had so much on you. She said that she felt the information given to the congregation was inaccurate and incomplete, and that she couldn't make a decision based upon it, but was being asked to. I told her that we had to look at the situation in terms of the worst of the possibilities, and that Dad always did this as part of his duty to the collective. Also that we often cannot expect that we will have perfect intelligence on everything that is going on -- we might have to make calculated determinations on what's available. I think she felt better after we talked for about five minutes. She said so, anyway.

I feel that Lisa's reaction is a danger sign. I personally did not know all of the details, but my feeling was very definite that we were being tested on our collective and individual determination and willingness to die. But this time, I felt that the kind of necessary collective testing didn't quite ~~ring~~ come across authentic. Most people again tried to sense which way the wind was blowing, and 'voted' that way. My apprehension is that among the Lisa Layton-Marlene Wheeler-Jann Gurvich segment of our community, in other words, people with a fair degree of savvy and intelligence, there is going to be a feeling from now on that the white night is really a kind of elaborate ritual testing. Already the same format has been followed too often -- we go through the test, take a 'vote' and the right and wrong sides of the vote are pretty much felt by the fact that those voting against immediate 'revolutionary suicide' are subject to questioning that contains within it a not-so-subtle intimidation that they are either cowards or disloyal or too attached to living.

This, I feel, is going to undermine the respect people have for the white night situation -- it's going to breed cynicism about it, and its going to ultimately lead people to harbor criticism about you. It may even jeopardize the whole proceedings of vote-taking, so that it no longer is an index to what people feel (if it ever was) but something else.

I don't know quite what to say about it as an answer. I just feel a little ominous about it, that the procedure will be counter-productive and breed distrust of you and less than total credulity of your motivations. When that happens, I don't know what to say. I also feel that a bad point of the evening is when Steven verbally attacked you. I can personally understand and empathize x, and don't mean at all to be critical of Steven -- in a way it's good that he be able to attack you purely from the psychological necessity of any young man to work out his Oedipus complex. But not in public.

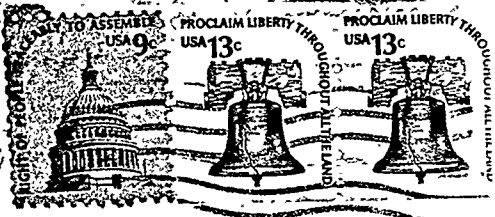

I've written this out of what I feel is a duty and responsibility. I think that other white nights strengthened this organization. I don't really know if this one did.

GUARDIANSHIP PROPOSALS:

Due to the new legislation beginning July 77- guardianships will have to be reviewed every year by the Judge. This changes our previous stance that we felt we should get court appointed guardianships in every case possible. Gene now suggests that we push to terminate every existing guardianship & that we can and ask the parents to sign permission for the kids to go to PL. with whoever was keeping them. This way we would only have to have parents permission and not the courts. (Parents are asked their permission in guardianship matters- and if parents disagree- an investigation - 'contest' is conducted- which of course would not be to our benefit housing-wise etc.)

If we follow the course of asking the courts permission to take children to the PL. we are back where we started from in that we have 10-15 workers all located on the 10th floor of the Flood Building- S.F. SB feels that we don't want to do this at any cost- since (1) all these separate workers will have to get their supervisors approval (and think this is the same person- not sure) (2) they will be tipped off as to the common denominator of So. America- PT etc.

Sb is inclined instead- to cont. with the individual guardianship operation since the possibility of all these separate workers getting together and discussing the recent influx of guardianship requests etc. is more remote. Then when the yearly review comes up next year- the guardian can write to the worker saying that they are now on a missionary duty in So. America and request the guardianship be renewed. If the court wants to see the child etc.- the guardian has no 'funds' with which to make the trip back to U.S. at that time- does the court wish to send the money? (of course not.)

At this point- even if the parents object- what are their alternatives to effectively get their child back if they don't want to come? Gene feels that the possibility of child stealing charges at that point in time is remote.

As is the chance of the court pushing its jurisdiction beyond national boundaries in these cases...

However, in cases- such as Arterberry- where the worker advised against guardianship due to the fact that she thought Clarence Moore's father would object- we have in that case petitioned the court to give Naomi permission to take the children to Guyana. This met with approval from the worker and she felt it would be no problem with the court (going to court the end of May). SB suggests that we only ask the worker about the possibility of court permission to take children to So. America- when guardianship is not feasible. (as it is not in all cases due to different circumstances).

SB also feels that if we follow the existing course of doing guardianships where possible- that we cont. to push the process- as it usually takes 5-6 weeks to have the matter placed on the court calendar. (even for court approval such as Arterberry case).

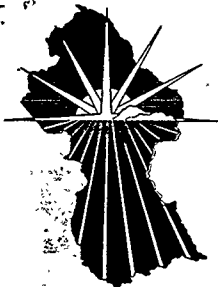

RE: THE FBI AND JIM JONES

The following discussion of the intense interest of the Federal Bureau of Investigation in the activities of one of the most progressive civil rights leaders in the United States (and a dedicated socialist) is by no means intended to be an indictment of the United States government or of the President, but rather another instance of the already well-known and highly-publicized excesses of the U.S. intelligence community, which has practically set itself up as a national and international policing agency to crush progressive, civil rights, and socialist leaders and organizations, even going so far as to finance and otherwise equip personnel to destabilize and overthrow leftist governments, as in Chile.

Jim Jones is only one of many who have worked for peace, social justice, and civil rights in the United States who have been monitored, harassed, and even persecuted by agencies within the intelligence community. Perhaps the most notable figure who was doubtlessly destroyed by this most vicious aspect of the U.S. intelligence establishment is Dr. Martin Luther King. The efforts against him have been exhaustively documented, as I am sure you are aware, in the revelations of the FBI's COINTELPRO operation, which also attempted to decimate the Socialist Workers Party in the USA. The U.S. Attorney-General has recently refused, in this latter situation, to turn over the files which are vital to litigation against the FBI and, in so acting, [has risked a citation] for contempt of court. [2] We want to make it clear that the right wing excesses of the U.S. intelligence community do not necessarily reflect upon

the government in general. For example, Rev. Jones met with Mrs. Rosalynn Carter at a dinner engagement some months before coming to Guyana, and [she seemed favorably inclined] to Rev. Jones' suggestion that the U.S. send medical supplies to Cuba, and wrote to him (letter enclosed) in a supportive vein. Our concern is about right-wing trends in the United States which can be detected within government agencies, and which have been [widely discussed and remarked upon even in the major] news media (i.e., Newsweek magazine). Not surprisingly, the FBI director himself, William Webster, recently admitted that he was a member of four racist organizations. Congress did not require him to drop his affiliations for confirmation of his post.

We wish to document here a few examples of evidence that the FBI has maintained an interest in Jim Jones for nearly thirty years, while at the same time officially denying that they have had any interest in him at all. When Jim Jones made application to see the contents of his FBI files in accordance with his privileges under the Freedom of Information Act, the FBI actually claimed that they kept no file on him. This astounding claim must be weighed against the evidence which follows.

During the 1950's, a current member of Peoples Temple, Mr. Charles Touchette [now farm manager at the] Agricultural Project) was hostile toward Jim Jones because his entire family had decided to join Peoples Temple, a militantly civil rights and fully integrated organization. At the time Mr Touchette was anti-socialist and racist. He called the FBI to investigate us, speculating that Jim Jones was "in with the communists" (a catch-phrase in those days, now being revived in the neo-McCarthyite atmosphere in the United States). Mr. Touchette's report prompted investigators to interrogate members of Peoples Temple. One of these was an elderly woman who had been given a home by Jim Jones when she was unable to support herself, without even a Social Security check. She was queried extensively: 'Did Jim Jones

buy you clothes?' 'Did he buy you the hose you are wearing?' 'Is Jim Jones a member of the NAACP?' 'Is Jim Jones a communist?' (We note that Mr. Touchette has for many years been a devoted member of Peoples Temple, and has renounced his former views, and is today a staunch integrationist. His total acceptance into Peoples Temple even after he tried to get the FBI to destroy Jim Jones is a reflection on the kind of character that Jim Jones has. The woman in question who was interrogated, Mrs. Muller, was in her 60's at the time and is now approaching 80, residing here in Guyana.)

Later, after Jim Jones moved from the Midwest (where the above incidents took place) ⁽¹⁾ to Ukiah, California in the mid-1960's, the Chief of Police of that town informed Jim Jones that the FBI had compiled a long list of his activities, in conjunction with local police anti-subversive units (called 'red squads' in those days). ⁽²⁾ [The Ukiah chief,] though holding right-wing views, admired Jim Jones and his church members for their good citizenship, and his efforts to rehabilitate young people and care for the elderly, ⁽³⁾ [as well as his emphasis on law-abiding behavior.] The chief, in addition, did not feel that the FBI should have any control over local police departments. This, we speculate, is what prompted him to disclose the above information to Jim Jones, which is at total variance with the denial of the FBI that any files have been kept on him. It is also probably the case that, although this police chief had become friendly to Peoples Temple, he would ⁽⁴⁾ [not be so disposed today,] in view of the resurgence of racist and right-wing attitudes in US society.

Another important clue that we have come upon revealing FBI monitoring and activity to discredit and destroy Jim Jones, concerns a report from a Midwestern journalist, Mrs. Caroline Pickering, to the effect that the FBI and San Francisco police conspired to instigate a series of smear-type stories about Jim Jones in 1972, using a racist journalist ⁽⁵⁾ [who has since been exposed as working for U.S. corporate interests] in South Africa. The action against Jim Jones was prompted by the church

donating a large sum to the defense of Angela Davis and other civil rights and black activists who were in no way socialists or Marxist-Leninists. (Note: Mrs. Pickering is currently married to a right-wing judge, and would probably not repeat this information to anyone representing us; the comment was made when she was talking with a person whom she thought shared her views. We have not been able, unfortunately, to locate the names of the FBI agent and police officials in our files, though a complaint was filed at the time.)

Another indication that the FBI has had an interest in Jim Jones happened in the mid-1960's when he applied for a visa to visit the Soviet Union as part of a projected trip to several European countries. Several weeks (after making the visa application,) Jim Jones was contacted by the FBI and searchingly interrogated as to why he wanted to visit the Soviet Union. (Jim Jones replied that he thought he had the right to travel as an American citizen). Even though this was long after the McCarthy Era, and many people were visiting the Soviet Union, the FBI insisted on questioning him. [Note: Jim Jones was unable to carry out his travel plans because of arrangements concerning moving with his family to California.]

On yet another occasion, famous Washington columnist Drew Pearson, who had revealed much corruption in US foreign affairs, was planning to visit Jim Jones because of support and encouragement that he and members of Peoples Temple had consistently given to Pearson when he stuck his neck out to reveal various unsavory practices in the US government both at home and abroad. Pearson, who was to pass away soon after, had lost a major network radio broadcast and even was close to losing his nationally-syndicated column. Pearson was also at one time brutally attacked in a restaurant by none other than Senator Joe McCarthy. Pearson never got to visit Jim Jones, but he wanted him to know that "the FBI was after him" (Jones).

In the early 1950's, during the McCarthy period, Jim Jones went to see Paul Robeson, in Chicago. The FBI learned of this (and could have only learned of it through a telephone wire-tap) an

and subsequently interrogated Rev. Jones' mother for seven hours. Mrs. Jones knew that her son was a good person, but [she was not at all aware of his] socialist ideology and [she thought that her son was 'crazy' to be involved] with it -- a typical attitude of many people, even with progressive ideas, in that period of intense anti-communist propaganda and the climate of fear and intimidation that went along with it. Mrs. Jones absolutely refused to tell her interrogators anything. [She was questioned at her place of employment] where she was a shop stewardess in her union, and lost her position as a result. Later, Mrs. Jones became a devoted socialist and died here in Guyana, where she enjoyed the happiest months of her life.

The very recent series of concerted efforts that have been directed against the work of Jim Jones was perhaps touched off by an incident in late 1976, when a high-ranking military intelligence surveillance team was discovered spying on a Peoples Temple meeting in San Francisco, where the black mayor of Mayersville, Mississippi, Mrs. Unita Wright, [was speaking about places she had visited. Our personnel checked the license plate of the car] that the men had arrived in, and traced it [through the District Attorney] after much probing and difficulty) to an Air Force Base in Biloxi, Mississippi. Further investigation confirmed that they were receiving their instructions from a racist, reactionary U.S. Senator, John Stennis. The Air Force denied that these individuals were in our area at all. Congressmen who we asked to help in exploring this matter further could get nowhere. And a prominent editor in one of the major establishment newspapers in San Francisco told us [that "this time you have gone too far."] Nobody would touch the story, except for the president of the black press, [a friend] of Jim Jones [who should be visiting here soon.] It was only two days after this story was released to the press that (we later learned) a group of people who were conspiring to discredit Jim Jones began to co-ordinate their activities with the aid of a prominent public relations outfit. We would discover later that one of their tactics would be to use people who had left our organization to 'bait' the media with ridiculous stories about Peoples Temple. The people involved had both ultra-right backgrounds along with some

who were part of an anarchist/Trotskyite group that advocated irresponsible activities and courses of violence in total contradiction with our beliefs. We now have good reason to believe that their insane, 'revolutionary' schemes were advanced as a provocative ruse, [as has been ¹done with other] groups advocating social change.

There are other incidents. But the above highlights, we feel, amply illustrate that there has been a continuing effort on the part of the FBI to undermine, thwart, discredit, and ultimately destroy Jim Jones and Peoples Temple, an effort that is not at all inconsistent with the shameful activities that have been catalogued with respect to many groups and principled leaders who have been attempting to work for constructive social change in the United States. We also note that the CIA has similarly denied that any files are maintained on Jim Jones -- a curious statement in view of the fact that it has released material [it has kept on several members ²of Peoples Temple.]

At this point, we would like to bring up some related considerations that will help put the foregoing into a wider perspective.

As we have noted, the intense campaign to impugn the reputation of Jim Jones, smear his character, and sow discord about his work, is nothing new to the progressive community in the United States. Many leaders and organizations working for social change have been similarly victimized.

Community and civil rights activists who know of the work of Jim Jones and Peoples Temple intimately, have remained staunch supporters. These are people of all races and varying political persuasions. We cite just a few of the more notable examples:

--Mr. Robert Gnaizda, Director of Public Advocates, Inc., an important legal collective that has exposed much corruption in government, is a strong supporter. Mr. Gnaizda, incidentally, was a key aide to California Governor Edmund Brown, Jr.

--California's Lieutenant Governor and former Congressman Mervyn Dymally has been a close friend. Mr. Dymally, a native West Indian, has visited the Agricultural Project, and has published a book through Peoples Temple documenting a national conspiracy [to harass and ruin hundreds of black elected officials,] himself included;

[--Progressive California State Assemblyman Willie Brown;]

--Dr. Carlton Goodlett, M.D. and Ph.D., President of the NNPA (which is the major black press association in the U.S.), who has publicly and repeatedly denounced the efforts against Jim Jones;

--Mr. Thomas Fleming, editor of the largest Afro-American newspaper in the San Francisco Bay Area;

--Jane Fonda, internationally-acclaimed actress;

--Angela Davis, rights activist;

(Note: Ms. Davis has been very supportive of our position here and has been very much aware of our support of the government)

--John Maher, nationally-known for his rehabilitation work with ex-convicts, and who currently has his own ABC-TV program. Maher has offered his assistance to Peoples Temple in locating a doctor to help get a local Guyanese child here in the North West Region a corneal transplant operation that will save his vision. Incidentally, Mr. Maher, in order to 'survive' in a climate prejudicial to the collective lifestyle of his prison-rehabilitation foundation, has had to moderate his views in public, something that Jim Jones refused to do, and which helps explain the kinds of attacks to which he has been subjected; ③

--Other local supporters, which include longtime civil rights activists Enola Maxwell and Yvonne Golden (Ms. Golden is President of the San Francisco Black Teachers Caucus); author Albert Kahn (whose works are among the most translated of any American writer); organizations such as the Women's International League for Peace and Freedom (WILPF), the World Peace Council, and the NAACP; the head of the San Francisco Council of Churches; members of the San Francisco Human Rights Commission, and many progressive clergymen.

All of these people, [and many more,] ④ have been outraged by the despicable use of false witnesses to air monstrous lies about Peoples Temple. The entire catalogue of media-sponsored stratagems and bogus investigations are already well-known and have shocked many people. Those who have followed the campaign against our movement have concurred with our profound dissatisfaction that the U.S. Embassy here was unable to prevent a

young woman from walking out of Guyana with several thousands of dollars she stole [from elderly people¹ here in our community], and who subsequently proceeded to cover her crime by shamelessly lying to the press about the nature of our community. There was nothing we could do about it. Our refutations were only marginally covered [in a prejudiced media² -- a typical pattern.] We cannot afford, in addition, to become encumbered any further with libel actions which would require that we send witnesses back to the United States to testify.

We recommend, to put all of the foregoing into perspective, that you see [the recent³ issue of Ebony] magazine where extensive, quasi-genocidal efforts are exposed that seek to destroy all black elected officials. A similar expose also appeared in Sepia magazine a few months ago in an article by Mary Warner, excerpted from a volume printed through Peoples Temple. The extensive list of targeted individuals includes Rep. Charles Diggs (founder of the Congressional Black Caucus), Senator Edward Brooke (the only black U.S. Senator since the Reconstruction Era), and moderate civil rights leader Jesse Jackson of Operation PUSH [who at one time, it has been⁴ suggested, even gave information to the FBI, along with Roy Wilkins, about Dr. Martin Luther King].

All of this is nightmarish, and is producing a neo-McCarthyite climate of fear in the United States that is stifling dissent and decimating any vestiges of forthright black leadership in the wake of successful right-wing efforts to cut back important programs for minority and poor people, and other key civil rights gains in many areas of U.S. society.

We are also alarmed and disturbed -- as is a large segment of the American public -- at the actions of President Carter in backing down from what had promised to be a progressive administration. [We don't believe⁵ that Mr. Carter] is a hypocrite. We can only speculate that there have been some enormous pressures brought to bear upon him, and that these are perhaps related to the selective assassinations of the 1960's of several progressive leaders (the

conspiratorial nature of which is now being investigated and exposed, revealing high-level complicity).

The effect of this is quickly clarifying who rules America --and who in fact dictates the policies of government: a super-rich military/industrial complex, run by a corporate oligarchy. This kind of pressure has extended into all areas of government, especially the U.S. Congress, which has recommended courses of action (such as breaking relations with Cuba) that have even shocked State Department officials. Another disturbing sign was the frustration experienced by former Watergate Chief Prosecutor Leon Jaworski, who was assigned to investigate U.S. Congress payoff-taking from KCIA go-betweens. Jaworski concluded that the investigation he was to carry out was really only designed to make it appear that the government was policing corruption in its ranks, because when he seriously began to get at the roots of the situation, he was rebuffed, and [was himself investigated, and had to curtail his efforts.] Similar things happened during the Church Committee investigations of the U.S. intelligence community.

We could cite much more evidence that points to the resurgence of a right-wing, fascist-like mentality so frightening that hundreds of people -- many of whom we do not even know -- who have heard of our work here are expressing a desire to join us. [Many of these are people who express] a sense of alienation and lack of personal fulfillment, bred by an advanced technological state that looks upon human beings, increasingly, as mere commodities, and which is losing touch with the needs of millions of people.

A final note in this vein that is particularly chilling: we know [a young man in the US Air Force] whose mother is residing here in our community. He tells her that people in the military have a joke about the neutron bomb. They call it the 'nigger bomb,' referring to its projected, special tactical use on black ghettos

to wipe out the population while saving the property, adding that it will be sent to South Africa for the same purpose.

Our purpose in providing you with this information has not been, again, to cast aspersions on the United States, but to illustrate the kind of activity which has worked to undermine progressive movements. The reactionary and right-wing currents within U.S. society can work to undermine, additionally, our quest for international co-operation and peace. These issues have troubled millions of people of conscience in the United States, including many people in all areas of government.

On November 5, 1978, a group of us went to a conference at the Jack Tar Hotel sponsored by the American Russian Institute/Holland Roberts Center. Jean Brown, Andy and myself approached the Consul General, Alex I. Zinchunk, Jean Brown delivered to Mr. Zinchunk your message as instructed. Zinchunk had received considerable information about Peoples Temple and his comments were, " I understand that your group has been quite active". The more Jean spoke the more he nodded and stated, yes, I know, I know. It seems that Davidow and Bransford or whomever, has been doing a lot of talking about P.T. Davidow mentioned to me that it won't be long now before some of from P.T. will be going to the U.S.S.R.

On the morning of 11/5, Hue Fortson was a featured speaker in Oakland at this humanist fellowship church. Hue took slides. The members of this church are affiliated with the Holland Roberts Institute, through Andy, P.T. was invited to this church to explain to the membership what P.T. was all about, both here and in Guyana. There was some question and answers but because the slides took up so much of the time, the questions were minimal. However, one man approached HUE and inquired about the relationship between Jonestown, Burnham, Chagen. He went on to say that he spent some time in Guyana mining Diamonds but ran out of money so he returned to the U.S. By in large through, I think the impression that was left with the small group was positive. One lady asked about the monetary system in Jonestown. Hue explained that folks had money but there was no monetary exchange necessary due to the collective lifestyle. She talked about slave labor camps. I do think though, that the slides told the complete story about Jonestown.

According to the minister of this church the congregation was a mixture of old leftists, union members, socialists and communists. He considered himself a communist. He wanted to know what our affiliation was with Glide, and it seems like I here that question a lot. I told him none. He then elaborated about Cecil Williams which was quite unfavorable.

On Thursday November 9, 1978 a group of us will go to Sproul Hall to hear Angela Davis speak.

Last Friday, Oct. 31, 1978 HUE, GUY, ANDY and MYSELF went to a fundraiser for Yvonne Burke, who is running for Atty. General of California. Yvonne did not show nor did Dymally, but Andrew Young did show. We talked with him twice. Once was very brief, too many folks around. On the second attempt, Hue asked for his autograph while I talked in his ear. I told him about the project and the reputation it is receiving from visitors around the world and that as UN.ambassador he should see the project for himself. He promised that whenever he was in the caribbean, specifically, Guyana, he would drop in on the project. He said he would like to see it.

Andrew Young's speech was somber, dismal and an attack on the black middle class. He talked about the systematic oppression of minorities and the systematic exclusion of minorities from the mainstream of economic, political life. He spoke about conservatism and the move towards racism as oppose to one world government.

While I was speaking to Andrew Young, a woman overheard my comments about Jonestown, and later asked to speak with us about the project. It seems as though this woman had been to Guyana and was familiar with the land lease program of Prime Minister Burnham. She spoke of a group who presently reside in the bush, originally from the U.S., who received mail from surrounding villagers and citizens of Georgetown who want to know what is happening in Jonestown.

According to this woman, whose name I will have to forward later, she has been sending copies of articles clipped from papers here in America. We invited her to the church to see the slides. She was eager to come, she did say that she wasn't guaranteeing that she would be convinced by what we had to say to her.

Justice Clinton White. I had previously met Clinton White at a correctional seminar and he was friendly. He said he knew little about P.T. other than what he had been told by Billy Hunter and read in the newspaper. He did say that he had heard that J.J. was a very good man. We ran into Justice White on 10/31 approx. 2/3 weeks after the first encounter and he had been approached by Stoen. He brought up the child situation, we explained the child situation. He seemed reluctant to listen but he listened.

We told him about Stoen's activities in Germany and his conduct as an attorney representing clients against a church to which he was once attorney. Justice White was defensive of Stoen's behavior in Germany and summarized such activity as something he would have done in his youth. He said he would talk with Goodlett and Gary, but wouldn't promise to read the literature.

On Friday, November 10, 1978, we will sell food at an Oakland International Festival at the Oakland Auditorium. On 10/31 a group of our children went to Holland Roberts for a Halloween party. One man who had been totally negative re: P.T. was very impressed with David, one of Jessimere Harris' grandsons to the point that his opinion of J.J. changed as a result of David's good manners and maturity.

I called Dymally's office in Sac., from work, to obtain precinct information for S.F. and this area is doing literally nothing in support of the Lt. Gov. I mentioned that I was from P.T. and the response I received was that the Sac. office was very impressed with the amount of support P.T. has given the Lt. Gov throughout the year.

On Thurs. evening _____ Perry will be at the Temple for dinner. I understand from Andy's report, See Attached, that he has been cleared to visit Jonestown. A report will follow his visit.

The principle upon which value substitution works is that value systems, indeed all frames of reference for most persons, are maintained by perception, stimuli. Research and Experience has conclusively sustained that people deprived of stimulation become very docile and tractile.

The trend in all "brain washing" is away from any kind of pain administration as it engenders strong reinforcements to the mental "set." Rather comfort reduces resistance to reprogramming or value substitution.

Varying levels of intensity yield varying results over varying time span. One method utilizes vitimine B complex deficiency. Vitimine 'B' is said to be the Brain and Nerve vitimine and has been found to be very influential in the amount of perseverance and or stubbornness individuals exhibited.

Secondly, the amount of sensory deprivation influences the time needed to achieve plasticity. In a dark space, on mattresses, sound proof, with hands and feet padded (hand fingers and toes are primary ~~sens~~ tactile sensors) the person usually experiences degeneration of reasoning functions in about 72 hrs. This process is usually indicated by hallucination and be signalled by frequent screaming. Most persons at this point are not able to controll the hallucinations. However, they monitor can controll the hallucinations by providing carefully selected stimuli for determined

periods. The subject is free from ^{MC 96} the hallucinations as long as he attends to or concentrates on the stimulus and its related aspects. The result then is that with proper time scheduling, the subject begins to desire the stimuli and becomes dependent on it for freedom from the sensation of being lost, discentrated, lacking identity, verification. The identity verification is an important concept. It would then follow that persons with poorly developed self concepts (images) are more susceptible to this process.

The more stimulus free, the shorter the period required to reduce resistance to value substitution. Scheduling the intervals between and duration and content of the redevelopment stage is most important. The initial redevelopment stage should have the shorter periods of value presentation and spaced at longer intervals. The periods become longer and more frequent as the subject shows progress in internalization of the new values. Thus the periods of discussions are rewards for progress.

It is important that the proctor realize that the subject is quite suggestible during the redeveloping phase and this period requires considerable thought, and planning prior to implementation. Also, conversation not directly related to the values desired is kept to a minimum. In the later phases it may be increased as a reward.

The Facility: should be large enough not to give claustrophobia, say 6'x6'x6' minimum. It should be light-tight and in an area devoid of sound. The floor should be covered with mattresses. It is desirable though not compulsory to pad the walls also.

One method includes the use of a restraining jacket and feet restraints. The process is expedited though probably more traumatic. We may not desire this procedure.

The process may be completed in from 5-7 days.

I am the first born, the name-sake, the second element in the Dynasty, Lemuel Thomas Grubbs (II), I am the duce and was suppose to be the protoge', the ego extention. But it didn't work out.

My dad was built like Charles Atlas, was a lumber Jack and a tag-team wrestler with his dad in Alaska as a young man. I turned out physically and mentally more like the Lathan side of the family - he never liked that.

I was a sickly child, most child hood diseases, pneumonia (twice I believe) and then 6 years of Rheumatic fever ages 5-11. I spent most of those years in bed away from everyone and every thing. Of course, Dad's great fantasies were shattered - he was greatly frustrated; He made unrealistic expectations of all of his children, me particularly as the oldest and his name sake; I could never please him; I was always a disappointment or disgusting. His impatience caused me to retreat mentally and he would scream and curse at me because I would not anticipate his moves and have his tools ready for him (at the time he was a finish carpenter part time and in the Navy).

When home Dad was working, reading (an escape mechanism to avoid fighting with my mom) or sleeping. A thousand times I stood beside his chair and called his name over and over, up to 15 times; then unable to break the spell of his book left disappointed --

not even worth as much as his book

as I have said dad was a huskily built man. He used punishment, fear and intimidation a lot. Being confused and emotionally unstable I was easily intimidated - and I hated it. Then when I was 15 he fist whipped me. I can still remember bouncing between fists and the wall. That incident brought some major changes. The mother fuckers can kill me - I am not going to be intimidated any more! On several occasions after that I went outside to fight him, knowing he could have hospitalized or killed me but believing I might get a few blows in and it would be better than being intimidated. No one ever intimidated me again until you, but the price of resistance was pretty high.

My Mom was a sick woman. A victim of incest, a nymphomaniac that never said no to any man until she was at least 30 years of age. She was a hypochondriac, and was a victim of my dad's ^{racist} chauvinism. Her only means of revenge was to emasculate his dream, his 'protoge' - me. I am convinced that some of those years of illness were her projection.

at age 12 my parents divorced and I moved with my mom to a socialist based religious community in Wyoming. Both parents had formerly belonged to the quaisi socialist religious movement the Shepards' Rod Davidians Lead by a 'Prophet' named Howtiff. Long story short, mom became mentally ill from guilt and frustration. She was a fear and guilt manipulator and an expert at brain washing. I later studied the techniques and psychology of brain washing in college - she had used them all!!

after living in a house without heat, windows furniture or food - just eating what we could forage from the land - for a few months conditions improved for a while - we had a house with windows and heat and better food.

sugar beets and potatoes 3 times a day
for months. Sometimes we had bread - but
always we had bible verses, 3 before every meal
before we could eat a bite and had to recite
all 21 flawlessly on Sabbath before we could eat
anything.

We then moved to Texas where we survived
by collecting food from trash bins behind stores.
I learned a new lesson - I can take better
care of me than others can - I ate better
out of trash bins than I had before.

After 9 months of Texas and eating out of
trash cans, with our bodies as our sole testi-
mony the court awarded custody to my
dad. Things improved materially, but we then
had a step mother who was blatant about
her favoritism for her 2 younger boys. I
had more lessons to learn. - I was always
a disappointment or disgusting to dad, we
were not worth as much as the step children,
we were not as important as the furniture,
the car or dad's tools.

I mentioned that my mom was a sick
person, mentally, and that she was a
great manipulator of fear and guilt. She
finally played her trump card - she com-
mitted suicide by starvation!! There are
too many memories in this regard to write.

So here I am - always fearful that I
cannot do good enough (tend to be a perfectionist
by compulsion). I hate to be manipulated by
fear or guilt. I insist on thinking for
myself - my dad said many times, "When
you are old enough to think for yourself, I
will tell you, until then, I will do your thinking
for you." I hated it!

Now I am not afraid to die. But I am
afraid of being a failure or inadequate, a
disappointment. This condition was further
intensified during the years I worked on the

PA and radio broadcasts, I was constantly confronted by problems for which I caught "Flack" and there was no one to help. (Some one who knew more than me).

I am not afraid of punishment or discipline for what I do - I am anxious about what I can see needs to be done that I don't get to. My compensation for feelings of worthlessness was a compulsion to learn to do everything I do well. I believe I am better as a teacher than anything but I also cut hair, repair eyeglasses, repair tape recorders, know and enjoy working with trees, work with wood, tool and work leather, am an archer that can make my own bowstrings, string jig, arrows and accessory equipment, I am knowledgeable in psychology, particularly education psychology, can repair most small appliances. This presents new frustrations. People want me to do all of these things and I don't have time - I spend many hours in meetings when I would rather be working. I am happiest when I can work 18 hours a day, 6 of them making or repairing things. I found I can feed my own ego by making and repairing things, then I don't have to wait for praise or approval from others.

Sometimes the pressure of the list of things I need to do and/or want to do gets so great I get flippy unless I write them down and get them off my mind.

Sex - as you know I practice bestiality and have for 24 years. I have never been caught but I have risked my life to avoid capture in a trap - I made a fast trip through a peat bog late on a dark night to escape. I have never been caught and exposed - but I know!! I know it isn't normal and approved. This contributes to my feelings of worthlessness or inferiority. For a long time I feared exposure on the "Floor", but I don't worry about that so much anymore.

Reticles I hate to be conned to, exaggerated to, duped, manipulated (fear or guilt) or intimidated. I have had a life time full of it. I can see these things like ink on paper and I hate them. People have played with my head all of my life. I understand your good purposes and 95% of the time my thinking mind over-rule the protest from the emotion dept. It is only when I get frustrated and anxious that the emotional reaction becomes dominant.

Hate You have intimidated me on 2 ~~occass~~ occasions that I remember clearly and probably a 3rd. I hate anything that can cause me fear (death can't) and you have done it. Again, my rational mind usually represses the hate and fear (fear that you will do it again) but it is there.

Fantasies I have one recurring fantasy - that I die, ~~is~~ am killed, murdered; for resisting intimidation in a public meeting. I do not see my self doing violence usually, but fighting back verbally. I realize too that fantasies occur only with unresolved anxieties.

Resentments I have never knowingly lied to you. That is not my way because someone intimidated lies and I hate being intimidated. However, I believe I have been misrepresented to you. Once on the Floor nearly 3 years ago by Bea Morton (Corsot) and recently by the team of Christine Lucientas and Lois Ponts. I have examined that situation CAREFULLY and believe I know my motives at the time I spoke. Lois had several personal grudges to settle. I try to keep my rational mind in control and make principled decisions but here is an irrational exception: I would rather die than intimidated or manipulated by fear. You ask me a strait question and I will try to give an honest answer. In that exchange over the charge by Christine and Lois I believe you projected heavy prejudice. I recognize

my error in that regard, speaking harshly to Christine in front of the children. My motive reference to the office were not as depicted.

Guilt. I hate being manipulated or controlled by guilt. But you are so busy I feel guilty to

Speak to you about things I should speak about. So -- I try to get answers through other leaders and only get partial answers and still have a lot of unresolved questions -- the anxiety level goes up again. I am often afraid that in the scope of things my questions and comments will seem trivial so I don't speak until the pressure mounts up.

Zero. I suppose that becoming zero is hard for people who have believed they are or have been something. However, there are some aspects of bitterness for someone that has been a "less than zero, negative" most of my life. I believe in frugality to the N-th degree and am pissed by waste and selfish abuse. I have some items 20-24 years and many between 15-20 years. Probably my 2nd or 3rd greatest frustration is the rate of waste and abuse of property.

Socialism, Communism. I have read the Communist Manifesto, parts of Das Capital, the Introduction to Socialism and have lived Communal for 5 years. There is no doubt in my mind that it is the right, the only meaningful way to live. I don't mind making ~~so~~ a lot of "sacrifices". I have lived most my life with little. I need little.

What I ASK: a life free of intimidation, guilt, manipulation (big request too soon, huh?)
A job I can do, the tools and materials to do it with, a few good books to keep the mind stimulated, and occasionally, classical music.

Oh, yes, a chance to do the job

I don't need any luxuries except classical music. Even my dog has chosen another. I think I have finally accepted even that.

Dear Dad, I'm aware of my responsibility and the terrible consequences my deviant behavior has brought to our children, complicating their lives and promoting my own problem in them. I have learned to face what I've done and assume the burden of guilt it brings, and to use this guilt to strengthen my determination never to repeat my treasonous behavior. It has taken a long time for me to trust anyone, especially other adults. Your continued love, patience and acceptance (even while rejecting my negative patterns) have won my total trust in you despite my paranoid tendencies. I have had a tremendous block in communicating to other adults, but now I feel I can communicate well with you and with Tom Grubbs. This communication is vital to me in heading off situations before they become problems. These new channels for communication have averted rash behavior when I was feeling my lowest, and they have given me insights into my real motivations. I feel I have more control over myself and over situations in my life. I have devoted a lot of time analyzing my motives and patterns of behavior which lead to deviant behavior, which I felt I had to understand before they could be controlled. I have recognized five steps or levels of involvement, usually separated by passage of time. They are as follows:

Level One: At this level I become involved with the children, their problems, their needs and desires. It includes teaching school, teaching crafts, skills like playing guitar, art, games, hikes, joking and doing favors. Sometimes it's just giving a listening ear or a word of encouragement. It involves giving the children attention, the attention I never had but can enjoy vicariously, as I feel useful and needed even if it's only to be used in meeting a need. Penny calls this "romancing" the children, and has forbidden this contact as a precaution. In examining my sexual motives at this level I find that many deep Level One involvements never involved any sexual attraction, as with David Chalken, for example. Of course, Level One is also a point of contact for those I have had further unhealthy interests in.

Level Two: At this level there is a lot of sexual fantasizing, reviewing sexual experiences from my past, ~~imagine~~ imagining situations and masturbating. It is at this level which I'm consciously redirecting my fantasies away from children. In the past, many of these fantasies were never acted upon simply because the child gave clear indications in my contact with him that he would not be receptive and I have never forced myself on anyone who clearly is not interested. ~~hide who he is not~~

Level Three: At this level I would feel out the person's reactions to me. It involved a lot of time and carefully contrived situations, I would be extremely sensitive to signs of recognition of my intentions and signs of rejection. These situations would include activities like wrestling where close body contact would lend itself to "accidental" brushing against the "privates". I was careful to leave a doubt in the other person's mind as to my intentions so that if I sensed a negative reaction coming, I could withdraw all such contacts. I've come to understand that at this age children have a lot of confusion about themselves and their sexual feelings and will give mixed signals without any intention to invite sexual involvement. I didn't know that before and those mixed signals would cause me to proceed to Level Four.

Level Four: After recieving what I took to be signs of interest, the next step would be to become more direct, and leave less doubt about my intentions. Direct touching of area of the "privates". This is the point where most of my sexual contacts with children have ended. In most cases a clear rejection came from this contact (much to my surprise), as their mixed signals had misled me to proceed. At this point I'd reverse my course of action as fast as I could, didn't repeat any further attempt at sexual contact, and (cont)

I tried to reestablish a Level One Relationship as quickly as possible. I had to realize that they could tell about it anytime they pleased (eventually all did).

Level Five - In a few rare instances, the child didn't reject my advances. At this level I received what I was after -- acceptance. In my paranoid way of thinking, sexual cooperation was the ultimate sign which proved their sincerity of acceptance. After analyzing this I realize people really use each other sexually and it proves nothing about their sincerity or acceptance. It was hard for me to separate my real goal from sex, but in thinking back, I realized that when my advances were accepted, a great burden of worry came with it, that I would not be pleasing, and that the temporary acceptance I had received would be withdrawn. There would be great anxiety over being caught, and I never proceeded without elaborate precautions and isolation. I wanted to get it over with, but leave my partner satisfied. Afterward I would question myself that I would indulge in so dangerous a practice, jeopardise all I held dear, have to face my conscience (my guilt level may have been low but I did have a conscience that did not give me peace while indulging my perversions) and derive so little sexual pleasure in return. I didn't identify that acceptance was my real payoff. Torn between compulsion and conscience I've been precariously close to suicide all my life. When I was a child and during my early teens, I refrained out of concern for my pets. Later drugs (a slower suicide) kept me from ending it before I came to this family. Since then I have come close to ending my crazy existence, rationalizing that people in general would not be too affected and that children forget quickly. I never could get around the fact that you would care and that you would be hurt. I couldn't be sure that even if I cleverly disguised my suicide, it might not be used in some way against our Cause by our enemies. Even though the alternatives were public confrontations and humiliations and rejections I feared worse than death, I just couldn't do that to you and the Cause. If you ever feel that it would be better to remove me from the collective, for the good of Socialism, I am willing and able to cooperate in any plan that can aid Socialism and destroy Fascism. I have lived 50 years and feel 500. I'm not looking for much more out of life anymore.

Alternatives to my past behavior are to develop clear channels to communication (which I have already begun establishing) and to cultivate adult relationships of comradery. I am really looking for the Dad/Big Brother figure I missed out on as an only child. I'm looking for communication on an adult level based on respect. I feel in view of the practical realities of your horrendous schedule, that to take up your time is unthinkable. However, Tom Grubbs has been friendly enough to me, seems to understand my problems fairly accurately, is open to communication (though I don't know much about his present problems, he is open about his past). I have a lot of respect for Tom as a teacher, craftsman, and perfectionist in his endeavours. I don't think he is without faults, but I feel my view of him is not too unrealistic as far as it goes. With your consent I will work to build up that communication and interaction and will continue to look for others I can relate to on Principle. I will work to strengthen my controls and to examine my motives so that I never again cause you and our family grief. Thank you Dad for caring. I owe my life to you and to Socialism. I will try to justify the mercy you have given me by my contributions to the Collective.

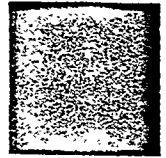

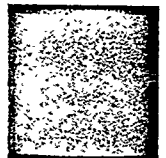

Here are some ideas for possible strategies that may or may not be useful, but may help spark other ideas:

1. Katsaris is there some way to pressure him to drop his suit in light of what we have on the CIA connections -- if he doesn't co-operate with us he will be implicated in a CIA-plot, etc. What we ask him to do is drop the suit -- we will have Maria publicly forgive him, maybe have a public 'reconciliation' -- with understanding that he allows Maria to live her life as she chooses without any interference from him. 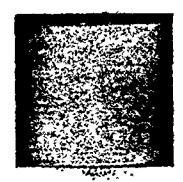
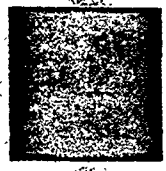

This is a start anyway. I'm hopeful about having more time soon --in two weeks, I'll get two weeks vacation time, and can tackle this better, plus catch up on other things. These mass letter-writing projects are very time-consuming; I wind up writing most of the drafts myself, and we distribute in service, right in the auditorium, to make sure everyone writes. It's more work in one sense, but has become the most expedient way of getting it done, rather than assigning, waiting, prodding, feeding ideas, re-working drafts, clearing, the whole mess. Everyone writes, including the older children; and whoever can't write has someone write for them, plus their own. We're going to draw on some additional lists too, for names; I don't see where we have much option.

A child who volunteers to help on letter-writing projects regularly, incidentally, and works very well, is Amanda Brown, one of Roseana Dickerson's grandchildren. She was the one who was sent back down South over a year back when she tried to burn down the girls' restroom at school. She's very sweet when she has something constructive to do; and I wanted to put in a good word for her because Roseana's nasty to her from what I can see, tears her down, and the child's really trying. Anhara Alexander (Jim Alexander's daughter) is also very helpful.

I contacted Joanne Molloy, she's still extremely positive, and was thrilled to have an open invitation to visit. The Northern California Alliance, the group she's been working with, is all split up now, and "Common Sense" has come out for the last time. The Black Panther Paper just folded too.

Jane Fonda didn't win the Oscar for "Julia", but Vanessa Redgrave did (supporting actress) -- I think she's a better actress anyway, more genuine. Redgrave made a nice speech (in news articles enclosed) for which she was hissed and booed; but she was in fact picketed by the JDL, PLO, and the Nazis all at once, with threats for many weeks ahead. The JDL burned her in effigy in front of the Academy, while Allen Vincent told newsmen "I was just demonstrating for the white race when 'a bunch of animals' came up from behind and attacked me". The jet set crowd should have at least appreciated that she had the guts to show --she could have been assassinated in a melee like that-- but of course they didn't.

Re-sent our "600" packet to those who didn't return receipts yet --three out of five were from the State Dept (Vance did receive, the others no confirmation), and will give IRS a few more days, no receipt back from them either. Sent out amended QSL list to those to whom we already sent the wrong one only. Also got the packet out to HEW.

Some more clippings enclosed, pretty much caught up now. Note Carter is about to stop neutron bomb production, but the pressures against him are pretty stiff, and nothing definite has been announced. It looks like it could go either way.

Regarding what goes to the International Human Rights Commission, what to the press, communications were schizophrenic on that at best, and I assure you I had not been told you cleared that and wanted it out right away. I was first told to go through the (idiotic string of) lies and meticulously refute them point-by-point, to go to the Commission. Then Jim Randolph told me Teri said keep working on it, but something was being done over there simultaneously, which I could use word-for-word instead of what I was writing. I assumed what was being written over there would either greatly clarify what I was about, or could mesh right in, or I could make a direct substitution. But what finally came over, the thing Tropp wrote (sounded like Tropp anyway), was the opposite of a point-by-point refutation! The only word I got about sending anything to the press was along with the notes on what to send to the Commission, so I could only assume it was one and the same letter. Tropp's letter never got past pencil notes^{untill} today, as according to what anyone understood from the radio its use was "optional", and the off-hand impression of Jean, Tom, and me was that it was "bad" -- I mean "bad" in the sense of sophomoric, overdone, snide. But I'm editing out the "Tropp trips" now, and it will get out.

One lesson well-learned: I'll be checking out questions myself on the radio so far as possible. It's not that anyone else's word is not reliable, but it just seems a built-in liability that "radio" can get to be more like "telephone" -- the final product becoming more distorted the more people it goes through.

One thing over the radio though I resented highly, and I want it conveyed to Lee: Teri was clarifying what was to be done about the Commission letter I was working on, and I was acknowledging; then Lee steps in just to say, "Do it." There was absolutely no need for a "man" to step in with "the final word", when Teri was handling all the instructions perfectly well. Why doesn't he do all the nitty-gritty of deciphering instructions and laborious secretarial work, like Teri and other sisters have always done, before he presumes to step in with "the authority trip"? If it weren't that it was your authority (in terms of your wanting something done) that he was talking about, I wanted to tell him where the hell to get off. And people do that, too: choose a time to back up you to make themselves look a little stronger. Your authority I respect, but his I don't. That's just chauvinistic "bullying", no more, no less. He came off looking weaker, not stronger. He insulted both Teri and me, and was using you. Sorry, I'm in one of my more "straightforward" moods, you might note. But it's really worth asking in these instances, if the great "authority figure" knows what the issue is! They generally don't; the "trip" generally supercedes the issue, or the responsibility, by far.

Well back to this letter to the Commission: I was surprised myself, we were taking on "charges" point-by-point, but I just figured it was so riddled with lies, blatant lies, that we could almost stand to gain, especially as the Commission had presumably read the outrageous document anyway. It could help to come across as thoroughly rational beings who are obviously in stark contrast to lying, devious reprobates. That's very easy to get across, just give the facts! And that crazy Crawford bitch, after they get her to perjure herself 16 times over, she winds up working at Macy's...

Anyway, this WASN'T the final version, only one person had had a chance to go through it all, Leona, who is an excellent critic on a pragmatic score, I found. That's one good thing, anyway, that came out of the meeting after you talked with us all over the radio. Leona was upset because she said the other long letter to Carter sounded like "true confessions" and accused me of not being responsive enough to her criticisms. So we spent several hours together over this thing, and got subtle frictions worked out in the process. I like Leona. I think she does have some racial paranoidias, but who wouldn't? I respect her a hell of a lot more than people who never speak what's on their mind.

You'll all find a lot wrong with this draft to the Commission, I'm sure! I had lots of unanswered questions, but the format, the approach I think is pretty solid, if we do in fact want to do this kind of thing. It was tedious, but not as hard as I expected, it's filled with abominable lies and transparent subterfuge.

On the assignment to write the Consulate, we got a total of 435 (letters and telegrams) out to the Consulate in L.A.; and the same to New York and Washington (but almost entire copies, which isn't an entirely effective way of doing things). Plus 179 more letters to Kurtz, and 128 to Carter re IRS.

Re the enclosed letter to Jerome Kurtz: written because of the threat made about "May 1st" to the Disciples, thought they should get something from us officially on it before that date, so we could say "we told you so" if we need to.

The enclosed letter from Sen. Sparkman just received by several. He was one we wrote months ago, nothing recent, and never got any response until now, so it looks like it really is a current concern, not just a response to a letter. Should we be swamping him with letters again?

Follow-up letter re Mazor enclosed too. And a copy of the current form letter from the State Department being sent to several.

Re my job: I'm making the request again. These reports are going in early, so no time to detail. But I would not ask without very sufficient reason. Your speculations about "very soon" are kind, but meaningless. I'll remain here as long as I'm needed, at least this always ~~has~~^{has} been and remains my intent, and everyone knows that is entirely unpredictable. All I want is conditions under which I can effectively function now.

Last week when I searched the file cabinets Evelyn's mother left behind to find income tax returns for people overseas as well as here, I found the contents of the safe that used to be in accounting, which we thought had been transported over there. Mildred radioed this over already. Martha suggested I should write up this report on it also. The contents of the safe were in a cardboard box sitting on top of the file cabinets, open. In the box were all the original deeds, wills, some statements of former members, and a binder, which contained coded minutes of old counseling sessions for meetings. I remember a year ago or so, when Frances and Bea did the minutes, there was confusion over a missing binder that failed to turn up when Frances turned in the minutes to Bea one night. Eventually it was assumed that Frances had lost the binder, and I think she was heavily confronted on it by Evelyn's mother and possibly Bea. After that, all the binders that were left were eventually burned. I am wondering if this is the missing binder. The time covered in this binder seems to be between February 1977 and May 1977, and there are also old pages that are interfiled, dating back to 1976, giving histories on people who were on the floor. If this is the missing binder, we don't know how it got to where it was found, but we will refrain from telling Frances or anyone else besides Mildred, Rex, Martha and me who know because we are afraid that considering the past history of confrontation and blaming of Frances, it would be demoralizing at this point for Frances and not important to know anymore anyhow.

If you think it's worth it, you might consider asking Evelyn's mother or Ed why the box was left in the room and why this binder was in with the rest of the stuff. However, at this point, we are just thankful that it was found. Security at this point also is irrelevant, since none of the file cabinets left behind by Evelyn's mother in the room where Lee and Jack stored them can be locked; Evelyn's mother took all the keys with her.

I think that fewer people would be needed for security if it were organized differently. This putting people into the fields.

Firstly as far as mercenaries go, we would need a far larger force of trained people to be effective against mercenaries, whose purpose would most likely be assassination by sniper which is very difficult to guard against, but which entails rather strategic placement of people and ~~control~~ caution as to the movements and location of targets (most likely the office). I don't think kidnapping is realistic unless they get inside assistance and even then this could be prevented by close surveillance of possible targets within. The only other possibility for mercenary action would be the aiding of the "escape" of

of an infiltrator, unless you know definitely who this is or is not, this is almost impossible to prevent.

Basically I think runaways could be classified into three possible categories: (1) Anarchistic or unbalanced types driven by emotion (2) Possible infiltrators (3) Some deliberate defector with planning and thought.

Prevention for the last two categories is very difficult though the best method for all three is basically psychological. I discussed this topic with C. T. who told me that he feels that many of those who have been here some time are aware that they could walk out of here any time. I said I could probably get to F. (4) The means of getting out of the Ridge or Kaituma and so forth.

(5) What to do upon reaching Georgetown (I don't feel that a person crossing the border is a realistic possibility without close outside assistance and alliances and money) — in summary

You could break this procedure down into four basic phases:

- (A) Bypassing external security
- (B) Fading the spot checks and body counts
- (C) Reaching point of Debarcation
- (1) Kaituma (2) Ridge (3) Border crossing
- (D) Transportation to Georgetown or City in Venezuela
- (E) Transportation to States.

It is my contention that (A) poses the easiest phase, and the (B) should be the prime focus as it is the most difficult to circumvent since a sufficient head start gained by bypassing

This area of security makes achieving (C) and making arrangements for (D) relatively simple, and even could run into phase (E) if a plane were taken (especially if radio contact with Georgetown were dead).

Methods for achieving each phase: (A) would require little but 5 minutes to walk to the bush line, presupposing a knowledge of direction, finding a person is essentially gone if given as much as 5 to 10 minutes head start in the bush, and can remain undetected until they reemerge on a road, trail, or population center. (B) requires observation of surveillance methods and timing, basic knowledge of train, plane or boat schedules, or else some ~~the~~ projected goal or contact, and some method of fooling the body count. (includes excuses manipulation, manipulation of supervisor role to the between crew and office, manipulation of collapse check or flight from an

isolated work site, then assuming that phase (C) is reached, having sufficient head start to either simply catch the plane or boat, or to arrange for transportation from an outside contact. This is where the situation can become touchy, an emotional or less than clever person might find difficulty here - however somebody with really insidious purposes could resort to one of three methods (1) pretend to be on church business or physically injured and claim an emergency (2) (assuming they have money [or valuables]) purchase a canoe hire a guide (3) the worst danger is that they might contact somebody who doesn't like us (eg Isaac Lambert) or somebody ambivalent who might be swayed with some kind of story and appeal.

Good P.R. of course is the best answer to this and the G.T. end

There is really no way to seal this off as far as I know, to detain somebody in G.I. without creating a serious incident, though this could be easier up here than there.

Preventions:

Phase (A) would not be possible to seal off with even triple the existing security force.

Phase (B) could be tighter, but mainly the thought that you ^{can} never get, for without being missed is a good deterrent. P.R. and arrangements with the govt can help with (C) + (D) but as far as I can see; until there is more of a real unified communist structure in this country, an insidious person could cause us damage in this area.

It is therefore my contention that you could effectively reduce the security force and increase the use of security checks at lunch

etc. But most important to continue to use ~~psy~~ psychological methods. Tell people that security has been retained, let people see that they know how to ~~large~~ handle their guns, have them do drills and so forth. Tell people about the C.D.R.'s on each crew, and of course say that the increased body counts are to allay kidnappers. I also don't see the security units as that much of a deterrent to anarchy, people know that they won't be shot for acting up and this recent concentration on the news has kept people busy and out of trouble. I think, I believe that a secret police to report on people's attitudes as well as surveys such as having everybody in a meeting to write up confessions would be effective & this helps to locate a real useful hero or potential traitor than ~~anybody~~ anything.
