**Peoples Temple Members Injected With Cyanide
 JONES' AIDE WORKED AS MURKIN IN ANGOLA**



(New York, N.Y.) — A top aide to Rev. Jim Jones, sent by the assassinated Peoples Temple leader to Guyana in 1974 to begin the Jonestown settlement, served as a mercenary and mercenary-recruiter in 1975 for the CIA-backed Union for the Total Independence of Angola (UNITA).
 According to an article in the December 15 issue of *Workers World*, the official organ of Youth Against War and Fascism (YAWF), Phillip Blakey, whose brother-in-law, Larry Layton has been charged with the murders of Congressman Leo Ryan and four others at the Kaituma airport on November 18, returned to Jonestown after his CIA assignment in Angola.

Holsinger asks black scholars to bring out Jonestown truth

 Joe Holsinger, former aide to U.S. Rep. Leo Ryan, is asking black scholars to help him "research the possibility that the truth about Jonestown has not yet been determined."
 He believes the CIA was involved there from the beginning.
 Holsinger appeared at a closed session yesterday of 20 black psychologists, sociologists, anthropologists and psychiatrists at the Miyako Hotel here. He questioned what he called the "mythology" about events in Guyana where the Peninsula congressman and three newsmen were slain, and 914 followers of cult leader Jim Jones were found dead Nov. 18, 1978.
 Afterward, Holsinger said he had repeated charges he made before the House International Operations Subcommittee in Washington three months ago: that he was "inclined to believe that our government, through the CIA, was in close touch with Jones,

helped him get established there in Jonestown), and then used him at minimum to keep control of the Guyanese government and at maximum to conduct LSD mind-control experiments."
 Holsinger said the CIA connection appeared to be further strengthened by the alleged activity of George Phillip Blakey, husband of Deborah Layton Blakey, who had been a Jones aide, and a "mercenary-recruiter for the CIA-backed UNITA forces in Angola in 1975."
 Holsinger said it was Blakey who arranged the lease of the Jonestown settlement tract with the government of Guyana.
