

EVERYONE WHO: “saw” gunmen shooting without disembarking; based “identifications” on vehicles; “identified” Stanley Gieg as driver of attack vehicle; “eyewitness identifications” now discounted by race, height, dress, body build; misidentified vehicle they “saw” during the attack; credited impossible feats to themselves..... **SUCH AS:**

“The individuals whom he knew personally and identified as being on the trailer are as follows: [list of names.]”

“...observed [list of names] in the wagon being towed by the tractor. Stanley Gieg was driving the tractor. At this point, the individuals riding in the wagon opened fire on the aircraft.”
