Enclosed for the Bureau are two copies of index of Guyana evidence received at San Francisco on 1/20/79, and two copies of the xeroxed evidence. (u)

For information of Bureau, 15 crates of Jonestown evidence received in second shipment have been reviewed and categorized by SAs and AUSA, San Francisco. Portions of that evidence were removed and xeroxed. Enclosed xeroxed evidence represents that portion of the 15 crates that was determined by AUSA to be of possible evidentiary nature. (u)

Bureau is being furnished under separate cover two complete copies of evidence; one copy is being furnished for the Bureau to disseminate to the Department of Justice. (u)

Evidence is being shipped in <sup>six</sup> separate packages. One complete set is contained in packages marked one through ~~three-four~~ and second copy is contained in packages marked ~~five~~ <sup>four</sup> through ~~eight~~ <sup>six</sup>. (u)
