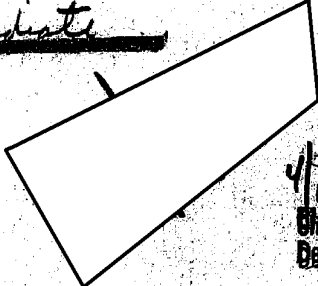

LEGAT IS OF OPINION THIS TECHNIQUE IS SWISS RESPONSE TO CASE OF ARNO ARNDT IN WHICH LAW ENFORCEMENT AUTHORITIES IN US ISSUED PRESS RELEASE PRIOR TO FILING FORMAL REQUEST FOR LEGAL ASSISTANCE OR FOR EXTRADITION OF ARNDT. LATTER CASE RESULTED IN CONSIDERABLE ADVERSE PUBLICITY TO SWITZERLAND IN US AND GREAT DISCOMFORT ON PART OF SWISS AUTHORITIES. (S)
