SCHOLLAERT WAS IN GEORGETOWN, GUYANA AT THE TIME OF THE SHOOTING OF RYAN AND WAS NOT INVOLVED OR ABLE TO FURNISH INFORMATION REGARDING PEOPLE'S TEMPLE (PT) OPERATIONS IN JONESTOWN. SCHOLLAERT INTERVIEWED BY BUREAU AGENTS IN DETAIL. (u)

THE AIRCRAFT LEFT SAN FRANCISCO EN ROUTE TO LOS ANGELES INTERNATIONAL AIRPORT, ARRIVING AT 11:45 AM. THE ONLY REMAINING INDIVIDUALS ON THE PLANE ARE THE MILITARY CREW AND THE BODY OF NEWMAN BOB BROWN. BROWN'S BODY WILL BE DEPLANED AT LOS ANGELES. (u)
