1. SINCE REFTELCON CONSUL HAS BEEN IN TOUCH WITH
 ASST. CRIME CHIEF ROBERTS WHO IS DIRECTLY IN CHARGE OF
 SECURITY OF THE "CONCERNED RELATIVES" AT THE PEGASUS HOTEL.
 THE PROPOSITION WAS PUT TO ROBERTS AS TO WHETHER OR NOT
