AS SUCH [REDACTED] ADVISED HE PLACES THIRD PARTY TELEPHONE CALLS FOR INDIVIDUALS IN CENTRAL AND SOUTH AMERICA, AS WELL AS ANTARCTICA, TO LOCATIONS IN THE UNITED STATES. (U)

[REDACTED] STATED THAT HIS RADIO LOG REFLECTS THAT ON SEPTEMBER 23, 1978, SEPTEMBER 30, 1978, OCTOBER 2, 1978, AND OCTOBER 16, 1978, HE

MADE CONNECTIONS BETWEEN SARA (LNU), CALL SIGN WB6MID/8R3, WHICH IS IN GUYANA, AND CAROL (LNU), TELEPHONE [REDACTED] BELIEVED SISTER OF SARA. [REDACTED] STATED THAT BECAUSE OF THE NATURE OF THE CONNECTION, IT IS NECESSARY FOR HIM TO MONITOR THE CALLS IN ORDER TO SWITCH BETWEEN RECEIVE AND SEND AT THE COMMAND OF THE SENDER BY THE WORD "OVER." (u)

[REDACTED] STATED ALL CONVERSATIONS WERE REGARDING FAMILY WELFARE IN THE U. S., AND NO MENTION WAS MADE REGARDING RELIGIOUS MATTERS OR CONDITIONS IN GUYANA. (u)

[REDACTED] CONTINUED STATING THAT HIS LOG ALSO INDICATES THAT ON OCTOBER 16, 1978, THE FIRST ATTEMPT TO CONTACT CAROL WAS NEGATIVE; HOWEVER, A MALE MADE CONTACT WITH HIS MOTHER FROM GUYANA TO TELEPHONE [REDACTED] STATED THAT HE HAD RETAINED NEITHER NAMES. (u)

[REDACTED] CONTINUED STATING THAT ON A SECOND ATTEMPT, CONTACT WAS MADE BY SARA WITH CAROL, AND TOWARDS THE END OF THEIR CONVERSATION CAROL RECEIVED ANOTHER CALL FROM W6ØDI. [REDACTED] STATED THAT CAROL COMMENTED STATING, "THERE'S MY STATION." THE CONVERSATION WITH SARA TERMINATED, AND APPARENTLY CAROL CHANGED FREQUENCIES.

[REDACTED] STATED THIS WAS THE LAST TIME HE HAD CONTACT WITH THE (u)
