POSSESSION SEVERAL HOURS OF CONVERSATIONS ON TAPE WHICH HE BELIEVED WERE BETWEEN THE PEOPLE'S TEMPLE IN CALIFORNIA AND PEOPLE'S TEMPLE OPERATION IN THE SOUTH AMERICAN NATION ON GUYANA. [REDACTED] ADVISED THE TIME FRAME COVERING THESE TAPES WAS APPROXIMATELY APRIL, 1978, THROUGH APPROXIMATELY OCTOBER, 1978, WHEN HE DISCONTINUED RECORDING THESE CONVERSATIONS. (u)

[REDACTED] TURNED OVER TO THE FBI AND WAS GIVEN A RECEIPT FOR ELEVEN SEVEN-INCH REELS OF ONE-QUARTER INCH RECORDING TAPE, TWO FIVE-INCH REELS OF ONE-QUARTER INCH RECORDING TAPE, AND NINETEEN CASSETTES OF VARIOUS TIMES, ALL OF WHICH ARE BELIEVED TO CONTAIN MATERIAL PERTINENT TO CAPTIONED MATTER. (u)

THESE TAPES ARE BEING FORWARDED FORTHWITH TO THE BUREAU FOR REPRODUCTION FOR COPIES TO THE BUREAU AND SAN FRANCISCO. (u)

[REDACTED] INDICATED HE LISTENED TO COMMUNICATIONS BETWEEN SAN FRANCISCO AND GUYANA FOR APPROXIMATELY ONE YEAR AND TAPED APPROXIMATELY SIX MONTHS OF THESE CONVERSATIONS.
