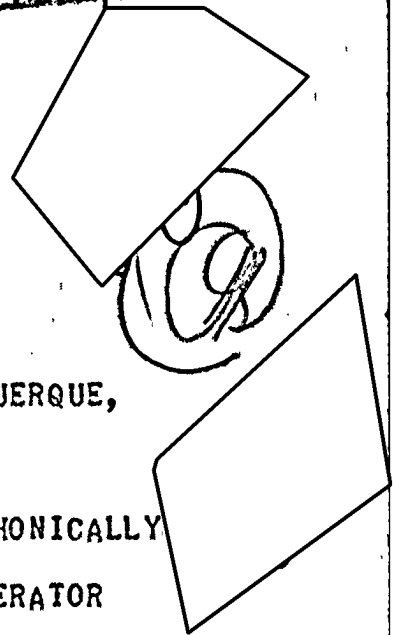
[redacted] NBC-NEWS, CHICAGO, ILLINOIS TELEPHONICALLY
ADVISED ON THIS DATE THAT HE IS AN AMATEUR HAM RADIO OPERATOR
(HAM). HE STATED THAT LAST SUMMER HE HAD CONTACT WITH BOB (LNU),
A MEMBER OF THE PEOPLE'S TEMPLE, WHO WAS IN GUYANA. BOB USED CALL
SIGN WB6MID. THE CONVERSATION WITH THE UNKNOWN OPERATOR IN
GUYANA DEALT WITH SMALL TALK ONLY (u)

[redacted] STATED HE HAS BEEN IN CONTACT WITH OTHER HAM OPERATORS AND
HAS BEEN ABLE TO LOCATE TWO OPERATORS WHO HANDLED TRAFFIC FROM THE
PEOPLE'S TEMPLE TO A CALIFORNIA TELEPHONE NUMBER 415-922-9597.
HAM OPERATORS HAVE A SERVICE NETWORK WHICH PATCHES THE
RADIO TRANSMISSIONS TO THE TELEPHONE. (u)

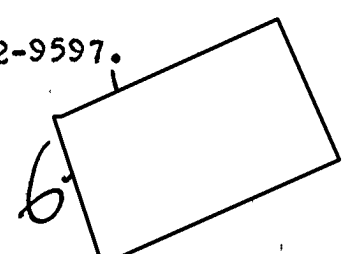

[REDACTED] STATED THAT ALLEGEDLY THE FCC CITED THE PEOPLE'S
TEMPLE AMATEUR RADIO STATION. SUPPOSEDLY AN AMATEUR RADIO STATION
CRAN NOT SPEAK ABOUT BUSINESS OR THEY MUST USE COMMERCIAL MEANS.
APPARENTLY THE PEOPLE'S TEMPLE AMATEUR RADIO STATION WAS CITED
FOR VIOLATION OF THIS RULE. (u)

THE PEOPLE'S TEMPLE GUYANA CALL SIGN IS BELIEVED TO BE
WB6MID PORTABLE 8R3. ALBERT TOUCHETTE, REDWOOD CITY, CALIFORNIA
IS BELIEVED TO BE A MEMBER OF THE PEOPLE'S TEMPLE AND INVOLVED
IN RADIO TRANSMISSIONS TO GUYANA. (u)
