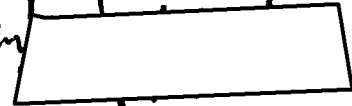

ABOVE TWO STATIONS MADE NO FURTHER CONTACT ATTEMPTS AND [] DID NOT SPEAK TO THEM OTHER THAN TO AID THEM IN ATTEMPTING TO CONTACT CALIFORNIA. [] NOTED HE KNEW ABOVE TWO STATIONS WERE FROM CALIFORNIA DUE TO "WB6" PREFIX. ALSO "8R1" AND "8R3" INDICATED STATIONS WERE OPERATING FROM GUYANA UNDER PORTABLE CONDITIONS. [] CONTACTED U.S. DEPARTMENT OF STATE RE ABOVE FOLLOWING RYMUR PUBLICITY. HE RECALLED A FRIEND, [] FORT LAUDERDALE, FLORIDA, CONVERSED IN PAST WITH ONE GUYANA STATION. (u)
