AMERICAN EMBASSY GEORGETOWN ADVISED (LOU) EMBASSY AND
LEGAT HAVE NO DIFFICULTY WITH PROCEDURES SUGGESTED BY STATE
DEPT AS LONG AS GOVERNMENT OF GUYANA CONCURS (u) (res)

(LOU) AS DEPARTMENT WILL RECALL, PERMISSION FOR FBI TECH-
NICAL TEAM TO VISIT GUYANA WAS GIVEN WITH CLEAR UNDERSTANDING
THAT THEIR ACTIVITIES IN GUYANA WOULD BE RESTRICTED TO EXAMIN-
ING EVIDENCE IN THE POSSESSION OF GOVERNMENT OF GUYANA AND
THE CONSULATE AND THAT THEY WOULD NOT CONDUCT A SEPARATE IN-
VESTIGATION. EMBASSY AND LEGAT BELIEVE THAT EXCELLENT COOPER-
ATION THUS FAR BETWEEN FBI REPRESENTATIVES AND GOVERNMENT OF
GUYANA AUTHORITIES SHOULD NOT BE JEOPARDIZED BY UNILATERAL
