2. (UNC) AIR FRANCE OFFICIAL INFORMED EMBASSY THAT AIR FRANCE OFFICE IN PORT OF SPAIN ASKED TRINIDAD AND TOBAGO IMMIGRATION OFFICIALS IF TOUCHETTE COULD ENTER COUNTRY. THEY REPLIED NO, GEORGETOWN OFFICE OF AIR FRANCE THEREFORE REFUSED TO CARRY HIM. TOUCHETTE HAD PREVIOUSLY TOLD CONSULAR OFFICER THAT GUYANA AIRWAYS HAD ALSO REFUSED TO SELL HIM TICKET.
