2. TOUCHETTE INFORMED CONOFF JANUARY 16 THAT VESSEL WITH ITS GUYANESE CREW (INCLUDING PT MEMBER PHILIP BLAXEY) WILL DISCHARGE ITS CARGO IN PORT OF SPAIN WITHIN 2-3 DAYS. VESSEL IS THEN EXPECTED TO RETURN TO GEORGETOWN FOR DRY-DOCK REPAIRS. ACCORDING TO TOUCHETTE, GEORGETOWN AGENT FOR THE ALBATROSS III (FERNANDES LIMITED) HAS RECEIVED ASSURANCE FROM GOG AUTHORITIES THAT NEITHER VESSEL NOR CREW WILL EXPERIENCE ANY DIFFUCULTIES WHEN THEY RETURN TO GUYANA. TOUCHETTE STATED THAT HE PLANS TO CONTINUE TO OPERATE THE ALBATROSS III BETWEEN GUYANA AND BARBADOS
