At 1:30 p. m., 11/20/78, Ms. [redacted] U. S. State Department Task Force - Guyana, telephonically provided the following information to SA Robert P. Finzel:

The State Department has received information through the office of Congressman Jim Weaver that a secretary in his Eugene, Oregon, office may have information concerning the People's Temple Cult bearing on the killing of representative Leo J. Ryan and other members of his party at a commune in Guyana. The employee is [redacted] FTS [redacted] According to Ms. [redacted] this individual lived in Guyana for approximately three years and is quite concerned of the welfare of her mother who is currently believed to be with the Cult in Guyana.

A second individual [redacted] of San Bernardino, California, [redacted] currently has a mother who is a member of that Temple in Guyana and Miss [redacted] is in possession of considerable correspondence from her mother containing information on the Cult and its activities.
