THE FBI MADE THE FOLLOWING PRESS RELEASE NOVEMBER 21:

BEGIN QUOTE: FBI DIRECTOR WILLIAM H. WEBSTER CONFIRMED TODAY THAT THE FBI IS INVESTIGATING THE MURDER OF CONGRESSMAN LEO J. RYAN OF CALIFORNIA AND THE EVENTS SURROUNDING HIS DEATH AT JONESTOWN, GUYANA.

DIRECTOR WEBSTER ADDED THE MURDER OF CONGRESSMAN RYAN IS BEING INVESTIGATED BY THE FBI UNDER THE PROVISIONS OF THE CONGRESSIONAL ASSASSINATIONS STATUTE INCLUDING CONSPIRACY PROVISIONS OF THE ACT; SINCE THOSE RESPONSIBLE FOR THE

DEATH OF CONGRESSMAN RYAN CAN BE PROSECUTED FOR THIS

SURVIVORS OF THE SHOOTING INCIDENT AT JONESTOWN ARE BEING  
INTERVIEWED BY SPECIAL AGENTS OF THE FBI UPON THEIR RETURN
