SC 100-4033 (JIM JONES, SM-C). ON 1/13/72, FLOYD EBBERS AND [REDACTED] MODESTO, CA, ADVISED THAT, AS A RESULT OF A RADIO BROADCAST, A FRIEND, MRS. [REDACTED] ATTENDED A ONE DAY SPIRITUAL MEETING AT REDWOOD VALLEY, CA. THE SPEAKER WAS JIM JONES, A BLACK MALE WHO PROFESSED A BELIEF IN COMMUNISM AND A DESIRE TO UNITE WITH THE RED CHINESE. HE INDICATED SOMEDAY THE U. S. WOULD BE UNDER THE RULE OF A MAOIST FORM OF GOVERNMENT. AS THE MEETING BROKE UP JONES REPORTEDLY SAID, "I AM YOUR FATHER AND I COMMAND YOU TO BE STILL AND LISTEN TO ME. SOMETIME IN THE NOT TOO DISTANT FUTURE WE WILL GO TO THE CAVE AND EVEN A WHISPER IN THE CAVE COULD MEAN YOUR LIFE. CONDITION YOURSELF TO LISTEN TO ME AND HEED MY COMMAND." (u)

MRS. [REDACTED] APPARENTLY HAD NO INTENTION OF ATTENDING MORE MEETINGS. (u)
