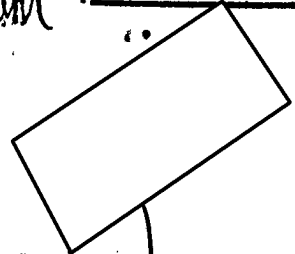

[redacted] NBC NEWS, CHICAGO, ADVISED ON NOVEMBER 21,  
1978, THAT [redacted] CANYON COUNTRY, CALIFORNIA,  
TELEPHONE [redacted] A HAM RADIO OPERATOR, PATCHED THREE  
TELEPHONE CALLS FROM THE PEOPLE'S TEMPLE IN GUYANA. ON  
AUGUST 15, 1978, MILDRED, LAST NAME UNKNOWN (LNU), IN  
GUYANA, WAS PATCHED TO MARTHA LNU AT TELEPHONE 415-992-9597. (u)

ON AUGUST 24, 1978, WES LNU ATTEMPTED TO CONTACT THE  
ABOVE CALIFORNIA NUMBER, BUT WAS UNSUCCESSFUL.

ON OCTOBER 19, 1978, SARA LNU WAS PATCHED TO TERRY LNU AT THE ABOVE TELEPHONE NUMBER. SARA WAS ASKING ABOUT MEDICAL SUPPLIES. (u)

[ ] ADVISED THAT THE ABOVE SARA'S LAST NAME IS BELIEVED TO BE TROTT (PHONETIC). SARA CLAIMED TO BE FROM NEW YORK AND WAS SUPPOSED TO BE A FORMER ATTORNEY. IT WAS THOUGHT THAT SHE MAY HAVE TAUGHT SCHOOL AT THE SETTLEMENT IN GUYANA. (u)

[ ] STATED THAT ALVA WILSON IN NEW MEXICO (WILSON REFERRED TO IN CHICAGO TELETYPE TO DIRECTOR, NOVEMBER 20, 1978, CAPTIONED AS ABOVE), STATED THAT AN ALTERNATE TELEPHONE NUMBER TO WHICH PATCHES WERE ATTEMPTED TO FROM GUYANA WAS 415-922-6118. (u)

[ ] DID NOT HAVE AVAILABLE HIS NOTES IN ORDER TO DETERMINE WHO PATCHED THE TELEPHONE CALL ON OCTOBER 12, 1978, FROM SARA TO TERRY IN CALIFORNIA AT 415-922-9597. SAMUELS PREVIOUSLY REPORTED THAT THIS CALL WAS PATCHED BY

INDIVIDUAL WAS LIKELY TO BE [REDACTED] OF OAK RIDGE,  
TENNESSEE. (u)

[REDACTED] A HAM RADIO OPERATOR, FROM MUNDELEIN,  
ILLINOIS, TELEPHONE [REDACTED] ADVISED THAT ON OCCASION  
HE MONITORED PEOPLE'S TEMPLE RADIO TRANSMISSIONS. A FEW  
MONTHS AGO, [REDACTED] OVERHEARD A CONVERSATION FROM GUYANA  
TO A LOCATION IN CALIFORNIA. THE PARTIES APPEARED TO BE  
SPEAKING IN A CODE. AT THE END OF ONE PARTICULAR  
TRANSMISSION, THE PARTY IN GUYANA TOLD THE CALIFORNIA  
PARTY TO WISH PATTY A HAPPY BIRTHDAY. MACKEY STATED THAT  
HE RECALLED THE NEXT DAY A NEWSPAPER ARTICLE MENTIONED  
THAT THIS PARTICULAR DAY WAS THE BIRTHDAY OF PATTY HEARST. (u)
