2. POLICE OFFICIALS, WHEN QUERIED REGARDING LEGAL STATUS OF MICHAEL J. CARTER, TIMOTHY J. CARTER AND MICHAEL J. PROKES (REF B) INDICATED THAT THEY WILL BE CHARGED WITH POSSESSION OF UNREGISTERED HANDGUNS FOR THE TIME BEING. THE POLICE APPARENTLY SUSPECT THEM OF MORE SERIOUS ACTIVITIES, HOWEVER.

3. PROMINENT LOCAL ATTORNEY, REX MCKAY, HAS BEEN ASKED TO REPRESENT THE INTERESTS OF SOME MEMBERS OF THE PEOPLE'S TEMPLE, BUT EXACTLY WHOM HE WILL REPRESENT IS NOT CLEAR AS YET, EVEN TO HIM.
