[REDACTED] COLUMBUS, OHIO, ADVISED HE IS A HAM RADIO OPERATOR, AND ON SEPTEMBER 3, 1978, HE HAD RADIO CONTACT ON THE 15 METER BAND WITH ONE ALBERT TOUCHETTE AND HIS WIFE TERRI, WHO WERE THEN AT THE PEOPLES TEMPLE CHURCH CAMP IN GUYANA. [REDACTED] STATED HE [initials] SUBSEQUENTLY RECEIVED A CONTACT CARD IN OCTOBER, 1978, FROM TOUCHETTE BEARING A RETURN ADDRESS OF P. O. BOX 808, GEORGETOWN, GUYANA. IT WAS NOTED TOUCHETTE'S AMATEUR RADIO CALL IS WB6MID, AND THAT A REVIEW OF THE "CALL BOOK" SHOWS HIS HOME ADDRESS TO BE 3747 ROAD B, REDWOOD VALLEY, CALIFORNIA, 95470. IT WAS ALSO NOTED THIS BOOK IS PUBLISHED IN DECEMBER OF EACH YEAR AND THAT AN AMATEUR (w)

[ ] ADVISED THE CARD HE RECEIVED SHOWED A PICTURE OF THE TEMPLE, A NEGRO FEMALE BENT OVER A MICROSCOPE, ANOTHER NEGRO FEMALE EXAMINING A PLANT, AND A NEGRO MALE WITH A WELDING TORCH BEING SUPERVISED BY A WHITE MALE. [ ] STATED THAT WHEN HE MADE CONTACT, TOUCHETTE WAS ATTEMPTING TO CONTACT ANY HAM OPERATOR IN COLORADO OR NEARBY AREA WHO HAD THE EQUIPMENT TO PATCH A RADIO CALL THROUGH ON TELEPHONE LINES. [ ] NOTED ANOTHER AMATEUR HE KNOWS HAD CONTACT A DAY BEFORE ON THE 20 METER BAND AND TOUCHETTE WAS AGAIN LOOKING FOR SOMEONE WITH TELEPHONE FACILITIES. [ ] ADVISED HE WOULD PLACE THE AGE OF THE TOUCHETTES BETWEEN 20 AND 30 YEARS OLD AND THERE WAS NO MENTION OF CHILDREN. (u)
