IS ACQUAINTED WITH [REDACTED] STATED BEGINNING WINTER, 1978, HE PERSONALLY MONITORED TRANSMISSIONS FROM GUYANA IN REGARD TO JIM JONES' SECT. HE NOTED, HOWEVER, HE DID NOT MONITOR BROADCASTS FOR APPROXIMATELY LAST THREE MONTHS. MOST BROADCASTS WERE TELEPHONE "PATCH" REQUESTS OR REQUESTS FOR MEDICAL AID AND ADVICE. MANY TRANSMISSIONS RELATED TO CALIFORNIA, BUT NOT BY [REDACTED] PERSONALLY. (u)

[REDACTED] NOTED MOST TRANSMISSIONS WERE BETWEEN 8:30 P.M. AND 9:30 P.M. HE DESCRIBED THE OPERATOR AS A MALE, SOUNDING WELL EDUCATED, SOFT SPOKEN, AND CALM. [REDACTED] NEVER NOTED ANY CONVERSATION INDICATING VIOLENCE OF ANY NATURE. (u)

[REDACTED] LATER ADVISED KAYE MADE NO TAPES OF RADIO TRANSMISSIONS, BUT SAID AN ORGANIZATION CALLED MARCO, WHICH HE BELIEVES STANDS FOR MEDICAL AMERICAN RADIO COOPERATIVE ORGANIZATION, DID RECORD SUCH TAPES IN WISCONSIN. MARCO IS COMPRISED OF MEDICAL PROFESSIONALS WHO ARE ALSO AMATEUR RADIO OPERATORS OFFERING MEDICAL AID TO OTHER OPERATORS.
