FOR MEDICAL AMATEUR RADIO COUNCIL (MARCO). THIS NET MEETS EACH

EVENING DEPENDING ON ATMOSPHERIC CONDITIONS AT 7236 MEGAHERTZ

AND 14280 MEGAHERTZ FROM 0100 TO 0200 GREENWICH MEAN TIME, AND

0200 TO 0300 GREENWICH MEAN TIME RESPECTIVELY. (u)

PURPOSE OF MARCO IS TO PROVIDE EMERGENCY MEDICAL SERVICES THROUGH CONSULTATION VIA AMATEUR RADIO. MEMBERSHIP CONSISTS OF DOCTORS OF MEDICINE IN ALL FIELDS AND LAY PEOPLE. IT IS A SCIENTIFIC MEMBERSHIP CORPORATION DESIGNED TO MEET THE MEDICAL, ELECTRONIC AND COMMUNICATIONS NEEDS THROUGHOUT THE WORLD. (u)

HE ADVISED THAT DUE TO HIS ACTIVE PARTICIPATION IN MARCO, HIS NAME WAS FURNISHED TO TELEVISION MEDIA REGARDING HIS HANDLING OF MESSAGES WITH THE PEOPLES TEMPLE AGRICULTURAL AND MEDICAL PROJECT RADIO STATIONS IN GUYANA. (u)

HE IDENTIFIED THE STATIONS IN GUYANA AS BEING ASSOCIATED WITH THE PEOPLES TEMPLE WHOSE FOLLOWERS RESIDED IN JONESTOWN AND GEORGETOWN, GUYANA: WB6MID/8R3 - THIS STATION BEING LOCATED AND OPERATED AT THE AGRICULTURAL AND MEDICAL PROJECT IN THE JUNGLE WHERE THE DEATH OF CONGRESSMAN RYAN AND SUBSEQUENT SUICIDES OF THE PEOPLES TEMPLE SECT OCCURRED; WB6MNH/8R1 - IDENTIFIED THIS AS BEING THE AMATEUR RADIO STATION AT GEORGETOWN, GUYANA. (u)

IN HIS CAPACITY AS NET CONTROL FOR MARCO, HE FIRST CONTACTED THE AGRICULTURAL AND MEDICAL PROJECT STATION AT GEORGETOWN ON FEBRUARY 20, 1978. (u)

SINCE THAT TIME HE HAS HAD NUMEROUS CONTACTS WITH BOTH AMATEUR RADIO STATIONS IN GUYANA ASSOCIATED WITH THE PEOPLES TEMPLE. HE HAS RELAYED AND EXCHANGED MEDICAL INFORMATION WITH INDIVIDUALS INCLUDING JAMES WARREN JONES AT THESE RADIO STATIONS. (u)

HE WAS UNABLE TO FURNISH ANY FACTS WHICH WOULD ASSIST IN THIS INVESTIGATION AS TO ANY ALLEGED CONSPIRATORS OR CONSPIRACY PURSUANT TO THE CONGRESSIONAL ASSASSINATION STATUTE. (u)

HOWEVER, HIS AMATEUR RADIO LOG REFLECTED THE FOLLOWING FIRST NAMES OF INDIVIDUALS OPERATING AT RADIO STATIONS IN GUYANA WITH WHOM HE TALKED: (u)

SARAH (LNU); MYRA (LNU); TERRY (LNU); "AL", KNOWN TO HIM AS JAMES WARREN JONES, ALSO KNOWN AS "BISHOP"; ART (LNU); JIM PROKES; MARGARET (LNU); DREW (LNU); RICK (LNU); DON (LNU); MILDRED (LNU); GRADY (LNU); DR. SCHEDT; DR. WALTER THAIN (PHONETIC) AND PAULA ADAMS. (u)

HE RECALLS DURING EACH CONTACT THAT THE TEXT OF THE CONVERSATIONS WAS CONCERNED WITH MEDICAL INFORMATION. (u)

HIS LOG REFLECTED THAT AMATEUR RADIO STATION WA6DTJ, (u)

APPARENTLY LOCATED IN SAN FRANCISCO, CALIFORNIA, MUST ALSO HAVE BEEN ASSOCIATED WITH THE PEOPLES TEMPLE. THEY WERE FREQUENTLY ON THE AIR COMMUNICATING WITH THE RADIO STATIONS IN GUYANA AT GEORGETOWN AND JONESTOWN. ON ONE OCCASION, HE OVERHEARD THE STATIONS IN GUYANA REQUESTING SUPPLIES AND OTHER PERSONAL INFORMATION CONCERNING MEMBERS. HE COULD NOT RECALL DETAILS. (u)

IN REFERENCE TO DR. [REDACTED] HIS AMATEUR RADIO LOG INDICATED THAT HE TALKED WITH DR. [REDACTED] WHILE THAIN WAS IN GUYANA ASSISTING IN THE AGRICULTURAL AND MEDICAL PROJECT ON OR ABOUT APRIL 30, 1978. DR. [REDACTED] WHO IS ALSO A RADIO AMATEUR OPERATOR, CALL LETTERS [REDACTED], RESIDES AT [REDACTED] [REDACTED], BOCA RATON, FLORIDA. (u)

HE ALSO HAS TALKED WITH A RETIRED COLONEL IN THE AIR FORCE WHO HE IDENTIFIED AS [REDACTED] WHO PRESENTLY RESIDES IN THE FLORIDA KEYS. [REDACTED] APPARENTLY OWNS OR OPERATES AN AIR CHARTER SERVICE AND IS ORIGINALLY FROM INDIANA. [REDACTED] AT ONE POINT ADVISED HIM THAT MARCO WAS CONSIDERING NOT ASSISTING THE PEOPLES TEMPLE FOLLOWERS IN GUYANA BECAUSE OF RECENT ADVERSE PUBLICITY REGARDING ALLEGED ACTS OF TORTURE AND INDIVIDUALS BEING HELD AGAINST THEIR WILL. ALSO, ATTEMPTS TO ACQUIRE PAYMENT FOR SUPPLIES FURNISHED (u)

TO THE PEOPLES TEMPLE SECT IN GUYANA HAD BEEN DIFFICULT. (u)

HIS AMATEUR RADIO LOG FURTHER REFLECTED ENTRIES MADE ON OR ABOUT MAY 8, 1978, AND MAY 9, 1978. ON MAY 8, 1978, THE RADIO OPERATOR OPERATING THE AMATEUR RADIO STATION AT THAT TIME, WHO HE IDENTIFIED AS SARAH, ARRANGED FOR PHONE PATCH TRAFFIC INTO CALIFORNIA THROUGH ANOTHER AMATEUR RADIO STATION IDENTIFIED AS [REDACTED] ON MAY 9, 1978, ANOTHER RADIO OPERATOR AT THE STATION IN GUYANA MADE ARRANGEMENTS FOR PHONE PATCH TRAFFIC THROUGH AN INDIVIDUAL IDENTIFIED AS [REDACTED] AT VAN NUYS, CALIFORNIA. THE CALL LETTERS OF THE VAN NUYS STATION WAS [REDACTED] FROM WHAT HE COULD DETERMINE, THE TELEPHONE CALLS WERE PERSONAL AND EITHER FRIENDS OR FAMILY OF INDIVIDUALS IN GUYANA. (u)
