HE IS MEMBER OF INTERCONTINENTAL NETWORK, ONE OF THREE NETS, WHICH TRANSMIT ON 20 METERS FREQUENCY BAND, BAND MOST SUITED FOR RADIO TRAFFIC TO GUYANA, ONLY OTHER ARIZONA HAM ON NET IS [REDACTED]

[REDACTED] PHOENIX, ARIZONA, ADVISED HE HAS LIKEWISE HAD NO DIRECT CONTACT WITH PT, HOWEVER, ABOUT THREE MONTHS AGO HE HEARD THE GUYANA SIDE OF THREE DIFFERENT RADIO CONVERSATIONS TO U.S. IN THE W3 OR W4 RADIO CALL SIGN AREA.
