[REDACTED] (A RETIRED COLONEL) WHO LIVES IN A TRAILER CAMP ON ROUTE ONE AT BOCACHICA ROAD, KEY WEST, FLORIDA, ACCORDING TO [REDACTED] HAS HAD AN INTEREST IN THE ALLEGED CRYPTIC MESSAGES BROADCAST OVER THE PT RADIO STATION. (U)

[REDACTED] STATED THAT FROM HIS CONVERSATIONS WITH OTHER HAM RADIO OPERATORS THAT THE INDIVIDUAL USING THE NAME AL ON THE PT GUYANA RADIO STATION WAS BELIEVED TO BE THE NAME UTILIZED BY JIM JONES. ACCORDING TO [REDACTED] WALTER THAIN PROVIDED THIS BIT OF INFORMATION. (U)

[REDACTED] ADVISED THAT HE WAS UNABLE TO LOCATE HIS NOTES AND THEREFORE WAS UNABLE TO STATE WHO HANDLED THE PATCH. (U)
