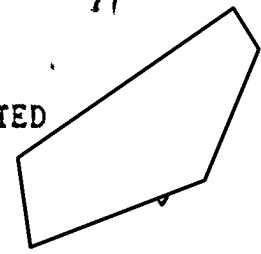

'AL' TOUCHETTE ON LETTER HEAD '' PEPLES TEMPLE, AGRICULTURAL MISSION, PO BOX 893, GEORGETOWN, GUYANA, SOUTH AMERICA'' DESCRIBING THE EFFORTS OF THE TEMPLE AND ITS FOUNDER THE REV. JIM JONES. (u)

ON 2/26/78, [REDACTED] RESPONDED TO A REQUEST FOR CONTACT BY CALL SIGN W6GMNH/ 8R1. THE HAM IDENTIFIED HERSELF AS PAULA AND A PITCH SIMILAR TO THE ONE MADE BY AL WAS MADE RELATING TO THE AIMS PURPOSES, AND PROJECTS OF THE TEMPLE. [REDACTED] IN CHECKING THROUGH THE "AMERICAN CALL-BOOK" PROVIDED THE FOLLOWING INFORMATION: THE CALLSIGN W6GMID IS ASSIGNED TO ALBERT A. TOUCHETTE, 3747 ROAD- B, RED WOOD VALLEY, CALIFORNIA, 95470. THE CALLSIGN W6GMNH IS ASSIGNED TO PAULA J. ADAMS, 1664 PAGE STREET, SAN FRANCISCO, CALIFORNIA, 94117. (u)

[REDACTED] WAS ASKED IF DURING HER CONTACTS WITH TEMPLE MEMBERS, USING THE HAM NETWORK OR IN CONVERSATIONS OVERHEARD BETWEEN TEMPLE MEMBERS AND OTHER HAMS, WHETHER ANY WORDS WHICH MIGHT BE CONSTRUED TO BE CODEWORDS WERE USED BY TEMPLE MEMBERS.

[REDACTED] REPLIED THAT TO THE BEST OF HER RECOLLECTIONS ALL CONVERSATIONS APPEARED TO BE COHERENT AND DID NOT CONTAIN ANY WORDS OR PHASES OUT OF THE CONTEXT OF THE SENTENCES. (u)

[REDACTED] FURTHER ADVISED THAT ALTHOUGH SHE DOES NOT HAVE TELEPHONE PATCH EQUIPMENT AND NO REQUEST FOR PATCHES WERE MADE OF HER, SHE DID HEAR TEMPLE MEMBERS IN GUYANA REQUESTING HAMS IN THE UNITED STATES FOR TELEPHONE PATCHES. [REDACTED] COULD NOT FURTHER IDENTIFY WHEN OR TO WHOM THESE REQUEST WERE MADE. FD- 302 OF [REDACTED] TO FOLLOW BY AIRTEL. (u) ARMED AND DANGEROUS- SUICIDAL TENDENCIES. (u)
