FLORIDA. THIS TRAFFIC STATED THAT A GOVERNMENT OFFICIAL, NFI,
WANTED TAPES OF ANY CONVERSATION BETWEEN THE U.S. AND GUYANA
AND THAT THESE TAPES SHOULD BE MAILED TO TO SCARBRO. (u)

DURING THE PAST YEAR HE HAS MONITORED TRAFFIC FROM A
CALL SIGN WBG6MID WORKING AS PORTABLE 8R3 AND THE LICENSEE FOR
THIS NUMBER IS ALBERT A. TOCHETTE, 3747 ROAD B, REDWOOD VALLEY,
CALIFORNIA. HE BELIEVES THAT THIS LICENSEE, ACCORDING TO
PREVIOUS TRANSMISSIONS, IS A YOUNGER PERSON; HOWEVER, OCCASIONALLY
AN OLDER SOUNDING PERSON WILL USE THAT CALL SIGN AND THE SUBSTANCE

OF THE CONVERSATION WAS PRIMARILY PROPAGANDA OR IDLE CHIT CHAT IN WORDS TO THE EFFECT THAT EVERYONE DWN THERE WAS DOING FINE AND THAT THE GROUP WAS A LOT OF HELP TO THE PEOPLE DOWN THERE. APPROXIMATELY ONE YEAR AGO, HE HEARD TRAFFIC FROM THIS SAME CALL SIGN DISCUSSING SALE OF PROPERTY THAT BELONGED TO THE "TEMPLE." THE CONVERSATION CONCERNED THE FACT THAT NOT ENOUGH MONEY WAS BEING OBTAINED FOR THE PROPERTY AND THAT ADDITIONAL NEGOTIATIONS SHOULD TAKE PLACE WITH THE REAL ESTATE AGENT HANDLING THE TRANSACTION. DURING APRIL, 1978, THE ABOVE MENTIONED STATION WAS SUSPENDED BY THE FCC ALONG WITH THE FOLLOWING OTHER STATIONS UTILIZING CALL NUMBERS WA6DTJ AND WB6MNH. THE EFFECT OF THIS SUSPENSION WAS THAT NO LICENSED OPERATORS SHOULD ENGAGE IN TRAFFIC WITH THEM OR RELAY MESSAGES FROM THEM. (u)
