[REDACTED] LEFT THE CHURCH IN 1973 WITH ~~JIM DOBB~~, MICKEY TOUCHETTE, WAYNE RIETELA, ALL OF SAN FRANCISCO, AND TOM POSBORSKI OF INDIANAPOLIS, INDIANA. (u)

[REDACTED] IS PERSONALLY AWARE OF ONLY ONE CRIME AND THIS OCCURED DURING LATE SUMMER 1972 WHEN [REDACTED] APPROACHED [REDACTED] ABOUT KILLING LESTER KINSOLVING. JONES LATER ALLEDED TO THIS BUT NEVER ACTUALLY REQUESTED [REDACTED] CARRY OUT THE ACT. [REDACTED] WILL TESTIFY TO THIS IF REQUIRED. (u) Cu

[REDACTED] BELIEVES MORE ASSASSINATIONS WILL BE CARRIED OUT ACCORDING TO JONES'S WISHES SPECIFICALLY BY SANDY BRADSHAW, LINDA AMOS, CAROLYN AND KAREN LEIGHTON. IT IS BELIEVED THESE WOMEN HAVE ALL AVAILABLE INSIDE INFORMATION TO JONES'S OPPERATION AND WERE DEVOUT FOLLOWERS AS WELL AS HIS MISTRESSES. (u) Cu

[REDACTED] ADVISED ~~JIM SUNBAR~~ CAUSED JONES MUCH GRIEF AND JONES WANTED HIM NEUTRALIZED BUT NEVER ORDERED HIS DEATH. JONES ALLEGEDELY ORDERED THE DEATH OF WHITEY AND OPAL FREESTONE, UKIHA CALIFORNIA BUT IT IS NOT BELIEVED THIS OCCURED. JONES IS BELIEVED TO HAVE DEFRAUDED ON INCOME TAX BY HAVING HIS SEC.-TREASURER, ~~EVA RUGH~~, BURY LARGE SUMS OF MONEY. [REDACTED] HAS HEARD TALK OF THE CHURCH HAVING 15 TO 20 MILLION DOLLARS.
