1. AMBASSADOR BURKE NEVER MET REVEREND JIM JONES EITHER OFFICIALLY OR SOCIALLY. AS FAR AS IS KNOWN, JONES WAS NEVER IN GEORGETOWN DURING THE

58 DEC 1978

'PERIOD' SINCE AMBASSADOR'S ARRIVAL IN SEPTEMBER 1977. AS INDICATED IN
PARA ONE REFTTEL, MRS JONES PAID A COURTESY CALL ON AMBASSADOR AT
3 PM MONDAY, JUNE 26. THIS WAS THEIR ONLY MEETING.

2. EMBASSY HAS NO RECORD OF EVER HAVING RECEIVED THE BLAKEY AFFIDAVIT
OF JUNE 15, 1978 FROM THE DEPARTMENT. EMBASSY DID, HOWEVER, RECEIVE
A COPY OF THE AFFIDAVIT DIRECTLY FROM ONE OF THE "CONCERNED RELATIVES"

GROUP IN A COMMUNICATION POSTMARKED AUGUST 11. SAME INDIVIDUAL IS
ALSO KNOWN TO HAVE ADDRESSED A LETTER TO PRIME MINISTER REGARDING
CONDITIONS IN JONESTOWN. THE AFFIDAVIT WAS NOT DISCUSSED WITH THE
GOG.
