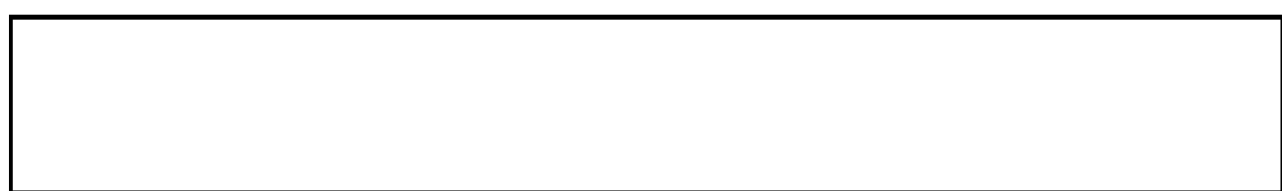

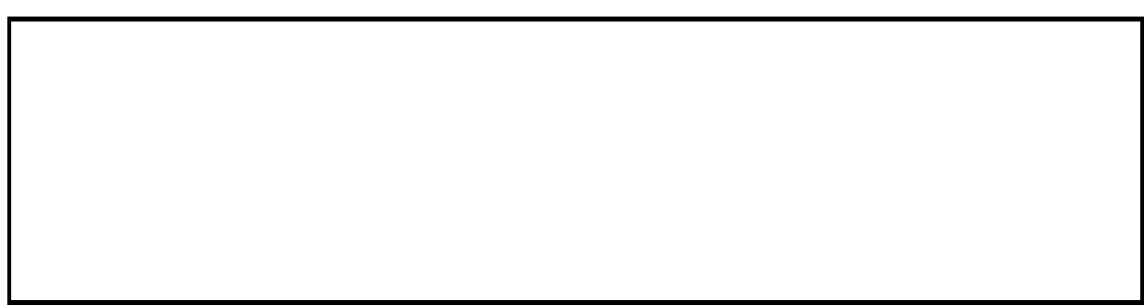

23. BEIKMAN IS ACCUSED OF MURDERING SHARON AMOS AND HER THREE CHILDREN, AND ATTEMPTING TO MURDER STEPHAIE JONES, ALL MEMBERS OF THE PEOPLE'S TEMPLE WHO WERE IN GEORGETOWN AT THE TIME OF THE MASS SUICIDE IN JONESTOWN, GUYANA.

24. ADVISORY OPINION. BEIKMAN SAID DEPARTMENT COULD NOTIFY NEXT OF KIN OF HIS ARREST, BUT DID NOT ACTUALLY SPECIFY THAT HE WISHED DEPARTMENT TO DO SO.
