[REDACTED] FURTHER STATED THAT PRIOR TO HER MOTHER DEPARTING FOR GUYANA SHE HAD SOLD ALL OF HER MATERIAL POSSESSIONS AND DISCARDED ALL OF HER IDENTIFICATION ON INSTRUCTIONS FROM THE REVEREND JIM JONES. MRS.
