ACCORDING TO MICKEY JEAN, JONES HAS LARGE SUMS OF MONEY HIDDEN IN CAVES ALL OVER THE STATE OF CALIFORNIA. SHE LEFT THE PT SEVERAL YEARS AGO AND HAS BEEN IN CONSTANT FEAR OF RETALIATION EVER SINCE.
