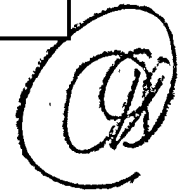
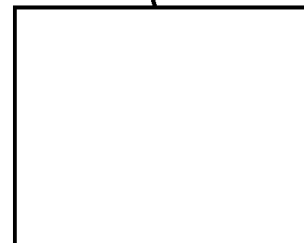

THE WASHINGTON OFFICE. SPEIER MAY HAVE HAD A LIST WITH

[REDACTED] WDC, ADVISED HIS MANAGING PARTNER, [REDACTED] RECEIVED A TELEPHONE CALL ON AUGUST 16, 1978, FROM [REDACTED] A SAN FRANCISCO ATTORNEY, WHO WAS RETAINED BY THE PEOPLE'S TEMPLE (PT) TO FILE AN FOIA REQUEST. [REDACTED] WAS A FORMER LAW STUDENT WITH [REDACTED] AT GEORGE WASHINGTON UNIVERSITY. [REDACTED] IS A HAM RADIO OPERATOR AND THE EXPERT IN THE FIRM REGARDING THESE MATTERS. [REDACTED] HAS HAD COMMUNICATIONS WITH ELTON ADAM, AKA TOM, WHO IS IN CHARGE OF THE SF HAM RADIO OF THE PT. [REDACTED] KNOWLEDGE OF THIS MATTER WAS LIMITED TO THE TECHNICAL ASPECTS AND POSSIBLE VIOLATIONS OF FCC REGULATIONS. HE HAD NO INDICATION OF ANY OTHER POSSIBLE CRIMINAL VIOLATIONS. (u)
