DISASTER TEAM AT DOVER AIR FORCE BASE IN RECEIPT OF
 INFORMATION THAT GUYANESE AUTHORITIES HAVE INKED FINGERPRINT
 IMPRESSIONS OF ALL JONESTOWN SETTLERS. DISASTER SQUAD HAS
 BEEN TOLD GUYANESE AUTHORITIES RELUCTANT TO TURN THESE RECORDS
 OVER. DESTRUCTION TEAM DESPERATELY NEEDS THESE FINGERPRINT CARDS
 TO IDENTIFY DEAD. GUYANESE AUTHORITIES SHOULD HAVE IMMEDIATE
 CONTACT TO ASCERTAIN IF THESE RECORDS EXIST. ASSURE GUYANESE
 AUTHORITIES THAT THE RECORDS WILL BE IMMEDIATELY RETURNED WHEN
 THE IDENTIFICATION PROCESS IS COMPLETED. IN LIEU OF ACTUAL
