16 TO DATE, GOVERNMENT OF GUYANA NOW HOLDS 78 SURVIVORS OF

 14 APPROXIMATELY 24 INDIVIDUALS WILL BE RELEASED TO TRAVEL TO THE
 UNITED STATES ON NOVEMBER 24, 1978, AND WILL COMPRISE THOSE

 8 CHARLESTON, SOUTH CAROLINA, ON EITHER FRIDAY OR SATURDAY NEXT.
 THE DEPARTMENT OF HEALTH, EDUCATION, AND WELFARE (HEW) WILL
 6 PROVIDE FOOD, HOUSING, CLOTHING AND MEDICAL CARE IMMEDIATELY
 FOLLOWING THE ARRIVAL OF SURVIVORS. HEW WILL RENT A MOTEL FOR
 4 THE PURPOSE OF ALLOWING SURVIVORS TO TAKE CARE OF IMMEDIATE

20 REUNIFICATION WITH THEIR FAMILIES.

18 COLUMBIA IS TO INSURE THAT A VIABLE CONTINGENCY PLAN IS
DEVELOPED WHICH SHOULD INCLUDE REPRESENTATIVES OF U.S. SECRET
16 SERVICE {USSS}, HEW, MILITARY, STATE DEPARTMENT, U. S. MARSHALS
SERVICE, AND LOCAL AUTHORITIES. COLUMBIA SHOULD INSURE THE
14 PRESENCE OF SUFFICIENT SA MANPOWER TO PROMPTLY INTERVIEW ALL
RETURNING AMERICANS IN A SECURE ATMOSPHERE AT THE SELECTED
12 MOTEL. THIS OPERATION IS TO BE CONSIDERED A CRITICAL PHASE OF
A MAJOR ONGOING LAW ENFORCEMENT ACTION AND, AS SUCH, ALL

8 COLUMBIA IS TO INSURE THAT LEGITIMATE INTERESTS OF THE

6 ACTS OF VIOLENCE BY PEOPLES TEMPLE MEMBERS MAY BE CARRIED OUT
