SAN FRANCISCO OFFICE DISCUSSED RESULTS OF MEMPHIS OFFICE
 CONTACT WITH MARK LANE WITH USA WILLIAM HUNTER AND CHIEF
 CRIMINAL DEPUTY ROBERT BREAKSTONE, SAN FRANCISCO, TODAY. HUNTER
 REQUESTED THAT LANE BE IMMEDIATELY RECONTACTED AND ADVISED THAT
 HIS OFFICE WOULD CONSIDER GRANTING IMMUNITY TO ANY VALUABLE
 GOVERNMENT WITNESS, HOWEVER, HE OBVIOUSLY IS IN NO POSITION TO

3) ANY SPECIFIC KNOWLEDGE OF THE ACQUISITION, CACHEING, LICENSING OR SHIPMENT OF WEAPONS BY PT MEMBERS.

4) ANY DIRECT KNOWLEDGE OF THREATS TO HARM ANY PUBLIC OFFICIALS, CURRENT OR FORMER PT MEMBERS, AS A RESULT OF PERSONS ATTEMPTING TO EXPOSE THE PT, INFILTRATE THE PT OR INDUCING A MEMBER TO LEAVE THE PT.

5) ANY KNOWLEDGE CONCERNING THE COMPROMISING AND/OR CORRUPTION OF PUBLIC OFFICIALS.

6) ANY KNOWLEDGE CONCERNING THE GATHERING OR CACHEING OF MONIES.

7) ANY INFORMATION CONCERNING ANY CONTINGENCY PLANS.

8) ANY PERSONAL KNOWLEDGE REGARDING ILLEGAL ACTIVITIES ON THE PART OF JIM JONES AND/OR ANY PT MEMBERS.
