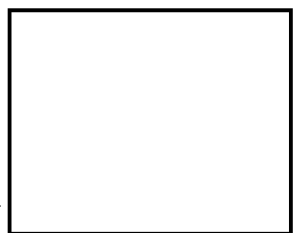

ON NOVEMBER 28, 1978, [REDACTED] OFFICE OF THE DIRECTOR OF CARRIBEAN AFFAIRS, U.S. DEPARTMENT OF STATE (USDS), WASHINGTON, D. C. (WDC), ADVISED THAT HE RECALLED THAT ON SUNDAY EVENING, NOVEMBER 17, 1978, THE DAY OF RYAN'S DEATH, HE RECEIVED A TELEPHONE CALL FROM A [REDACTED] WHO ADVISED [REDACTED] THAT HE HAD, FOR THE PAST SEVERAL YEARS,

BEEN MONITORING RADIO BROADCASTS FROM THE PEOPLE'S TEMPLE (PT) IN GUYANA TO THE TEMPLE IN THE UNITED STATES, AND THAT HE HAD RECORDED A NUMBER OF THESE BROADCASTS. [REDACTED] FURTHER STATED THAT [REDACTED] HAD ADVISED HIM THAT HE WAS OF THE OPINION THAT THERE WERE THREE (3) PT RADIOS LOCATED AT VARIOUS POINTS IN GUYANA, AND STRESSED THE POSSIBILITY OF THE EXISTENCE OF AN UNKNOWN PT SITE. HOWEVER, [REDACTED] STATED THAT AFTER SOME THOUGHT IN THIS AREA, HE DETERMINED THAT IN ADDITION TO THE TWO KNOWN PT RADIOS IN JONESTOWN AND GEORGETOWN, THE THIRD ONE WAS IN ALL PROBABILITY LOCATED ON THE PT TRAWLER.

[REDACTED] STATED THAT HE HAD ALSO LEARNED FROM [REDACTED] THAT A (FNU) [REDACTED] FROM TEXAS AND AN UNKNOWN INDIVIDUAL FROM FLORIDA HAD ADDITIONAL INFORMATION REGARDING THE RADIO TRANSMISSIONS.

ADDITIONALLY, [REDACTED] ADVISED THAT ON THE FOLLOWING DAY HE RECEIVED A TELEPHONE CALL FROM AN INDIVIDUAL IN NEW JERSEY, WHOSE NAME HE CANNOT RECALL, WHO ADVISED HIM THAT HE HAD TAPED A NUMBER OF CODED RADIO MESSAGES FROM THE PT IN

GUYANA FOLLOWING RYAN'S MURDER AND THAT THIS INDIVIDUAL HAD  
PLAYED ONE OF THE TAPES OVER THE TELEPHONE. [REDACTED] INSTRUCTED  
THIS INDIVIDUAL TO TAKE THESE TAPES TO THE LOCAL POLICE  
CHIEF TO BE HELD FOR THE FBI. [REDACTED] ADVISED THAT HE FURNISHED  
THE NAME OF THIS INDIVIDUAL TO [REDACTED] FBI LIAISON  
REPRESENTATIVE.
