WHEN THE GROUP CONTACTED THE MEDICAL AMATEUR RADIO COUNSEL LIMITED (MARCL), OF WHICH [REDACTED] WAS A MEMBER, TO TALK TO AN OBSTETRICIAN REGARDING ADVICE ON A CESAREAN OPERATION DUE TO A MULTIPLE BIRTH OF A LOCAL NATIVE WOMAN. (u)

[REDACTED] STATED ACTIVITY ON AMATEUR RADIO USUALLY STARTED AROUND FIVE THIRTY P.M. DAILY WITH PT GUYANA TRYING TO CONTACT PTSF. TRANSMISSIONS OFTEN LASTED PAST MIDNIGHT AND FREQUENTLY INTO THE EARLY HOURS OF THE MORNING. (u)

[REDACTED] STATED PT STATIONS SOON STARTED "WALKING ON OTHER BROADCASTERS" WITH THEIR RADIO TRAFFIC AND OTHERWISE MISUSING AIRWAYS AND [REDACTED] AND OTHER AMATEUR OPERATORS COMPLAINED TO THE FEDERAL COMMUNICATIONS COMMISSION (FCC). FCC CITATIONS ULTIMATELY FORCED CLOSING OF PTSF WB6DTJ AND THEREAFTER CAME ON THE AIR AS WD6DIV. (u)

[REDACTED] STATED HE TALKED TO JONES ON AT LEAST TWO OCCASIONS AND INSISTS JONES USED NAME AL TOUCHETTE ON THE AIR. [REDACTED] STATED HE TOLD JONES HE WAS A PHOTOGRAPHER AND JONES WAS INTERESTED IN ARRANGING FOR A FILM DOCUMENTARY OF THEIR GUYANA OPERATION. [REDACTED] PUT JONES IN TOUCH WITH A PHOTOGRAPHER WHOM [REDACTED] REFUSED TO NAME BECAUSE THE (u)

MAN FEARS REPRISAL. [REDACTED] STATED THIS PHOTOGRAPHER LATER MET WITH PT PRINCIPLES IN SAN FRANCISCO AND [REDACTED] AT ONE TIME CONSIDERED GOING TO GUYANA AS AN ASSISTANT PHOTOGRAPHER BUT DECLINED LATER WHEN HE LEARNED THE PARENTS OF CHILDREN IN JONESTOWN WERE PRESSING FOR RETURN OF THEIR FAMILY MEMBERS. THIS WAS AROUND APRIL OR MAY, 1978. (u)

[REDACTED] STATED AT ONE TIME LARRY LAYTON CAME ON THE AIR ALONG WITH LAYTON'S MOTHER AND DENOUNCED HIS SISTER, DEBORAH LAYTON, AND BLAMED PT'S TROUBLES ON THE FACT PT MEMBERS WERE SOCIALISTS. COMMENTS WERE ELUDED TO BELIEVE JIM JONES WOULD BE REMEMBERED AS MARTIN LUTHER KING WAS REMEMBERED. [REDACTED] STATED AN UNIDENTIFIED WOMAN BROADCAST THIS FROM GUYANA DURING ONE TRANSMISSION ON AN UNRECALLED DATE. (u)

[REDACTED] STATED HE BELIEVES JONES HAD A MEDICAL PROBLEM CONCERNING SHORTNESS OF BREATH AND CHRONIC BRONCHITIS. (u)

[REDACTED] STATED, DUE TO A LONG PERIOD OF TIME LISTENING TO THESE BROADCASTS, HE CANNOT NOW REMEMBER EVERYTHING BUT BELIEVES WHEN HE HEARS HIS THIRTY TO FORTY HOURS OF TAPES AGAIN HE WILL RECALL MUCH MORE AND ALSO REMEMBER MATTERS THAT WERE NEVER TAPED. (u)
