AT THAT TIME HE STATED TO HER THAT HE WAS A MEMBER OF PEOPLES TEMPLE (PT) AND THAT HE HAD RECENTLY RECEIVED SOME MONEY, PART OF WHICH HE WAS GOING TO GIVE TO THE CHURCH. HE FURTHER ADVISED HER THAT HE WAS ABOUT TO GO OVERSEAS WITH THE CHURCH TO A NEW LOCATION WHERE EVERYONE COOPERATED AND WORKED
