MEMBER OF THE PEOPLES TEMPLE FOR THE PAST EIGHT YEARS. THE CALLER INQUIRED IF [] HAD A COUSIN BY THE NAME OF ROZYNKO AND ASKED IF HE COULD FURNISH ANY BACKGROUND INFORMATION CONCERNING THE INDIVIDUAL. [] APPARENTLY TERMINATED THE CONVERSATION AT THAT POINT AS HE WAS NOT POSITIVE OF THE IDENTITY OF THE CALLER. [] STATED HIS COUSIN, MRS ANNIE ROZYNKO IS IN HER MID 50'S AND HAS TWO CHILDREN, CHRIS AND MIKE, IN THEIR LATE 20'S WHO PRESUMABLY HAVE BEEN IN JONESTOWN, GUYANA, FOR THE PAST YEAR. (u)

[] REPORTED THAT A PROPERTY SETTLEMENT RESULTING FROM THE DEATH OF ROZYNKO'S MOTHER DURING 1976, WAS SIGNED TO THE PEOPLES TEMPLE OF JONESTOWN BY MRS. ROZYNKO, AND [] BELIEVES THAT SOME OF THE RELATIVES NAMES LISTED MAY HAVE BEEN OBTAINED BY THE PEOPLES TEMPLE IN SAN FRANCISCO, THUS EXPLAINING THE POSSIBLE METHOD BY WHICH [] WAS CONTACTED IN FLORIDA. NO ADDITIONAL RELATIVE HAS BEEN CONTACTED IN THE FAMILY BY THIS MANNER. (u)

[] STATED THAT THEY HAVE RECEIVED NO INFORMATION REGARDING THE STATUS OF ROZYNKO AND CHILDREN AS A RESULT OF THE JONESTOWN MASSACRE. (u)
