THE INTERCEPTION OF HAM RADIO TRAFFIC BETWEEN THE PEOPLES
TEMPLE (PT) STATIONS BY SERGEANT [REDACTED] LANGLEY
AIR FORCE BASE, VIRGINIA, DURING SEPTEMBER 1977, REVEALS
THE FOLLOWING MESSAGES:

TRANSMISSIONS IMMEDIATELY PRIOR TO THIS REFERRED TO GENEVA'S TEDDY BEING CONTACTED BY A REPRESENTATIVE (NOT FURTHER IDENTIFIED) AND CONCERN AS TO WHETHER THE REPRESENTATIVE WAS COMING TOMORROW (SEPTEMBER 12, 1977), ON THE CHARTER. THIS INFORMATION HAD BEEN SUPPLIED BY TEDDY TO SHEILA.

7 "NO. I'M TALKING ABOUT TEDDY. DOES ANYBODY KNOW WHAT TEDDY'S PLANS ARE? DID ANYBODY TELL HIM THAT THIS MAN, THIS MAN THAT CAME TO VISIT HIM IS VERY MUCH TIED IN WITH THE WHOLE CONSPIRACY?

SENATOR EDWARD KENNEDY'S OFFICE WAS CONTACTED TO DETERMINE IF SENATOR KENNEDY HAD PLANNED ANY TRIP OR INQUIRY REGARDING THE PT. SENATOR KENNEDY HAS NEVER PLANNED A TRIP REGARDING THE PT AND NO LETTERS OR OTHER INFORMATION WAS RECEIVED BY HIS OFFICE PRIOR TO CONGRESSMAN RYAN'S DEATH. (u)

PURSUANT TO BUREAU TELEPHONE CALL TO WFO, THE FOLLOWING WERE NOTIFIED THAT SENATOR JOHN STENNIS IS INCLUDED ON THE "HIT" LIST OF THE PT (u)

ON NOVEMBER 28, 1978, MR. [REDACTED] SECURITY, FCC, ADVISED HAM RADIO CALL NUMBER WB5QAV IS NOT AN ASSIGNED DESIGNATION. LIAISON HAS BEEN ESTABLISHED WITH USSS AT WASHINGTON, D. C. (WDC), (u)

[REDACTED] SECURITY, FCC, ADVISED NOVEMBER 28, 1978, THE LIVERMORE CALIFORNIA, MONITORING STATION OF THE FCC IS STILL RECEIVING REQUESTS FROM THE HAYWARD RA FOR RECORDINGS OF PT HAM RADIO TRANSMISSIONS. IT WAS RE-AFFIRMED THAT A SUBPOENA WOULD BE SERVED ON THE FCC HEADQUARTERS, WDC, AND FCC HEADQUARTERS WOULD OBTAIN ALL AVAILABLE RECORDINGS OR TRANSCRIPTS AND TURN THESE OVER TO WFO.

WFO HAS BEGUN REVIEWING LETTERS RECEIVED BY THE FCC REGARDING THE PT AND IS IN THE PROCESS OF OBTAINING PASSPORT APPLICATIONS FROM THE DEPARTMENT OF STATE. LEADS FROM THE PASSPORT APPLICATIONS WILL BE SET OUT TO INTERVIEW RELATIVES OR ASSOCIATES FOR INFORMATION REGARDING THE PT AS SET FORTH IN SAN FRANCISCO TELETYPE DATED NOVEMBER 22, 1978.

LEADS. SAN FRANCISCO. AT SAN FRANCISCO. WILL ATTEMPT TO ASCERTAIN THE IDENTITY OF SHEILA, TEDDY, AND GENEVA THROUGH INFORMATION AVAILABLE YOUR DIVISION. (U)
