SHE WAS FORMER MEMBER PEOPLE'S TEMPLE (PT) CHURCH FROM DECEMBER, 1966, UNTIL HER DEFECTION IN SEPTEMBER, 1973. SHE WAS MEMBER OF CHURCH [REDACTED] UNTIL HER DEFECTION, AND MEMBER OF [REDACTED] [REDACTED] UNTIL HER DEFECTION. (u)

ACCORDING TO [REDACTED], INNER STAFF CONSISTED OF TEN TO TWELVE MEMBERS WHOSE SOLE RESPONSIBILITY WAS TO COMPILE PERSONAL INFORMATION ABOUT MEMBERS OF CHURCH CONGREGATIONS IN REDWOOD VALLEY, SAN FRANCISCO, AND LOS ANGELES, CALIFORNIA. INFORMATION GATHERED BY SURREPTITIOUS, NOT TO BE CONSIDERED ILLEGAL, MEANS. INFORMATION THEN USED BY REVEREND JIM JONES TO MYSTIFY MEMBERS OF CONGREGATION DURING SEGMENT OF PUBLIC CHURCH MEETINGS REFERRED TO BY JONES AS THE "REVELATIONS". ONLY MEMBERS OF INNER STAFF HAD KNOWLEDGE OF THIS TECHNIQUE AND ONLY JONES AND THEY HAD ACCESS TO FILES COMPILED (u) [REDACTED] *Carroll to JTX*

JOYCE PARKS WAS MEMBER OF CHURCH ^{Co} PLANNING COMMISSION AND

AWARE OF FUNCTIONS OF INNER STAFF. JOYCE PARKS WAS REGISTERED
NURSE ALSO EMPLOYED UKIAH GENERAL HOSPITAL. JONES ASSIGNED

FOR JONES, BUT WOULD RATHER ANSWER TO THAT QUESTION BE FURNISHED BY THEM. JONES HAD TRAIN CASE FILLED WITH DRUGS AND MEMBERS OF INNER STAFFED CHARGED WITH RESPONSIBILITY OF INSURING TRAIN CASE ACCOMPANIED JONES EVERY PLACE HE WENT. DRUGS CONSUMED BY JONES TO BEST OF [REDACTED] RECOLLECTION INCLUDED VALIUM AND QUAALIDE. NO OTHER MEMBERS OF CHURCH WERE FURNISHED DRUGS TO KNOWLEDGE OF [REDACTED] WHO ADVISED KICE PROBABLY WOULD KNOW FOR CERTAIN. (u)

COLLABORATION WAS NECESSARY AS DEFECTORS WERE REGARDED AS ENEMIES OF JONES AND THE CHURCH AND JONES FREQUENTLY TOLD MEMBERS OF THE CHURCH THAT IF ANYTHING HAPPENED TO HIM, EVERY EFFORT SHOULD BE TAKEN TO "TAKE CARE OF" (KILL) HIS ENEMIES. TO INSURE THEIR SAFETY, [REDACTED] HAD TAKEN FIVE SUITCASES FILLED WITH FILES CONTAINING PERSONAL DATA SHE HAD COMPILED ABOUT MEMBERS OF LOS ANGELES CHURCH CONGREGATION, AS WELL AS SOUND RECORDINGS (TAPES) OF VARIOUS CHURCH MEETINGS, ALL OF WHICH WERE ROUTINELY TAPED. [REDACTED] ALSO HAD SOME TAPES. ON ANNOUNCING DEFECTION TO JONES, [REDACTED] TOLD HIM SHE WOULD RETURN FILES IF HE LEFT HER AND OTHER DEFECTORS ALONE. JONES AGREED AND FILES RETURNED. [REDACTED] BELIEVES SHE RETAINED TAPES, BUT DOES NOT KNOW WHAT BECAME OF THEM. (u)

SAN FRANCISCO HAS INFORMATION INDICATING CHURCH MEMBERS OR FOLLOWERS HAVE BEEN MURDERED, BUT, ACCORDING TO [REDACTED] JONES DISCUSSED WITH INNER STAFF AND PLANNING COMMISSION ABOUT KILLING CERTAIN PERSONS WHO WERE CAUSING TROUBLE FOR JONES OR CHURCH. [REDACTED] KNEW OF NO INSTANCE WHERE KILLINGS WERE CARRIED OUT, AND SHE HAS NO REASON TO BELIEVE [REDACTED] [REDACTED] HAVE KNOWLEDGE OF ANY MORE INFORMATION THAN DOES SHE IN THIS REGARD. (u)
